APPOINTING SPECIAL COUNSEL UNDER THE SUPERVISION AND DIRECTION OF THE TOWN ATTORNEY

WHEREAS, the current Town Attorney, Timothy P. Downs, Esq.,("Town Attorney") has advised that the transfer of some open litigation files could result in additional legal expenses to the Town of Dover, and has therefore recommended that it is in the best financial interests of the Town of Dover to have former Town Attorney, David Pennella, Esq. ("Pennella") of Pennella & Claps Esqs., continue with some litigation files which Pennella had been handling; and

WHEREAS, the Mayor and Personnel Committee has concurred in the Town Attorney's recommendation; and

WHEREAS, the Mayor and Board of Aldermen find it in the best interests to follow the recommendation of the Town Attorney;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover, the following:

- 1. For the calendar year 2012, Pennella is hereby designated as Special Counsel on behalf of the Town of Dover, under the supervision and direction of the Town Attorney;
- 2. Pennella & Claps Esqs. shall immediately provide the Town Attorney with a list of each open Dover matter he has, together with a short summary of the matter, and the current status of same indicating any action which needs to be taken within the next 30 days;

All billings for legal services rendered by Pennella & Claps Esqs. for the matters assigned to them shall be first submitted to the Town Attorney for his review, and upon his approval, such billings will be forwarded to the Administrator for processing of vouchers and submission to the Mayor and Board of Aldermen for action.

MARIE TAMBINI – 10 E. Blackwell St. – Ms. Tambini explained the difficulties her apartment complex will have with putting garbage bags in cans; currently the complex utilizes a garbage compactor, which makes square cubes. Ms. Tambini asked the board to take her comments into consideration. Mayor Dodd noted the board will take her comments

into consideration but noted that garbage is a problem and needs to be addressed.

ANTONIO ACOSTA – 130 Madison St. – He hopes that this year the town progresses as a community and moves forward. He prefers to put the garbage out in the morning but would be in agreement with the cans if it helps the town stay cleaner. He's disappointed that he was not reappointed to the planning board but understands the reasons behind the decision.

WILLIAM (INAUDIBLE) – Victory Gardens – He noted that there are five (5) flood lights in the Town of Dover that remain on all 24 hours/7days a week (4 lights at the NJ Transit and 1 light at JFK Park). His other concern is idling engines; he explained the laws are not being enforced. He provided information and articles that were published on idling engines.
