#### **PUBLIC PORTION**

Mayor Marin opened this portion of the meeting to the public.

Jon Huston stated that he would take the issue of the new Town Attorney to a different forum, and asked that Attorney Cohen step down. Mr. Huston suggested to the Board that an Alderman may want to make a motion to authorize Jon Huston as the Municipal Attorney or as a Special Attorney for the town to take issues surrounding the appointment of Municipal Attorney for the Town of Dover for the year 2005 before the Superior Court. Mr. Huston asked that motion to include, under the direction of Adm. McDougall, an order of verbatim transcript for this meeting to be submitted to the proper judge. Ald. Dodd stated that he would like to make that motion to authorize Jon Huston to take this matter further in the court system if we need to do that. Ald. Dodd stated that we should not subject the tax payers of the town of Dover a legal expense and a lengthy drawn-out process of going to court. Ald. Dodd asked that Mayor Marin reconsider his thought process and let Mr. Huston do his job. Mayor Marin stated that he would not and Mr. Huston has no experience as a municipal attorney.

Ald. Dodd made a motion to authorize Mr. Huston to take legal action against Mr. Cohen and the Mayor Marin to go further in the court systems, duly seconded by Ald. Burbridge.

Mayor Marin stated that it is his intention to bring to referendum in 2005 extending the terms of office in the town, and doing away with civil service. Mayor Marin stated that the town will establish a Master Plan for the redevelopment areas and to hire grant writers.

Ald. Romaine made a motion for adjournment, duly seconded by Ald. Horan. The meeting was adjourned by group consensus.
