MAYOR'S REPORT:

- He provided an update on the Route 46/Route 15 project. The Pequannock Street is still scheduled to open in mid-November.
- Flu Clinic was held on October 17th and there's a second Flu Shot Clinic scheduled for Monday, October 31st from 2-5pm.
- Food Handlers' course was held in English & Spanish. Mr. Close noted that the course went extremely well.
- The Recreation Commission and the Mayor & Board of Aldermen will host the Annual Holiday Costume of Friday, October 28th.
- United Way of Morris County will host the March for Military Families and the Town of Dover has registered a team. Mayor Dodd asked for the public's support.
- Municipal Parking Lot Improvements is underway. He noted that the kiosk enclosure footings are done. The

- NJ Natural Gas is milling & paving the streets that they disturbed throughout their gas project.

AN ORDINANCE AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION PURSUANT TO N.J.S.A. 40A:4-55.1 FOR THE EXPENSES RELATED TO HURRICANE IRENE.

ORDINANCE NO. 19-2011

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AMENDING AND SUPPLEMENTING ARTICLE XXVII OF THE REVISED GENERAL CODE OF THE TOWN OF DOVER ENTITLED "PARKING" HANDICAPPED PARKING "SPACES" BY APPROVING A HANDICAPPED PARKING SPACE FOR 23 BERRY STREET

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This Ordinance shall take effect in accordance with law.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, AUTHORIZING AN AGREEMENT WITH LOCUST HILL CEMETERY ASSOCIATION FOR ROAD DEDICATION AND REPAIRS

WHEREAS, the Locust Hill Cemetery Association is the owner of Block 1408, Lot 1; and

WHEREAS, Losey Street intersects with the westerly boundary of Block 1408, Lot 1; and,

WHEREAS, Hoagland Avenue intersects with the northwest portion of Block 1408, Lot 1; and

WHEREAS, there exists a roadway connecting Losey Street with Hoagland Avenue which roadway is contained on Block 1408, Lot 1; and

WHEREAS, recent excessive heavy rains have created damage to this roadway area creating a public hazard; and

WHEREAS, there also exists a drainage pipe outside the connecting roadway on Block 1408, Lot 1 that has contributed to the necessity for repair; and

WHEREAS, Locust Hill Cemetery Association has requested assistance from the Town of Dover for repairs; and

WHEREAS, no easement and no dedication has been located with regard to the continuation of the roadway between Losey Street and Hoagland Avenue; and

WHEREAS, a recorded easement for the drainage line adjacent to the roadway between Losey Street and Hoagland Avenue cannot be located; and

WHEREAS, the Town intends to apply for funding through FEMA; and

WHEREAS, these issues need to be addressed in an expedited and emergency basis as the FEMA application deadline is Monday, October 31, 2001; and

WHEREAS, the parties wish to facilitate the repair of the water damage to the roadway and to the adjacent drainage pipe leading to the roadway; and

WHEREAS, the Locust Hill Cemetery Association wishes to dedicate to the Town the roadway between Losey Street and Hoagland Avenue located on their property known as Block 1408, Lot 1; and

WHEREAS, the Town is willing to make the repairs necessary to the connecting road between Losey Street and Hoagland Avenue, to the drainage pipe and driveway adjacent to such connecting roadway; and

WHEREAS, the Locust Hill Cemetery Association agrees to reimburse the Town of Dover for any and all costs and expenses, both soft costs and construction costs, that are not funded by FEMA; and

WHEREAS, the Town does not guarantee FEMA funding; and

WHEREAS, the Locust Hill Cemetery Association will pay the Town any money owned within twelve (12) months of the date of completion of the repairs;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

- 1. The Municipal Attorney is hereby directed to draft an agreement with the Locust Hill Cemetery Association upon the terms and conditions set forth above;
 - 2. The Mayor and Clerk are hereby authorized to execute such agreement;
