REGULAR MEETING MINUTES October 26, 2010

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:08 pm

ROLL CALL

Present: Aldermen Delaney, Poolas, Donofrio, Picciallo, Timpani, Romaine, Blackman and Mayor Dodd Absent: Alderman Visioli

Also present were Administrator Close, Attorney Pennella and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only.

<u>Jim Mullin</u> - 150 Ann Street – Mr. Mullin wanted clarification on the Open Public Request Act law, specifically, where it says "...individuals and attorneys who are using OPRA for their personal financial gain." Attorney Pennella explained.

Seeing no hands and hearing no voices, the meeting was closed to the public.

MAYOR'S REPORT – Mayor Dodd commented on the following:

- The US Marines will be hosting their annual "Toys for Tots" campaign on December 12th and noted that he asked local retired Marine John J. Rich to serve as honorable chairman.
- Turkestanian American Association will be opening its door to provide free holiday meals on Wednesday, November 24, 2010 from 3:00pm to 7:00pm. Delivery is available to seniors (65+) or homebound.
- Picatinny Arsenal Haunted House Oct. 29th & 30th from 6:30 9:30pm
- NJ Department of Transportation (NJDOT) held a public information meeting (October 14th) to address questions on the proposed bridge project. He noted that there wasn't a very large turn-out, only about 10 people. He expressed that the town was able to get NJDOT to put the raised aggregate panel on the Prospect Street Bridge to give it more of a historical look.
- The Harding Avenue Project will have the top course of asphalt put down and the signage and punch list will be completed by Friday, October 29th.
- The contractors are expected to start on the Chestnut Street Roadway Improvement Project.
- Milling and paving projects (Capital Project) are expected to start next week, throughout town.
- Department of Public Works made and installed two signs to help indentify the location of Dover High School for visitors of the community.
- Department of Public Works is completing the installation of new tables, benches, trash receptacles and recycling containers at the JFK Park. They are installing new concrete pads that will improve accessibility and maintenance. The equipment is made of recycle plastic so it's environmentally conscious and graffiti resistance. Mayor Dodd thanked and complimented DPW for an outstanding job.
- Dover Health Department held their influenza clinic; totaled shot given out to date is 111.
- Mayor Dodd attended the graduation at Uceda English Institute. Mayor Dodd noted that it was heartfelt to see the students receive their diploma. Mayor Dodd thanked them for the invitation.
- Saint Clare's will be hosting their 2nd Annual Community Meeting on November 4th from 6-9pm
- Mr. John Anderson, Representative of First Engery Corp/JCP&L provided Mr. Close with a written report on the recent power outages. Mayor Dodd noted that there's nothing that is typical and consistent to failures that they anticipate. Mayor Dodd considered it a fluke that so many occurrences happened at the same time, in different areas that affected the same residential neighborhood.

- 3. The taxpayer must waive interest on the overpaid amounts.
- 4. The Municipal Attorney is hereby authorized to execute a Stipulation of Settlement upon the terms set forth above.

RESOLUTION URGING THE NEW JERSEY LEGISLATIVE GOVERNMENT TO ENACT CHANGES TO THE OPEN PUBLIC RECORDS ACT (OPRA) LAW

WHEREAS, the Morris County Municipal Clerks represent the interests of the residents and officials in the County of Morris; and

WEREAS, the Morris County Municipal Clerks have identified compliance with the Open Public Records Act, N.J.S.A. 47:A-1 et seq. ("OPRA") as a problem for municipalities as a result of loss efficiency and out-of-pocket costs to municipalities; and

WHEREAS, the Morris County Clerks recognize the importance and virtue of access to public records for all citizens as an important issue because it encourages open government and increases confidence in the operation of government; and

WHEREAS, the Morris County Clerks have become increasingly aware of the cost of complying with OPRA and of individuals and attorneys who are using OPRA for their personal financial gain; and

WHEREAS, Municipal Officials and Municipal Clerks believe that the Open Public Records Act needs to be reformed to create standardization in providing records to the public and to prevent individuals and attorneys from profiting from the provisions of OPRA where they have no legitimate interest in the records they are requesting; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey that the Governor and State Legislature are urged to review the provisions of OPRA and consult with the Municipal Clerks to reform OPRA to include:

- 1. There should be no potential for Records Custodians to be personally responsible for fines. The public entity would be responsible for any violations.
- 2. A standardized statewide rate schedule for the most common requests to create uniformity from one municipality to the next.
- 3. The removal of references to the actual costs of certain records as the calculations can be different and the calculations completely discount the time spent by the Municipal Clerk.
- 4. Clear authorization to allow the Clerks to bill for time spent organizing data, researching documents, or translating documents to a different medium. An example is scanning documents to provide electronically.
- 5. The creation of standard legitimate interests to be applied to requests, such as, for example, tax payer or residency in the municipality or for the press. This would also include a mechanism to regulate commercial entities using OPRA requests to create mailing lists for advertising.

- 6. The municipality should be entitled to receive a seven (7) day extension for any large or complicated requests. Currently, the requestor must agree. This particularly affects small municipalities with a small or part time only staff.
- 7. All requested records should be required to be picked-up within a week so that the Clerk does not have to keep them indefinitely.
- 8. Directions to the Government Records Council or Office of Administrative Law as to when attorney's fees should be awarded to requestors under OPRA to limit the award of Attorney's fees to situations where there was a willful violation of OPRA that resulted in the requestor failing to receive a legitimately requested document.
- 9. Regulations should be created to prevent a requestor from repeatedly using OPRA to request the same documents as the purpose in these multiple requests is to harass municipal officials.
- 10. Documents which are already available to the public on a municipality's website should be excluded from OPRA.
- 11. The Government Records Council should have mandatory mediation for all complaints. Currently, mediation takes place only where both parties agree.
