REGULAR MEETING MINUTES November 20, 2012

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:14 pm

ROLL CALL

Present: Aldermen Visioli, Romaine, Blackman, Downs, Rutan, Noriega and Mayor Dodd

Absent: Alderman Picciallo & Timpani

Also present were Attorney Downs, Administrator Close and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened the meeting to public.

An audience member asked about the Warren Street parking. Mayor Dodd provided an update on the Warren Street parking. He noted that he has been in contact with NJ Department of Transportation (NJDOT) and was informed that the NJDOT's emergency maintenance crew will perform the job since PKF Contracting rejected the job. However, their emergency maintenance crew is now stationed in South Jersey due to Hurricane Sandy and a completion date can not be provided.

Seeing no hands and hearing no voices, Mayor Dodd closed the meeting to the public.

MAYOR'S REPORT – Mayor Dodd and members of the board attended the grand opening for the Zufall Health Clinic. Mayor Dodd noted that in 2013 the clinic has projected that they will see 59,000 patients and currently 25% of them are from Dover. Mayor Dodd commended them for the service that they provide to the community. He reminded the public that tomorrow the Turkestan American Association will host their annual thanksgiving dinner. He also noted that the Salvation Army will host a breakfast for needy families on Thursday morning. He expressed that the Santa Run will take place on December 16th. Mayor Dodd thanked the voters in Dover and congratulated Michelle Yzarnotegui.

ATTORNEY'S REPORT – Mr. Downs provided an updated on the OPRA lawsuit that was filed against the Municipal Clerk's office. He noted that the order came back favorable to the town.

Mayor Dodd provided a summary on the events of Hurricane Sandy in the Town of Dover. He thanked Rich Riley, Office Emergency Management Coordinator, Deputy Coordinator Frank Coppinger, Town Administrator Mr. Close, Public Safety Director Richard Rosell, Municipal Clerk Margaret Verga and staff including Department of Public Works.

Mayor Dodd thanked and recognized Danielle Guzman and the MIRA group for their assistance with the warming center. He also thanked Sabor Latino, Viking Bakery of Denville, Pan Pizza Bakery and Burger King for their donations of meals and snacks to the warming center.

WHEREAS, 28 W. Blackwell St., L.L.C. is the owner of 28 W. Blackwell St., A through D &31, Dover New Jersey, also known as Block 1218, Lot 16; and

WHEREAS, 28 W. Blackwell St., L.L.C. filed appeals with the Tax Court of New Jersey for the years 2009, 2010 and 2011 bearing Docket # 013280-2009, 017410-2010 and 012998-2011; and

RESOLUTION IN SUPPORT OF A-3393, LEGISLATION TO PROTECT RESIDENTIAL PROPERTY TAXPAYERS FROM THE LOSS OF TELECOMMUNICATIONS TAX SUPPORT

WHEREAS, in 1997, at the request of incumbent utilities, the laws regarding State taxation of telecommunications corporations were amended in response to technological and market innovations, in order to increase competition; and

WHEREAS, the amendments sought to preserve revenues to local governments by providing that local exchange telephone companies subject to the New Jersey Franchise and Gross Receipts Tax on April 1, 1997 would continue to be subject, annually, to the Business Personal Property Tax ("BPPT"); and

WHEREAS, the statute defines local exchange companies as those telecommunications carriers "providing dial tone and access to 51% of a local telephone exchange"; and

WHEREAS, Verizon's self-serving interpretation of the statutory definition has led it to claim exemption from the BPPT in any municipality where the corporation unilaterally determines, in any given year, that it no longer supplies dial tone and access to at least 51% of the local telephone exchanges; and

WHEREAS, Hopewell Borough's challenge to that claim was upheld by the Mercer County Board of Taxation in 2009; and

WHEREAS, Verizon's appeal of that determination to the Tax Court resulted in a June, 2012 trial court decision accepting the corporation's self-serving interpretation of the law; and

WHEREAS, as things now stand, over 100 municipalities know that they enter 2013 without BPPT revenues that will cost property taxpayers well in excess of \$8 million and, unless matters change, more municipalities will lose more millions in the future; and

WHEREAS, remedial legislation (A-3393) has been introduced by Assemblyman Ralph Caputo, which will clarify the perceived ambiguity of the statutory definition to further implement the original legislative intent to preserve revenues to local governments; and

WHEREAS, we anticipate the introduction of companion legislation by Senator Bob Smith, as soon as the Senate next convenes;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Board of Aldermen of the Town_of Dover commends Assemblyman Caputo and Senator Smith and strongly supports A-3393, which would clearly identify the telecommunications carriers subject to taxation on their business personal property and remove the budget uncertainty caused by Verizon's obfuscation; and

BE IT FURTHER RESOLVED, that we urge our State Senator and our representatives in the General Assembly to join as co-sponsors of A-3393 and its companion bill; and

BE IT FINALLY RESOLVED, that copies of this Resolution be forwarded to the Honorable Governor Chris Christie, the Honorable Speaker of the General Assembly Sheila Oliver, the Honorable President of the State Senate Stephen M. Sweeney, the Honorable Assembly Republican Leader Jon Bramnick, the Honorable Senate Republican Leader Thomas H. Kean, Jr., and our own State Senator and Representatives in the General Assembly, and to the New Jersey State League of Municipalities.

ORDINANCE FOR INTRODUCTION

ORDINANCE NO. 18-2012 AN ORDINANCE AMENDING CHAPTER 57 OF THE CODE OF THE TOWN OF DOVER, ENTITLED "POLICE DEPARTMENT"

BE IT ORDAINED by the Municipal Council of the Town of Dover (the "Town"), in the County of Morris and State of New Jersey, that:

WHEREAS, the governing body of a municipality may make, amend, repeal, and enforce ordinances to adopt policies and procedures for the protection of public health, safety and welfare; and

WHEREAS, the Town of Dover desires to amend Chapter 57 of the Town Code to create an Auxiliary Police Force and to reallocate responsibilities accordingly. This Ordinance shall be organized under Article IV of the Code, and the current "Article IV Table of Organization (§ 57-19)" shall be now designated as "Article V Table of Organization (§ 57-19)"

WHEREAS, the Board of Aldermen of the Town of Dover believes that it is in the best interests of the Town to establish an auxiliary police organization to assist and augment the regular police force during disasters and other

emergency conditions, all in accordance with New Jersey Statute, Appendix A: 9, et seq., all duly adopted Executive Orders promulgated by the New Jersey Office of Emergency Management, and all rules, regulations and memoranda issued by the Local Emergency Management Coordinator and the Chief of Police; and

WHEREAS, the Board of Aldermen wishes to establish rules and procedures governing the interaction between the Auxiliary Police and the Dover Police Department; and

WHEREAS, it is hereby established as a policy of the Dover Police Department to utilize the Police Auxiliary as a supplement to police personnel in times of disaster or public emergency and assist in the training of the Police Auxiliary, so as to maximize preparedness in times of disaster or emergency; and

WHEREAS, it is the further stated intent of this legislation to establish the Police Auxiliary of the Town of Dover as being under the direct supervision of the Dover Emergency Management Coordinator during a properly declared state or local emergency or disaster, and under the direct supervision of the Chief of Police during period of bona fide training in preparation for such occurrence, such training being nevertheless as approved by the Board of Aldermen in cooperation with the Mayor and Borough Emergency Management Coordinator;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Board of Aldermen

of the Town of Dover, County of Morris, State of New Jersey, that Chapter 57 of the Town Code entitled, "Police Department" is hereby amended as follows (any subsection not enumerated herein remains unchanged):

Article IV

Section 1

§ 57-19 Auxiliary Police Department Established

There is hereby established in the Town of Dover an Auxiliary Police Department. The purpose of this ordinance is to establish rules and regulations regarding the Auxiliary Police Department, consistent with Appendix A, Chapter 9, National Defense and other directives of the State of New Jersey Director of Emergency Management or the Governor of the State of New Jersey.

Section 2.

§ 57-20 Qualifications of the Town of Dover Auxiliary Police

- A. All members of the Police Auxiliary must be residents of and maintain residence in the Town of Dover. Exceptions will be considered on a case by case basis and only when:
 - 1. The applicant's residence is not more than five (5) miles from the nearest corporate borders of the Town of Dover; and
 - 2. Upon approval of the Mayor and Board of Aldermen
- B. The selection criteria for membership in the Borough of Dover Policy Auxiliary include:
 - 1. Citizen of the United States and the State of New Jersey;
 - 2. At least 18 years of age;
 - 3. Able to read, write and speak the English language;
 - 4. Good moral character (based upon contemporary standards);
 - 5. Physically qualified to perform assigned duties. Physical disability is not a disqualifier if the person is able to perform assigned duties;
 - 6. Free of criminal conviction involving moral turpitude;
 - 7. Must possess a valid New Jersey driver's license by date of appointment if vehicle operation is required;
 - 8. Auxiliary Police members may not simultaneously be members of the regular Dover Police Department;
 - 9. Shall agree to an extensive background investigation and shall have his fingerprints taken, and they shall be filed with the Division of State Police and the Federal Bureau of Investigation.
 - 10. Meet such other requirements as are established in the Dover Auxiliary Police Rules and Regulations;

§ 57-21 Responsibilities of Department Officers

- A. All auxiliary police officers are required to successfully complete a basic training course for auxiliary police prior to taking an oath of office.
- B. All auxiliary police officers, before assuming the duties of their office, shall take and subscribe to the oaths required by NJSA 41:1-1, et seq. The original executed oaths shall be filed with the Municipal Clerk. Copies shall be forwarded to:
 - 1. The Police Auxiliary officer taking the oath;
 - 2. The Chief of Police:

- 3. If not a Town of Dover resident, to the clerk of the municipality in which the officer(s) reside(s).
- C. Auxiliary police officers in good faith carrying out, and complying with, or attempting to comply with rules and regulations made and promulgated or performing any authorized service shall have and possess all the rights, privileges and immunities conferred upon civilian defense volunteers by the laws of this State.
- D. Auxiliary police personnel are not regular sworn police officers. NJSA App. A:9-45 states that auxiliary police shall have the powers of a regular police office only during a declared emergency, disaster, or assigned training mission.
 - 1. Regular police officers, regardless of rank or assignment, shall not relinquish their authority to any member of the Police Auxiliary.
 - 2. Auxiliary Police officers shall obey the instructions of any regular police officer except as provided in the Town of Dover Police Department Rules and Regulations.
 - 3. Powers granted to the Auxiliary Police can be restricted and controlled in accordance with applicable laws, statutes, guidelines, and directives issued by the New Jersey Legislature, New Jersey Office of Emergency Management, New Jersey Attorney General, Morris County Prosecutor, Board of Aldermen, or the Chief of Police.
- E. Auxiliary police personnel are covered by state and federal statutes for compensation insurance in case of death or personal injury only when on duty during a declared emergency, disaster, or assigned training mission.
- F. Auxiliary police officers are provided with public liability protection equal to that provided to regular police officers.
- G. Auxiliary police personnel must comply with all rules and regulations of the Town of Dover Police Department, those established for the Police Auxiliary, and applicable written directives as may be prescribed.
- H. Auxiliary police officers are prohibited from using their identification card, badge, or affiliation with the Town of Dover Police Auxiliary or the Town of Dover for any financial gain, advantage, or other unethical purpose. All Auxiliary Police, while on duty, shall be uniformed in a manner, which is clearly distinctive from that of a regular police officer within the Town of Dover. Additionally, each volunteer auxiliary police officer shall wear a badge at all times while on duty indicating membership in the auxiliary police of the Town of Dover.
- I. Arming of the Police Auxiliary with less lethal weapons is authorized subject to the following:
 - 1. The only authorized less lethal weapons are the:
 - a. Baton: collapsible friction lock baton
 - b. Oleoresin capsicum spray
 - 2. Auxiliary officers are also authorized to carry and use handcuffs in comportment with any training provided in basic training and/or in-service training provided by the police department.
 - 3. Only those Police Auxiliary officers who have been instructed in the Town of Dover Police Department's use of force and weapons directives and have demonstrated proficiency with the above less lethal weapons are authorized to carry these weapons.
 - 4. All Police Auxiliary officers must receive refresher training in the use of force and weapons directives and demonstrate proficiency with the above authorized less lethal weapons with the same frequency as regular police officers.
 - 5. These authorized weapons and equipment can only be carried on duty during a disaster, declared emergency, or authorized training mission.
 - 6. These authorized weapons must be stored in a safe manner while off duty to retard theft or unauthorized possession or use by unauthorized persons.
 - 7. Police Auxiliary officers shall promptly report any lost or stolen weapons or equipment to the Town of Dover Police Department as soon as possible following discovery of the loss.
 - 8. Any use of force must comply with the Town of Dover Police Department's use of force and weapons directives.
- J. UNDER NO CIRCUMSTANCES shall a Police Auxiliary officer initiate or participate in any motor vehicle pursuit or high-speed response.
 - 1. A high speed response is any call response that exceeds posted speed limit.
 - 2. Auxiliary police are authorized to use emergency lights and sirens under certain conditions to include:
 - a. Parades;
 - b. Funerals;

- c. Other special events as authorized by the Chief of Police.
- 3. Police Auxiliary personnel are permitted to utilize a Town of Dover vehicle only when assigned during a declared emergency, disaster, or training mission, when clearly designated by sign or emblem denoting Auxiliary Police, and with the approval of the squad commander of designee.
- 4. Auxiliary Police are not authorized to utilize emergency lights or siren when driving to any fixed post assignment.
- K. The following list is representative of the functions, which may be proper and appropriate for assignment to the Police Auxiliary. The list is not all inclusive and other functions may be assigned at the discretion of the Chief of Police or designee.
 - 1. Vehicular and pedestrian traffic control;
 - 2. Receive and disseminate warnings or information and instructions to the public as directed;
 - 3. Crowd and assemblage control;
 - 4. Security of Federal, State, County or local government buildings, excluding the Municipal Court, within the Town of Dover;
 - 5. Assist with staffing and functioning of the Town's Emergency Operations Center, field command posts, staging areas, or police headquarters operations;
 - 6. Enforcement of law and maintenance of order as required and/or directed;
 - 7. Satisfactory documentation of all assigned tasks initiated or completed, and reporting unusual incidents encountered during assigned duty.
- L. Auxiliary police officers are required to attend mandatory training made necessary by their assignment or duties. Those training topics statutory required of regular police officers shall be provided. These topics include, but are not limited to:
 - 1. Use of Force;
 - 2. Weapons proficiency (authorized less lethal);
 - 3. Right to Know;
 - 4. Hazardous Materials Awareness;
 - 5. Other topics mandated by the Public Safety Director.

§ 57-21 Evaluation of Auxiliary Police

- A. Annually, the Chief of Police or designee shall submit to the State Director of Emergency Management the names and addresses of current Police Auxiliary officers and an outline of the proposed training program.
- B. Police Auxiliary officers shall receive annual performance evaluations in accordance with the Dover Police Department's Performance Evaluation directive.
 - 1. All Police Auxiliary personnel shall be evaluated.
 - 2. Personnel should be evaluated by their immediate supervisor/commander.
 - 3. The Auxiliary Police Captain shall be evaluated by the Police Liaison.

§ 57-22 Appointment of Auxiliary Police Department Members

The Mayor and Board of Aldermen may appoint from time to time auxiliary police officers in accordance with New Jersey laws for terms not exceeding one year. They shall possess and exercise all the powers and duties provided by said laws consistent with this ordinance during their term in office, but shall not be considered as regular members of the Police Department and shall not be entitled to tenure.

§ 57-23 Term of Appointment; revocation

Auxiliary police shall be appointed annually by the Mayor and Board of Aldermen for a term of one year, and the appointment may be revoked by the Mayor and Board of Aldermen without cause and without a hearing. Auxiliary police so appointed shall not be members of the police force.

Section 2.

If any chapter, article, section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction such decisions shall not affect the remaining portions of this Ordinance.

Section 3.

Except to the extent amended hereunder, all other parts or sections of Chapter 57, Police, shall remain in full force and effect. All parts and provisions of any ordinance, which are inconsistent with the provisions of this ordinance, shall be repealed to the extent of such inconsistency.

Section 4.

This Ordinance shall take effect 20 days after final adoption and publication as provided by law.
