REGULAR MEETING MINUTES November 9, 2010

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:08 pm

ROLL CALL

Present: Aldermen Delaney, Poolas (late 7:23pm), Visioli, Donofrio, Picciallo, Timpani, Romaine and Mayor Dodd Absent: Alderwoman Blackman

Also present were Administrator Close, Attorney Pennella and Maria Santana

Maria Santana stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only.

Seeing no hands and hearing no voices, Mayor Dodd closed the meeting to the public.

MAYOR'S REPORT – Mayor Dodd commented on the following:

- Toys for Tots will have a special train to collect donated toys. The train will be stopping at town hall on December 12, from 1:30PM to 2:00PM
- The Turkestanian American Association has offered to but and prepare holiday meals on November 24th from 3-7pm. Mayor Dodd noted that the town will partner with delivering food to seniors.
- The Recreation Commission will host the Annual Christmas Tree Lighting on December 1st
- Harding Avenue Road Improvement status: The top course of asphalt was put down; striping and signage have been completed.
- Chestnut Street Roadway Improvement status: Contractor has begun installation of new curbing and is expected to complete remaining curb work, milling & paving by Thanksgiving.
- Milling & paving projects have started and the streets include Garrison, Linwood, Highland, Lemar, Berry & Grant
- Department of Public Works (DPW) has completed the installation of new tables, benches, trash receptacles and recycling containers at JFK Park and they have been placed on new concrete pads to improve accessibility and maintenance.
- The signage required for the conversion of the street to a one-way should be completed tomorrow, if everything goes
 well
- Letters have been sent to the residents of Monmouth Street regarding the parking decals. The signs are scheduled to be installed next week and that's when enforcement will begin.
- Leaf collection has started and will continue through December

ADMINISTRATOR CLOSE – No report

ATTORNEY'S REPORT – Attorney Pennella noted that there's a tax appeal on tonight's agency which is a continuation of the prior year settlement and there has been no change in status of litigation since the last meeting.

Alderman Timpani commented that flag football completed there season undefeated (9-0). Mayor Dodd will host the team for a presentation at the next town meeting.

Alderwoman Romaine commented on the transfer resolution and noted that the town has excessive funds within certain account balances for various departments which are transferred to certain areas that have a shortage. Alderwoman Romaine noted that transfer can only be down after November to help with certain deficiencies.

<u>JON SPERRY</u> – 58 North Essex Street – Mr. Sperry expressed his frustration with the piles of leaves and asked if a leaf vacuum could come through North Essex Street. Mayor Dodd asked if he has seen a difference from this year to any other year with the leaf pick-up. Mr. Sperry noted that he hasn't seen the leaf vacuum come through, this year. Mayor Dodd noted that there will be a leaf vacuum in the area tomorrow.

<u>JIM MULLIN</u> – 150 Ann Street – Mr. Mullin wanted clarification on the transfer resolution, specifically, on the line item for "other insurance." Mr. Close clarified that it's an installment payments on a pre-existing claim.

<u>NANCY HAGERICH</u> – Munson Avenue – Ms. Hagerich thanked the board for the tables that she requested at the last town meeting. Ms. Hagerich will contact the recreation commission about their month meetings.

<u>DAWN DEL GUERCIO</u> – 122 Watson Drive – Mrs. Del Guercio expressed that during the past several years, there has been a hazardous condition during the winter months caused by water gathering in front of her driveway. She noted that department of public works does come around to salt and plow the area of concern. Mrs. Del Guercio commented that the streets in Salem Village were paved but Watson Drive was excluded and she wanted to know the reason for the exclusion. Mayor Dodd noted that the Engineer Department will have to look into the drainage problem because safety is an important factor. Mayor Dodd explained that the Engineering Department makes the recommendation of the streets that need to be paved. He noted that there might be circumstances that prevented Watson Drive to be paved. Mr. Close commented on several steps that are being taken and will be in contact with Mrs. Del Guercio.

Alderman Poolas arrived at 7:23 PM.

Alderman Poolas announced that the Memorial Association will host a candle light vigil at Hurd Park for Veteran's Day.
