Mike Postorino with Revenue Guard made a presentation concerning Ambulance Billing Services. Revenue Guard has over 80 clients and bill on behalf of municipality under insurance laws. The company collects revenue on whatever insurance pays. The amount billed to insurance depends on nature of the call.

The goal is to maximize Client's net revenue, improve regulatory compliance and assist the Client's EMS department as requested. Services shall include pre-billing eligibility services, coding, billing, processing, dunning notices, collection calls to patients and insurance providers, posting and other related tasks.

Osvaldo O'Rama expressed his concerns and asked if salary resolution 252-2019 be tabled till 2020. Mr. O'Rama has no confidence in the resolution and looks shady. He also stated that he supports the new administration.

Robin Kline who resides on Jackson Avenue expressed the salary resolution 252-2019 should be fair, employees earned it.
