## **REGULAR MEETING MINUTES** February 14, 2012

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:13pm

## **ROLL CALL**

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened the meeting to public.

Seeing no hands and hearing no voices Mayor Dodd closed the meeting to the public.

MAYOR'S REPORT: Mayor Dodd commented on the following:

- He expressed that Dover has been one of the lead towns for shared services. He announced that the Town of Dover has negotiated with Victory Gardens to be part of Dover's Joint Municipal Court as of March 1, 2012. He noted that Dover continues to look at ways of cost saving measures.
- Mayor Dodd has been in contact with Capt. Michael Cruz of the local National Guard unit (Dover, NJ). The Mayor noted the importance in establishing communication with the National Guard for their assistance during catastrophic events. Capt. Cruz will hold a meeting with surrounding towns' Mayors and Administrator's on how to improve communications with the National Guard.
- He reminded the public that Pequannock Street is now open. Mayor Dodd is upset with the Route 46/Route 15 Bridge project being at a stalemate. He noted that NJ Department of Transportation can not pour concrete during winter months; activity will not be seen till the spring months.
- He thanked the Dover High School Band for their spaghetti dinner. Mayor Dodd and several board members attended the event and he's proud to support their efforts.

## TAX REIMBURSEMENT CERTIFICATION

**WHEREAS**, the Recycling Enhancement Act, P.L. 2007, Chapter 311, has established a recycling fund from which tonnage grants are made to municipalities in order to encourage local source separation and recycling programs; and

**WHEREAS**, there is levied upon the owner or operator of every solid waste facility (with certain exceptions) a recycling tax of \$3.00 per ton on all solid waste accepted for disposal or transfer at the solid waste facility.

**WHEREAS**, whenever a municipality operates a municipal service system for solid waste collection, or provides for regular solid waste collection service under a contract awarded pursuant to the "Local Public Contracts Law", the amount of grant monies received by the municipality shall not be less than the annual amount of recycling tax paid by the municipality except that all grant moneys received by the municipality shall be expended only for its recycling program.

**NOW THEREFORE BE IT RESOLVED** by the Town of Dover that the Town of Dover hereby certifies a submission of expenditure for taxes paid pursuant to P.L. 2007, Chapter 311, in 2011 in the amount of \$16,203.24. Documentation supporting this submission is available at 37 N. Sussex St., Dover, NJ and shall be maintained for no less than five years from this date.

#### ORDINANCE NO. 02-2012 ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER PROVIDING FOR HANDICAPPED PARKING SPACE AT 14 SUMMER AVE.

**BE IT ORDAINED** by the Mayor and Board of Aldermen of the Town of Dover, County of Morris, State of New Jersey, as follows:

#### SECTION 1. Description for handicap parking space to be located at 14 Summer Ave.

Said handicap parking space shall be located along the northerly curb line of Summer Avenue beginning at a point 372 feet east of the northeasterly curb line intersection of S. Morris Street and Summer Avenue, thence continuing in an easterly direction for a distance of 20 feet. End Description.

**SECTION 2.** All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. The Ordinance shall take effect in accordance with law.

## RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER <u>AUTHORIZING APPROVAL OF INSTITUTIONAL AND ENGINEERING CONTROLS</u> <u>FOR BLOCK 901, LOT 1.02, A PORTION OF COMMERCE CENTER DRIVE</u> <u>AND A PORTION OF N. SUSSEX STREET</u>

WHEREAS, by Ordinance #34-99, the Town of Dover established a redevelopment plan for Block 901, Lot 1; and

**WHEREAS**, pursuant to such Plan, the Town of Dover advertised for proposals for the development of Block 901, Lot 1.02, the "Redevelopment Property"; and,

WHEREAS, Woodmont at Dover ET, LLC, hereinafter "Woodmont," was named as the developer of the redevelopment property; and

**WHEREAS**, Woodmont, as part of the conditions of the transfer of title to them for Block 901, Lot 1, undertook the remediation of the property which contained the former Dover Landfill and also that part of the landfill located on Town of Dover property; and

**WHEREAS**, Woodmont is undertaking a remediation of the property identified as the Town of Dover Department of Public Works at Block 901, Lot 1.02 of the tax map of the Town of Dover, New Jersey, a portion of Commerce Center Drive starting at the southern end and extending 620 feet to the north for the entire width of the roadway, and a portion of North Sussex Street Extension starting 140 feet to the north of Roswell Street and extending 345 feet to the north, ("Property"), pursuant to the requirements of the New Jersey Department of Environmental Protection ("NJDEP"); and

WHEREAS, the Town of Dover is the owner of the property; and

**WHEREAS**, pursuant to a Remedial Action Work Plan, dated January 2007, locations on the property have been identified with levels of contaminants in excess of the unrestricted use standard(s) set by the NJDEP; and

**WHEREAS**, pursuant to its Technical Requirements for Site Remediation, N.J.A.C. 7:26E-1.1 *et. seq.*, the NJDEP provides for the establishment of institutional and engineering controls as a remedy for soil with concentrations of substances which are in excess of the unrestricted use standard(s) set by the NJDEP; and

WHEREAS, only the Town of Dover, as owner of the Property, has the authority to execute and record a Deed Notice.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

1. **WHEREAS**, the Town of Dover of the County of Morris, State of New Jersey, has established a Joint Municipal Court serving the Town of Dover, Township of Mine Hill, Borough of Mt. Arlington, Borough of Rockaway and Borough of Wharton under a Shared Services Agreement with the Town of Dover as lead agency; and

WHEREAS, the Borough of Victory Gardens currently operates its own municipal court in the town adjoining the Town of Dover; and

**WHEREAS**, the municipalities have determined it to be in their mutual best interests to provide for joint municipal court facilities, personnel and resources for use by their respective municipal courts with Dover as the lead agency; and,

WHEREAS, the agreement is established in accordance with the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:61-1 *et. seq.*; and

**WHEREAS**, each of participating municipalities will realize a savings to their respective tax payers in entering into this Shared Service Agreement; and

**WHEREAS**, the scope of services provides that Dover will make the necessary facilities available by way of courtroom, offices and storage space; and

**WHEREAS**, the Dover Municipal Court personnel will include judges, prosecutors and public defenders, interpreters and court administrators as well as security personnel; and

WHEREAS, the municipal court operations will be managed by Dover as a joint court using one set of books and one court calendar; and

WHEREAS, all municipalities will each receive and retain all net revenues generated by each of their respective cases; and

**WHEREAS**, the supported municipalities have agreed to pay increases based upon increases in the cost of the operation of the joint municipal court; and

**WHEREAS**, Dover will be able to obtain a substantial annual cost savings benefit which benefit must continue into the future of the agreement; and

WHEREAS, additional municipal participants may become part of the joint municipal court; and

**WHEREAS**, there will be two judges and two prosecutors appointed with Dover making a recommendation for the presiding judge and the presiding prosecutor and a committee to be established to make a recommendation for the second judge and prosecutor; and

Hanlon, Dunn and Robertson, Attorneys at Law, to be appointed as Conflicts Public Defender effective February 15-29, 2012 for the customary remuneration, but effective March 1, 2012, Alexa Perry, Esq. of Hanlon, Dunn and Robertson, Attorneys at Law shall transition to Chief Public Defender of the Joint Court of Dover, serving the Town of Dover, Township of Mine Hill, Borough of Mt.
