#### ORDINANCE NO. 12-2006 OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER PROHIBITING PARKING ON A PORTION OF BERKSHIRE AVENUE

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

1. Parking is hereby prohibited on the easterly side of Berkshire Ave. from its intersection with Turner Street to the south, in a northerly direction to the municipal boundary with Rockaway Township.

2. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistency.

3. This ordinance shall take effect in accordance with law.

# ORDINANCE NO. 13-2006

## Of The Mayor and Board of Aldermen of the Town of Dover Providing the Street Name for a New Roadway to be Built on Block 901, Lots 1 and 1.01

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover as follows:

1. The roadway described on the attached Schedule A commencing at Mt. Pleasant Avenue and traveling southward across lots 1 and 1.01 in Block 901 is hereby named Commerce Center Drive; and

2. This name shall be submitted to the Planning Board of the Town of Dover for its approval pursuant to the Code of the Town of Dover, Section 236-58, q.; and

3. This Ordinance shall be effective upon final passage and advertisement and upon approval by the Planning Board to the Town of Dover.

4. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.

5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

6. The Ordinance shall take effect in accordance with law.

#### ORDINANCE No. 14-2006 AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AMENDING AND SUPPLEMENTING CHAPTER 265 OF THE CODE OF DOVERENTITLED "PARKS AND RECREATION"

#### Ordinance 15-2006: First Reading

## ORDINANCE NO. 15-2006 CALENDAR YEAR 2006 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK N.J.S.A. 40a:4-45.154)

WHEREAS, the Local Government Cap Law, N,J.S.40A"4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Mayor and Board of Aldermen of the Town of Dover in the County of Morris finds it advisable and necessary to increase its CY 2006 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Mayor and Board of Aldermen hereby determines that a 1% increase in the budget for said year, amounting to \$93,403 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Mayor and Board of Aldermen hereby determine that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Board of Aldermen of the Town of Dover, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2006 budget year, the final appropriations of the Town of Dover shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$326,909 and that the CY 2006 municipal budget for the Town of Dover be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Whereas, two matters are pending in the Tax Court of New Jersey and/or the Morris County Tax Board brought by *Morristown & Erie Railway, Inc.*, with respect to property owned by the County of Morris at Block 604, Lot 5, leased to the plaintiff, and parts of which are in turn leased by the plaintiff to third parties for non-railroad use, and

Whereas, the Tax Assessor and Special Counsel for Dover, after inspecting the sites, analyzing and examining the plaintiff's claims for dual assessment and exemption, and Dover's counterclaim on the issues of valuation and assessment for that part of the property in non-railroad use, and considering other appropriate information, have recommend that the matters be settled on the terms specified on the attached *Stipulation of Settlement*, as supplemented by an April 6, 2006 letter signed by Jon Huston, Esq., including payment to the Town of \$41,200.00 for taxes, interest, costs, and penalties, and

Whereas, after considering this recommendation and the supporting facts and circumstances, the Mayor and Board of Aldermen concur with this recommendation, and have determined that the proposed settlement is in the best interest of the Town of Dover,

Now, therefore it is resolved by the Mayor and Board of Aldermen of the Town of Dover, as follows:

Special Counsel, Jon Huston, Esq. is authorized to sign the proposed *Stipulation of Settlement* in the form as attached, and to sign such other documents as are necessary to finalize the settlement.

## Resolution Authorizing the Execution of a Mutual Firefighting and EMS Assistance Agreement with Mine Hill

1. The Mayor and Clerk are hereby authorized to execute a mutual firefighting and EMS assistance agreement with the Township of Minehill.

Virginia Brennan – 17 Cross St. Questioned the terms of the agreement for the Town Administrator. Mayor Dodd responded that there is not a signed agreement, therefore it can't be discussed.

Ed Ridner -33 Knickerbocker Ave. Questioned the terms of the pay increase for the Town Administrator Satellite Dishes – they are being hung off fire escapes. This is a safety issue. Certain awnings are also a safety issue to the fire department.

Renee Jacoby – Baker St. Concerned about the ethics of the Town Administrator regarding the recent events regarding the administrator's renegotiating contract. The 1.5% pay increase for town employees by previous administration was also questioned. Why is overtime reported differently at town hall than at the Water Department. Hallway as it relates to court is unsafe. OPRA information from Water Commission has been slow in forthcoming.

Jon Sperry -158 Essex St. - Questioned why at public meeting last week, why wasn't public allowed to speak. The lights in the park were not taken care of by Alderman Delaney. Mr. Sperry was able to get the lights replaced by JCPL employees. Signage for park should be moved as it relates to the hours of the park.

Bob Woodhull-North Sussex St.. When are trucks doing work at FEDEX going to stop going by his house on N. Sussex St.

Matthew Barrick – 107 Bassett Highway. Concerned that no one has gone to the owners of properties regarding the Bassett Highway project.

Bill Cook – Princeton Ave. How much time will tenants are given to vacate their businesses regarding the Bassett Highway project.

Mike Cicchetti – 130 S. Salem St. Questioned how defined the law would be in regards to people walking thru parks with regards to Ordinance 14-2006.
