# SUPPORTING THE NEW JERSEY EMPLOYER SUPPORT GUARD AND RESERVE WITH THEIR EMPLOYMENT INITIATIVE PROGRAM

WHEREAS, on Tuesday, January 24, the Commander-in-Chief of our Armed Forces reminded all Americans that, "Above all, our freedom endures because of the men and women in uniform who defend it," and that "... this generation of heroes has made the United States safer and more respected around the world"; and

WHEREAS, the President, further, promised, "As they come home, we must serve them as well as they've served us. That includes giving them the care and the benefits they have earned ... And it means enlisting our veterans in the work of rebuilding our nation"; and

WHEREAS, National Guard and Reserve forces today total over 1 million service members and represent 48 percent of our total military force; while every day around the globe, thousands of men and women in uniform, including dedicated members of the National Guard and Reserves, risk their lives and make great sacrifices to defend our national interests, serving extended tours away from their homes, families and jobs; and

WHEREAS, at the same time, we are now seeing unprecedented levels of unemployment and underemployment among members of the Guard and Reserve, as up to 22 percent of Guard and Reserve members face unemployment; and

WHEREAS, in this time of economic uncertainty, the Employer Support Guard and Reserve (ESGR) is focusing on connecting employers with the talented pool of service members and their spouses, with the intent of facilitating meaningful employment opportunities; and

WHEREAS, to further this goal, the New Jersey ESGR has launched an Employment Initiative Program (EIP), which is a collaborative effort with federal agencies including the Department of Labor (Veterans Affairs), the Department of Veterans, the Small Business Administration and the Office of Personnel Management; and

WHEREAS, the goal is to enhance the employment process and serve as an effective resource for service members and employers. ESGR is also partnering with Employer Partnership of the Armed Forces (EPAF) through EIP with a high-tech and high-touch approach; and

WHEREAS, for almost a year, now, the United States Chamber of Commerce has also endeavored to find employment for our returning veterans and the spouses of those who continue to serve, at home and abroad, with its Hiring Our Heroes program; and

WHEREAS, the Hiring Our Heroes program is a nationwide effort to help veterans and military spouses find meaningful employment, in partnership with the Department of Labor Veterans Employment and Training Service (DOL VETS), to improve public-private sector coordination in local communities, where veterans and their families are returning every day; and

WHEREAS, despite those efforts, the unemployment rate for veterans of our Armed Forces in our Nation and in our State continues to exceed the over-all rate; and

WHEREAS, in order to take the lead on advancing the EIP to the next level, the New Jersey ESGR has enlisted strong and positive support from corporate leaders, the New Jersey State Chamber of Commerce, US Dept. of

Labor/VETS and the New Jersey League of Municipalities; and

WHEREAS, it is incumbent on all of us to prove that New Jersey cares for the men and women in uniform who risk their lives and make great sacrifices to defend our national interests; and

WHEREAS, this employment initiative can be New Jersey's way of saying thank you to the men and women who made great sacrifices to protect our nation's freedom; and

WHEREAS, local officials throughout the State of New Jersey, working together through the League of Municipalities, and with the New Jersey ESGR, their local and State Chambers of Commerce, and local business leaders can help to advance basic fairness to our vets and their families by pursuing one simple goal: to allow America's over one million unemployed veterans and military spouses to follow their dreams, instead of spending their lives just trying to catch up; now therefore be it,

RESOLVED, on this April 24, 2012 that the Mayor and Board of Aldermen of the Town of Dover recognizes that we will never be able to repay the debt we owe to all members of our armed forces; and

BE IT FURTHER RESOLVED, that in gratitude, the Town of Dover pledges its enthusiastic and unqualified support for the Employment Initiative Program of the New Jersey Employer Support Guard and Reserves; and

# A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER SUPPORTING PROPOSED LEGISLATION TO REQUIRE FIRE DISTRICTS, SCHOOL DISTRICTS AND COUNTY GOVERNMENTS TO PAY THEIR FAIR SHARE OF TAX APPEAL REFUNDS AND SETTLEMENTS (S-2904 AND A-1503)

WHEREAS, municipalities are presently required to full fund refunds resulting from real property tax appeals despite the fact that fire districts, school districts, and county government all are funded through the tax revenue which is the subject of the appeals; and

WHEREAS, the current real estate market has resulted in an unprecedented number of tax appeals which have created a substantial burden on municipalities who are required to fund the entire cost of defending the appeals and payment of resulting judgments requiring tax refunds; and

**WHEREAS,** Senator Anthony Bucco has introduced legislation, S-2904, which would require municipal tax collectors to deduct the applicable pro rata share of property tax refunds from the amounts to be paid in a subsequent tax year to the county, school district or fire district; and

**WHEREAS**, the Mayor and Board of Aldermen of the Town of Dover support the efforts of Senator Bucco and those in the Assembly who have introduced the Assembly version of this legislation, A-1503

**NOW, THEREFORE, BE IT RESOLVED,** by the Mayor and Board of Aldermen of the Town of Dover, in the County of Morris, and State of New Jersey that the Town of Dover supports the proposed legislation to require fire districts, school districts and county governments to pay their fair share of tax appeal refunds and settlements (S-2904 and A-1503) and urges the Legislature to move forward with this important legislation; and be it

**FURTHER RESOLVED,** that a copy of this Resolution also be provided to our State legislative representatives, neighboring communities, and the New Jersey State League of Municipalities.

- 4. The Ordinance shall take effect in accordance with law.

# AMMENDING EMERGENCY APPROPRIATION RESOLUTION ADOPTED ON OCTOBER 25, 2011 FOR EXPENSES INCURRED BY HURRICANE IRENE

**WHEREAS**, it had been found necessary to make an Emergency Appropriation to meet certain extraordinary expenses incurred, by Hurricane Irene and,

**WHEREAS**, NJS 40A:4-55.1 provides that it shall be lawful to make such appropriation, which appropriation and/or the "special emergency notes" issued to finance the same shall be provided for in succeeding annual budgets by the inclusion of an appropriation of at least one-fifth of the amount authorized pursuant to this act.

**NOW, THEREFORE BE IT RESOLVED**, (by not less than two-thirds of all governing body members affirmatively concurring) that in accordance with the provisions of NJS 40A:4-55.1:

1. An emergency appropriation was made for Hurricane Irene in the total amount of \$250,000.00, for expenses incurred or to be incurred, and said emergency appropriation shall be provided for in the budgets of the next succeeding years by the inclusion of not less than \$50,000.00.

- 2. With reimbursements from FEMA and projected expenses not as costly, the Mayor and Board of Aldermen of the Town of Dover would like to amend the amount of the Emergency Appropriation to \$125,000.00 and said emergency appropriation shall be provided for in the budgets of the next succeeding years by the inclusion of not less than \$25,000.00.
- 3. That two (2) certified copies of this resolution will be filed with the Director of the Division of Local Government Services; however, no approval is required from the Division.

He noted that certain areas (growth) can not be touched because it's protected by NJ Department of Protection (NJDEP). He expressed that the clean up is not affected by the budget cuts but more by the manpower since the town is not replacing employees that retire. Mr. Close noted that the town invested in new park benches for Hurd Park and two new tables will be coming soon.
