CAUCUS MEETING MINUTES May 12, 2015 7:00 PM

The Caucus Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

Mayor Dodd called the meeting to order at 7:00 pm

All joined in the Pledge of Allegiance to the Flag.

Mayor Dodd commented that resolution #7-"Supporting S1696 and A2135" is an issue of public safety concern. He feels that undocumented people will drive with or without a driver's license and noted that he supports the bill because then all drivers can be held accountable. Mayor Dodd supports this resolution and hopes that the other board members do as well.

Mayor Dodd explained that the resolution only shows supports for the bill to go to the state legislature. Alderwoman Romaine expressed that having uninsured motorist impacts the entire state and agrees with supporting the resolution.

Alderman Visioli commented that it's a matter of developing a process and starting to do things the right way. He noted that it's a development of a process which needs the approval of the state legislature.

Ms. Jackie Zapata (63 Michigan Avenue, Wharton) from Wind of Spirit translated (English to Spanish) for the Mayor and Board of Aldermen.

REGULAR MEETING MINUTES May 12, 2015

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:07 pm

ROLL CALL

Present: Aldermen Visioli, Picciallo, Romaine, Blackman, Rutan, Noriega, MacDonald, Toth and Mayor Dodd

Also present were Municipal Clerk Margaret Verga, Administrator Donald Travisano and Attorney Downs

Municipal Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened the meeting to the public on any agenda items.

Connie Sibona–Foster – 90 Penn Avenue, Dover – She wanted to know if the Baker Theater is truly being used as a theater and questioned the minimal fee for a theater license. Mayor Dodd explained that a licensing inspector position has been created and each ordinance regarding municipal licenses will be thoroughly reviewed and updated.

Jackie Zapata – 63 Michigan Avenue, Wharton - She expressed that the room is packed which shows the community is present. She commented that people are present to get the support on the resolution that allows the issuance of driving privilege cards to undocumented residents. She noted that it's a safety public issue and not an immigration issue. (She also translated her comments in Spanish)

Reverend Anthony Menzel - Abundant Love Christian Church (located in St. John's Episcopal Church) – Pastor Menzel commented that he's had to deal with the issue of undocumented people without driver's license on a personal level. He noted that members of his congregation want to drive but live in constant fear. He believes that the matter should be handled in a compassionate way and financially sound way.

Elba Perez – 53 E. McFarlan Avenue, Dover – We are hardworking individuals that live in the community. She commented that not having a driver's license makes it very difficult for families. She currently has a driver's license but supports everyone that needs one. She also commented that the town needs schools buses.

Mayor Dodd commented that he was born and raised in the Town of Dover and as a young boy he had to walk during inclement weather to school however the lack of school buses is a board of education issue and not a town issue. The Town of Dover has historically always been considered a walking district. Attorney Downs reinforced that the Board of Education has the only authority over school buses.

Connie Sibona-Foster -90 Penn Avenue, Dover - She clarified that under state law the town of Dover does not have to provide transportation since the town is less than 2 miles. She also noted that the Board of Education provides transportation to special needs students. Mrs. Sibona-Foster commented that transportation can be a very expensive issue which can cause a rise in taxes.

Karol Ruiz – Dover Resident – Ms. Ruiz urged the board to support the resolution for the public safety of the community and for the benefit of the immigrants in Dover and throughout the state. Ms. Ruiz provided statistics from the NJ Policy Prospective Study which was received in support of the resolution. She believes that providing driver's licenses to undocumented immigrants will ensure the building of trust between the police department and the undocumented immigrant communities. She commented that in the past the board has not supported the immigrant community and referred to the opposition on the resolution pertaining to the education of the undocumented community. It was clarified that the board did support that resolution. Discussions on the support of the immigrant community continued...

Mayor Dodd encouraged everyone to provide their comments but made it clear that he's pretty confident that the board will vote in favorable of the resolution.

Edward Correa – 88 E. Blackwell Street – Mr. Correa provided a history on his background and noted that he's an advocate for the voice of the voiceless. He noted that he is a community advocate and not an advocate of criminals or those who do not want to follow the law. He provided a story regarding a friend that was stopped by police and was fined differently because of her immigration status. He commented that the Mayor is not a friend of the immigrant community and is moving the resolution forward because of political reasons.

Mayor Dodd expressed that he doesn't appreciate Mr. Correa's comments that he is not a friend of the immigrant community because he is a friend. He also doesn't appreciate that Mr. Correa is trying to make the resolution a political issue. Mayor Dodd commented that it's about the livelihood of people and immigrants who need driver's license for their families. He reiterated that the matter is not political and it's a quality of life issue.

Yolanda Ruiz – 98 Prospect Street, Dover – She is happy to hear that Mayor Dodd is a friend of the immigrant community but noted that this is the time to prove it by speaking to the Governor. She has not seen or heard the Mayor's proposal to help the community and the youth. Mayor Dodd explained that he has taken the position to put the resolution on the agenda for the board to vote on it. He noted that a letter will be drafted to the Governor to show the town's support. She asked that the Mayor also include the children of the community when making decisions on what issues should be on the agenda.

Mayor Dodd expressed that her comments were not fair to the community because the board has established several programs for the youth; however the participation is very small. He noted that the board supported the Youth Empowerment Impact Program along with a host of programs and expressed that parents also have to get involved. Jackie Zapata commented on the community center and the upcoming events.

Nelly Bobadilla - 43 Mase Avenue, Dover – Ms. Bobadilla asked the board to support the resolution and thanked them for all they have done in the community.

Alandra (*last name inaudible*) – Dover High School student – She asked for the board's support on the resolution. She provide a brief family history and the difficulties they incur because her mother does not have a driver's license.

Jose Ruiz – 27 W. Fairview Avenue, Dover – Mr. Ruiz asked for the board's support on the resolution. He provided information on his background and how driver's licenses would help the community.

Mr. Vargas – 83 Guy Street – Ms. Vargas provided information on her background and asked the board to support to the resolution.

Ricardo (*last name inaudible*) - 40 Central Avenue, Dover – He wanted to know if the town of Dover had the authority to issue driver's licenses to undocumented residents. It was noted that the town of Dover does not have the authority. He asked that the board support the resolution.

$\frac{\textbf{RESOLUTION IN SUPPORT OF EXPANDING ACCESS TO DRIVER'S LICENSES}}{\textbf{TO UNDOCUMENTED NEW JERSEY RESIDENTS}}$

WHEREAS, Town of Dover values the contributions of all residents, including immigrants, to the economic health, cultural diversity, and public safety of the Town of Dover; and

WHEREAS, Town of Dover recognizes the fundamental importance of all of our residents' ability to participate in civic life, ensure the health and safety of their families, and to move freely across this State; and

WHEREAS, New Jersey law currently prohibits undocumented residents from obtaining a driver's license; and

WHEREAS, other states, including California, Colorado, Connecticut, Illinois, Maryland, Nevada, New Mexico, Vermont, Washington, and Utah, as well as Washington, D.C. and Puerto Rico do not prohibit access to driver's licenses based on immigration status;

WHEREAS, the safety of Town of Dover's roads would be enhanced if all residents of appropriate driving age were tested, trained, licensed, and insured, regardless of immigration status; and

WHEREAS, The AAA Foundation for Traffic Safety has documented that car crashes rank among the leading causes of death in the United States and that approximately one in five fatal crashes in the United States involve an unlicensed or invalidly licensed driver; and

WHEREAS, New Jersey would become safer with fewer uninsured and unlicensed drivers on the road, resulting in a predicted decrease in fatal traffic accidents and fewer hit-and-run crimes; and

WHEREAS, the public safety of Town of Dover would be enhanced by helping bring immigrant communities out of the shadows to participate more fully in civic life, building trust and cooperation between immigrant communities and law enforcement and strengthening the ability of police to investigate and solve crimes; and

WHEREAS, New Jersey Policy Perspective (NJPP) estimates that if New Jersey law were changed to expand access to

driver's licenses to undocumented residents, between 153,000 and 278,000 New Jersey residents would apply for a driver's license within the first three years of eligibility; and

WHEREAS, expanding access to driver's licenses would enhance New Jersey's and Town of Dover's economy; and

WHEREAS, undocumented immigrants pay an estimated \$476 million in state and local taxes in New Jersey each year;

WHEREAS, NJPP estimates that New Jersey insurance companies would take in over \$200 million in additional premiums per year, saving money for existing policyholders by expanding the pool of policyholders and reducing the number of claims against uninsured drivers; and

WHEREAS, the State of New Jersey would take in millions in new revenue from fees paid by new driver's license applicants and license renewals;

WHEREAS, Town of Dover's local economy would be bolstered by strengthening the mobility of its workforce and enhancing economic participation in undocumented communities; now therefore

BE IT RESOLVED by the Mayor and the Board of Alderman that the Town of Dover supports expanding access to driver's licenses to undocumented New Jersey residents; and

BE IT FURTHER RESOLVED that Mayor and Board of Aldermen of the Town of Dover urges the New Jersey State Legislature to pass legislation and urges the Governor to sign legislation expanding access to driver's licenses to undocumented New Jersey residents; and

BE IT FURTHER RESOLVED that a copy of this resolution shall be forwarded by the Municipal Clerk to the offices of Senator Anthony R. Bucco; Assemblyman Michael Carrol; Assemblyman Anthony Bucco; and Governor Chris Christie.
