ORDINANCE NO. 13-2014 ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER PROVIDING FOR HANDICAPPED PARKING SPACE AT 6 JAMES STREET

SECTION 4. The Ordinance shall take effect in accordance with law.

WHEREAS, it is the policy of the Town of Dover to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of the Town of Dover has determined that certain procedures need to be established to accomplish this policy

NOW, THEREFORE BET IT ADOPTED by the Mayor and Board of Aldermen that:

Section 1: No official, employee, appointee or volunteer of the Town of Dover by whatever title town, or any entity that is in way a part of the town shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the town's business or using the facilities or property of the town.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Town of Dover to provide services that otherwise could be performed by the Town of Dover.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

Section 4: The Administrator/Clerk shall establish written procedures for any person to report alleged discrimination, harassment and violation of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a compliant so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaint.

Section 5: No person shall retaliate against and person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Administrator/Clerk shall establish written procedures that require all officials, employees, appointees and volunteers of the town as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

Section 7: The Administrator/Clerk shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

Section 8: At least annually, the Administrator/Clerk shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the town. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the town's website.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Town in order for the public to be made aware of this policy and the town's commitment to the implementation and enforcement of this policy.
