Mayor Dodd thanked Administrator Close, Alderwoman Romaine, Alderman Visioli and Alderman Rutan (Finance Committee) for their hard work on the budget. Mayor Dodd noted sacrifices had to be made in order not exceed the 2% CAP. He expressed that Dover came below the 2% CAP. He explained that the average home assessed at \$290,025 will see a tax increase of \$19.58 per month. Budget discussions continued.

Mayor Dodd spoke about resolution awarding the bid for solid waste and recyclable materials collection. He noted that there will be a savings with the new bid proposal. He explained that difference in prices. He thanked Michael Hantson and Bill Isselin for their efforts.

Mayor Dodd expressed his concern with the UCEDA Institute's noise permit. He asked that the times be changed especially on Sunday due to church services. Mayor Dodd asked that the resolution be approved with conditions.

SUPPORTS A-2717, WHICH WOULD EXTEND THE TIME PERIOD FOR MUNICIPALITIES TO COMMIT TO EXPEND AFFORDABLE HOUSING TRUST FUND MONIES

WHEREAS, P.L. 2008, c. 46 established a four year timetable for municipal housing trust dollars to be "committed for expenditure, or risk forfeiture to the State;" and

WHEREAS, the 2008 Act did not define the term "committed for expenditure" and deferred to the Council on Affordable Housing (COAH) to promulgate regulations as to the requirements to be met for "committed" as well as a timetable for expenditures; and

WHEREAS, neither COAH nor the Department of Community Affairs has adopted, nor proposed, the regulations pursuant P.L. 2008, c 46; and

WHEREAS, hundreds of municipalities submitted spending plans to COAH, of which only a fraction of these plans were reviewed by the agency, and most of these municipalities have not been provided any guidance on their spending plans; and

WHEREAS, at the time of the 2008 Act, COAH was prepared to adopt its "third round regulations" establishing municipal obligations under the Fair Housing Act; and

WHEREAS, COAH's third round regulations were set aside by the Appellate Division, and the appeal of that decision now awaits consideration by the State Supreme Court, and

WHEREAS, eight years of litigation over COAH's methodology has had a chilling effect not only on the development of affordable housing, but on the ability of local governments to commit trust fund dollars without knowledge of their respective obligations, and certainty that such commitment would count towards its housing obligation; and

WHEREAS, forfeiture of trust fund dollars should be used as intended: to subsidize the costs for municipalities in meeting their affordable housing obligations while assuring that these costs do not fall to local taxpayers; and

WHEREAS, pursuant to the timetable established by P.L. 2008, c. 46, twenty-one Morris County municipalities will be required to forfeit over 21 million dollars in housing trust funds as of July 18, 2012;

NOW, THEREFORE, BE IT RESLOVED, THAT THE Mayor and Board of Aldermen of the Town of Dover urges our State Legislators to support and approve A-2717, which will provide a four-year extension for municipalities to commit the municipal housing trust fund dollars; and

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the sponsor of A-2717, Assemblyman Anthony Bucco, all Morris County local legislative representatives, members of the Assembly Housing and Local Government Committee, the New Jersey State League of Municipalities and the Office of the Governor.

ORDINANCE FOR FIRST READING

ORDINANCE NO. 08-2012

CALENDAR YEAR 2012 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK N.J.S.A. 40a:4-45.14)

WHEREAS, the Local Government Cap Law, N,J.S.40A"4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Mayor and Board of Aldermen of the Town of Dover in the County of Morris finds it advisable and necessary to increase its CY 2011 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Mayor and Board of Aldermen hereby determines that a 1.0% increase in the budget for said year, amounting to \$148,183 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Mayor and Board of Aldermen hereby determine that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Board of Aldermen of the Town of Dover, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2012 budget year, the final appropriations of the Town of Dover shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$518,642 and that the CY 2012 municipal budget for the Town of Dover be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon; be filed with said Director within 5 days after such adoption.

ORDINANCE NO. 07-2012 OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AMENDING AND SUPPLEMENTING CHAPTER 105-11 "ALCOHOLIC BEVERAGE LICENSE FEES"
