RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AUTHORIZING THE TOWN OF DOVER TO APPLY FOR, ACCEPT, AND EXECUTE ANY AND ALL DOCUMENTATION WITH THE NJDEP PERTAINING TO A GRANT IN THE AMOUNT OF \$24,000 FOR THE PURCHASE AND INSTALLATION OF DUAL-PORT CHARGING STATIONS

Mayor Dodd opened the meeting to the public.

Kathy Barreto—Dover High School Teacher and Vice President of the Dover Education Association — Ms. Barreto discussed the negative impact that Senator Sweeney's proposed Path to Progress would impose on teachers. She provided examples of the increase in health premiums with Chapter 78. She requested help from the Board to oppose the legislation.

Noreen Staples—Brookside, NJ—Ms. Staples requested that the Town film their Town Meetings and asked about the costs to film the meetings. She also requested clarification regarding the three minutes the public has to comment during the meeting.

Brian Adams—NJEA and CCEA Member—Mr. Adams represented educators of Dover and Morris County on the opposition of Senators Sweeney's Path to Progress proposal. He addressed mistruths within the proposed Resolution. He pointed out the State's failure to pay their share into the public pension system and mentioned a way to fix it.

John Caniglio—509 Mount Hope Avenue, Dover— President of the Dover Education Association. Mr. Caniglio is also a teacher in Dover and asked that the Board vote no on the Path to Progress. He stated that the State is forcing public employees to pay more for reduced benefits and reduced pension with an unfair approach that mirrors that of Chapter 78.

Karol Ruiz—86 South Morris Street, Dover— Co-President of Wind of the Spirit and member of CWA. Ms. Ruiz stated the Senator's Path to Progress would affect many of the residents of Dover. She asked that the Board do research regarding the proposed plan. She stated that adoption of the Senator's plan would cause the Town difficulties in securing teachers.

Mark M— 10 Ridgedale Avenue, Morristown— Mr. M from NJ Working Families presented statistics in regards to those who would be affected by the Path to Progress. He presented the Board with several different State issues that they could become more involved with.

Judy Rugg—28 Audrey Place, Dover— Ms. Rugg asked when the PLA and responsible bidders' pieces of legislation would be placed on the agenda.

Laurie Schorno—President of Morris County Council of Education Association. Ms. Schorno urged the Board to consider the salaries of teachers versus other professionals. She stated healthcare and retirement benefits are provided in exchange for their much lower salaries.

TC McCourt—32 Davis Avenue, Dover—Mr. McCourt stated he does believe that there is some benefits in the written proposal for Senator Sweeney's Path to Progress in regards to cutting down on administrative costs. However he is in opposition because many of those who would be affected by the plan are residents of Dover. He mentioned how prideful he is of Dover and the progress with redevelopment. He specifically mentioned the Meridia Transit Plaza and thanked the board for their support of the project.

Janet Quinones—221 Penn Avenue, Dover—Ms. Quinones is a paying member of the CWA 1037. She stated that the plan would hurt the taxpayers. She also mentioned that the Path to Progress would remove the ability for collective bargaining. She asked the Board to vote no if the Path to Progress comes up in the future for voting.

Mayor Dodd made the motion to adjourn at 7:43 PM and Alderwoman Wittner the motion and duly seconded and passed it by the following voice vote.
