# REGULAR MEETING MINUTES DOVER TOWN HALL 37 N. SUSSEX ST., DOVER, NJ 07801 JUNE 23, 2020

Mayor Carolyn Blackman called the June 23, 2020 Regular Meeting of the Mayor and Board of Alderman to order at 7:01p.m. and read the Sunshine Statement that the meeting was being held in accordance with the Open Public Meetings Act, also known as the Sunshine Law, N.J.S.A. 10:4-6. Notice of the meeting was sent to the Daily Record and Star Ledger on January 4, 2020 and published in the Record and Ledger on January 10, 2020. Notice was also posted on the Bulletin Board in Town Hall.

Alderman Ballesteros asked for clarification about Resolution 170-2020. Mayor Blackman asked Bill Isselin to explain the resolution. Mr. Isselin explained that there will be 26 spaces spread out on Blackwell Street from Blackwell to Prospect and on side streets in front of restaurants. Alderman Ballesteros asked if a number could be added to the Resolution. Bill Isselin stated that the Resolution number would be on the signs. Alderman Ballesteros clarified his question about numbering the signs and Mr. Isselin clarified that the parking spaces are not going to be reserved for a particular business but will allow a 15-minute parking zone to support businesses in general. Deputy Administrator Sanchez commented that the resolutions are temporary signage until the State of Emergency is lifted to help our business community. Deputy Administrator Sanchez stated that if the parking zones work, it may be discussed with the Economic Development Committee to make some of the 15-minute parking zones permanent via an Ordinance.

Following the explanation, a motion was made by Alderwoman Wittner, to adopt Resolutions 166-2020 to 173-2020, which was seconded by Alderwoman Cruz.

Resolution 174-2020 was approved by a vote of 9-0.

With no other business on the agenda, the Board then held the public comment portion of the meeting.

#### PUBLIC COMMENT

Mayor Blackman read a statement regarding public comment and then opened the meeting to the public.

Antonio Acosta, 130 Madison St., Dover, NJ – Mr. Acosta stated that he hopes in person meetings will begin again and that it is difficult to hear, especially the Mayor. He also spoke about the last meeting, that the Mayor spoke about litter and being aware of it. He challenged the Board to take it further and use Facebook, Instagram and rally behind it so everyone is on the same page and to deploy all the assets we have. Mr. Acosta also commented about the Pride Flag being hoisted at JFK Park and hopes that it is at Town Hall, in a more visible spot. Mr. Acosta also spoke about COVID-19 and that it showed we do not have enough space in Dover and he hopes to see the Board of Education cooperate and open up the track and tennis courts. He spoke of the importance of open space. Mr. Acosta also spoke about the Board of Education meeting, where test scores were presented. He stated that 90% of Hispanic kids were below state levels and African American children were worse. He said that the results are disappointing and we have to do better. He also commented that the Board members should be more active and engaged at meetings. [Someone on the call said blah blah].

Mayor Blackman thanked Mr. Acosta for his comments. The Mayor also commented that the administrator and Board are working to move things in the right direction. The Mayor also thanked Mr. Acosta for the update about the schools.

Susan Shauer, 346 W. Clinton St., Dover NJ – Ms. Shauer spoke about a flyer sent to Dover residents about Wind of the Spirit March against Racial Injustice at Crescent Field. She wanted to know does anyone have a permit for this march and is the Town prepared. She also asked

about the financial implications, including overtime, trash pickup and about a possible increase in COVID-19.

Mayor Blackman asked Deputy Chief Delaney to respond. Deputy Chief Delaney commented that the Town and Police Department respects everyone's rights to assemble. He commented that he has been in contact with the organizers and that the Department's priority is everyone's safety. He stated Officers will be there to assist with traffic flow. He also stated that the Town and Department has had calls with other Departments and law enforcement agencies.

Mayor Blackman commented that she believes the Police Department is on top of what is going on. The Mayor stated that she believes this will be a peaceful march in Dover and she does not believe there will be a lot of trash or debris. Mayor Blackman also asked everyone to keep an open mind and commented that these marches have been going on all over, including in neighboring Parsippany.

Ms. Shauer asked again about her question, regarding a permit and if someone has applied. Mayor Blackman stated that we need to get that information from Deputy Chief Delaney if one will be applied for or if needed.

T.C. McCourt, 38 Davis Ave., Dover NJ – Mr. McCourt asked why there has not been two separate public comment periods. Mayor Blackman asked the Clerk to respond to the question. Acting Municipal Clerk Schmidt stated that in the old Chapter 2, the code had two public comments and when the new ordinance was adopted there was one 5-minute public comment. Acting Clerk Schmidt also stated that the Order of Business changed as well and that the agenda is based on the Code. Mr. McCourt stated he was unaware of what was in the old Code but if that is what the new code says, he accepts that answer. Mr. McCourt also asked why we now need a Deputy Clerk when the position was previously eliminated. He stated that he is not questioning Mr. Julve but that we did not have one from January to June but now we have one. He also asked how much sense it makes to have a fulltime Deputy Clerk and part-time clerk.

Municipal Attorney Tim Downs stated that in respect to the first part of the question, the Board will not be discussing personnel matters. Mr. McCourt repeated why we did not have one from January to June, but need one now. Attorney Downs responded that in January the Mayor stated that the Town was having a Pilot program and that it was going to be revaluated in June with the structure put in place or if modifications were going to be made. It was determined that after a review to make the decision that was made.

George Glander, Vice President of the Dover FMBA Local 60 – Mr. Glander congratulated Chief Parr on his appointment and stated they the firefighters and Union look forward to working with him as they improve the department in the future.

The Mayor asked if anyone else wished to speak. Alderwoman Wittner stated that she wanted to apologize to Mr. Acosta for the comment made when he was speaking.

With no other comments, the Mayor closed the public portion. The Mayor then asked if any officials on the call wanted to make a comment.

Bill Isselin wanted to congratulate Rey on his new position and stated that Rey has done a great job over the years in Construction and knows that he will do well in his new position

Mayor Blackman then entertained a motion to adjourn. Alderman Ballesteros moved to adjourn, seconded by Alderwoman Wittner. On voice vote, 9-0 (Aldermembers Correa, Tapia, Ballesteros, Rugg, Cruz, Valencia, Quinones, Wittner and Mayor Blackman in favor) the meeting was adjourned at 7:57p.m.
