RESOLUTION FOR TAX REDEMPTION

WHEREAS, at the Municipal Tax Sale held on June 9, 2016, a lien was sold on Block 1901.01 Lot 11.18 also known as 84 Boonton Street, Dover, New Jersey for delinquent 2015 taxes; and,

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER SUPPORTING PROPOSED LEGISLATION THAT WOULD MAKE CERTAIN CHANGES TO POLICE AND FIRE INTEREST ARBITRATION PROCEDURES

WHEREAS, in an effort to control and manage local property taxes, in 2010 the New Jersey State Legislature implemented legislation for an interest arbitration cap; and

WHEREAS, the legislation capped arbitration awards at 2% providing for more sustainable salary and wage increases and has also dramatically reduced the number of interest arbitration filings state-wide; and

WHEREAS, in June 2014 the State Legislature unanimously voted to extend the 2% cap on interest arbitration awards to expire December 31, 2017; and

WHEREAS, if the 2% hard cap on interest arbitration awards is not renewed, in the coming years New Jersey counties and municipalities will be faced with a very difficult situation of having to drastically reduce spending in order to comply with and pay for higher interest arbitration awards; and

WHEREAS, Assembly Bill A-3378 and Senate Bill S-1858 make permanent the 2% cap on base salary increases on interest arbitration awards and also make various changes to the State's interest arbitration procedures for settling contractual impasses between public employers and their police and fire departments; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Board of Aldermen of the Town of Dover, County of Morris, State of New Jersey as follows:

- 1. That the Mayor and Board of Aldermen of the Town of Dover supports these bills.
- 2. That a copy of this resolution will be forwarded to the sponsors of these bills, to all the local and state representatives to the Senate President, and to the Peak of the Assembly, urging them to support the aforesaid bill(s), and to the Honorable Governor of the State of New Jersey, Philip D. Murphy urging him to sign them should they be adopted.
- 3. That a copy of this resolution shall be distributed to the other municipalities in Morris County requesting they adopt similar resolutions.

ORDINANCE NO. 12-2018

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER PROVIDING FOR THE APPROVAL AND ADOPTION OF A MAP DEPICTING THE LOCATION AND BOUNDARIES OF DRUG FREE PUBLIC HOUSING FACILITIES, PUBLIC PARKS AND PUBLIC BUILDINGS ZONES, AND MAKING AN OFFICIAL FINDING AND RECORD OF THE LOCATION AND BOUNDARIES OF SUCH ZONES

WHEREAS, pursuant to N.J.S.A. 2C:35-7.1, there is an enhanced criminal penalty for a person convicted of violating N.J.S.A. 2C:35-5 by distributing, dispensing or possessing with intent to distribute a controlled dangerous substance or controlled substance analog while in, on or within 500 feet of the real property comprising a public housing facility, a public park, or a public building; and,

WHEREAS, N.J.S.A. 2C:35-7.1 defines Public Housing Facility as any dwelling, complex of dwellings, accommodation, building, structure or facility and real property of any nature appurtenant thereto and used in connection therewith, which is owned by or leased to a local housing authority in accordance with the "Local Redevelopment and Housing Law," P.L. 1992, c. 79 (C.40A:12A-1 et seq.) for the purpose of providing living accommodations to persons of low income; and

WHEREAS, N.J.S.A. 2C:35-7.1 defines Public Park as a park, recreation facility or area or playground owned or controlled by a State, county or local government unit; and

WHEREAS, N.J.S.A. 2C:35-7.1 defines Public Building as any publicly owned or leased library or museum; and

WHEREAS, the Township Engineer has prepared a map of those properties in the Town of Dover, coming within the definitions previously set forth, of such areas within 500 feet of public housing facilities, public parks and/or public building, as defined by N.J.S.A. 2C:35-7.1, et seq.; and

WHEREAS, in accordance with the Act, the map shall be filed with the Clerk of the Town of Dover and maintained as an official record of the Township.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Board of Aldermen of the Town of Dover, County of Morris, and State of New Jersey, as follows:

SECTION 1.

- 1. Statements of the preamble are incorporated into the ordinance by reference.
- 2. The map prepared by the Dover Town Engineer, Michael Hantson, PE, PP, CME entitled Town of Dover Drug Free Zone Map of Public Housing Facilities, Public Parks & Public Buildings revised May 23, 2018, is hereby approved as an official finding and record of the location and boundaries of the area or areas on or within 500 feet of public housing facilities, public parks and/or public building within the Town of Dover, as defined by N.J.S.A. 2C:35-7.1.
- 3. The original maps shall be filed with the Clerk of the Town of Dover and maintain as an official record of the Town.
- 4. The Town Clerk/Administrator are hereby directed and shall have the continuing obligation to promptly notify the Town Engineer and the Town Attorney of any changes or contemplated changes in the location and boundaries of the Town's public housing facilities, public parks and/or public buildings.

SECTION 2. Severability.

If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected thereby and shall remain in full force and effect.

SECTION 3. Repealer.

All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

SECTION 4. When effective.

This ordinance shall take effect immediately upon its final passage and publication as required by law.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER APPOINTING A HUMANE LAW ENFORCEMENT OFFICER (HLEO)

WHEREAS, in January 2018, the New Jersey Animal Cruelty Law Enforcement Statute was amended by the New Jersey Legislature and signed into law by the Governor. Specifically, as of May 1, 2018, animal welfare and animal cruelty investigations will fall under the purview of municipalities in the State of New Jersey. Consequently, each municipality will designate a Humane Law Enforcement Officer (HLEO) who shall be responsible for criminal investigations involving animal welfare and animal cruelty allegations. The purpose of this Directive is to provide direction to all law enforcement agencies operating in Morris County concerning Animal Welfare and Animal Cruelty Law Enforcement; and

WHEREAS, generally, animal welfare and animal cruelty can occur in many forms, including but not limited to physical abuse, neglect, utilizing animals for improper conduct, and torture. Physical abuse may include kicking or striking causing injury; neglect may include failure to provide shelter, food and water; improper conduct may include deliberately engaging animals in reciprocal destructive behavior such as dog fights; and torture may include pouring harmful chemicals on an animal. Specific animal welfare and animal cruelty laws are cited in N.J.S.A. Title 4, Chapter 22; and

WHEREAS, each municipality within Morris County shall designate an HLEO to investigate animal welfare and animal cruelty violations under N.J.S.A Title 4, Chapter 22; and

WHEREAS, effective August 1, 2018, law enforcement authority of previous animal control officers/animal cruelty investigators has been removed, including the powers to make arrests. An individual may serve concurrently as an Animal Control Officer (ACO) and HLEO. [N.J.S.A. 4:19-15.16 b]; and

NOW, THEREFORE, BE IT RESOLVED, that the Town of Dover has identified Police Officer Aldo Cicchetti, Jr. as the individual to be designated as the Humane Law Enforcement Officer (HLEO) who shall be responsible for criminal investigations involving animal welfare and animal cruelty allegations for the Town of Dover; and be it

BE IT FURTHER RESOLVED, that Officer Cicchetti shall hereby be appointed by the Town of Dover as the Humane Law Enforcement Officer (HLEO).

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AUTHORIZING THE APPROVAL AND EXECUTION OF A DEVELOPER'S AGREEMENT BETWEEN JING YEE LIMITED PARTNERSHIP AND THE TOWN OF DOVER

WHEREAS, Jing Yee Limited Partnership (the "Developer") is the owner and developer of real estate known as 1-21 Bassett Highway, Block 1203, Lot 2, in the Town of Dover (the "Property"), as shown on the official Tax Map of the Town; and

WHEREAS, the Planning Board of the Town of Dover granted Site Plan approval as part of Application No. P17-08 as reflected in a Resolution memorialized on April 25, 2018; and

WHEREAS, the Developer and the Town have engages in discussions regarding certain public improvements and the subsequent dedication of right of way to the Town; and

WHEREAS, the Developer is responsible as a condition of Site Plan approval to construct certain streetscape improvements along Bassett Highway, N. Sussex St. and Bassett Highway; and

WHEREAS, the Town will be undertaking streetscape improvements along Bassett Highway, N. Sussex St. and Bassett Highway which includes the frontage of the Developer's Property; and

WHEREAS, it is in the Town's best interest to undertake the construction of said improvements along the Developer's frontage as part of the Town's project, in lieu of the Developer doing the improvements on his own; and

WHEREAS, the Developer has agreed to pay the Town of Dover for the cost of said improvements along his frontage; and

WHEREAS, the Town Engineer has reviewed the Developer's Agreement and has determined it to be in the best interest of the Town of Dover to enter into the Developer's Agreement, and

WHEREAS, the Mayor and Board of Aldermen find that the approval of a Developer's Agreement in accordance with the recommendation of the Town Engineer furthers the health, safety and welfare of the Town of Dover and its residences,

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover as follows:

- 1. That the aforesaid recitals are hereby adopted and incorporated herein as if repeated in full; and

- 3. That the Mayor and Town Administration be and herby are authorized to take all reasonable and necessary actions to effectuate the same.
