ATTORNEY'S REPORT – No Report

Alderman Timpani expressed his concerns with the dispatch that is provided to the town by the county. He has received several complaints from residents that they are unhappy with the service. He spoke about his own experience with the dispatch service noting that it took 10 minutes for them (dispatch) to gather the information. He also does not agree with the locked doors at the police department and feels that an officer should be present 24 hours/7 days a week.

Mayor Dodd expressed that the concern should have been brought to the administrator's attention prior to tonight's meeting. Mayor Dodd asked Alderman Timpani to provide complete details about the incidents to the administrator so that it can be brought to the county's attention and corrected. Alderman Timpani stated he is not giving details that he is saying it happened.Mr. Close noted that the county has significant staff available to address calls and noted that there facility is very impressive.

Discussion continued on the dispatch service that is provided to the town.

RESOLUTION AUTHORIZING THE SALE AND ISSUANCE OF BOND ANTICIPATION NOTES, IN AN AGGREGATE AMOUNT NOT TO EXCEED \$4,938,299 OF THE TOWN OF DOVER, IN THE COUNTY OF MORRIS, NEW JERSEY

WHEREAS, the Town of Dover (the "Town"), County of Morris, New Jersey adopted Bond Ordinance No. 14-2009 on August 25, 2009, which authorized bonds or notes of the Town in the principal amount of \$929,879; and

WHEREAS, the Town adopted Bond Ordinance No. 16-2010 on September 14, 2010 which authorized bonds or notes of the Town in the principal amount of \$706,750; and

WHEREAS, pursuant to the above ordinances the Town issued a \$1,636,629 General Obligation General Improvement Bond Anticipation Note (the "Prior Improvement Note") dated March 13, 2012 and maturing September 28, 2012; and

WHEREAS, the Town adopted Bond Ordinance No. 5-2011 on April 12, 2011 which authorized bonds or notes of the Town in the principal amount of \$180,500 for police and fire equipment; and

WHEREAS, the Town adopted Bond Ordinance No. 18-2011 on September 13, 2011 which authorized bonds or notes of the Town in the principal amount of \$676,400 for various general improvements; and

WHEREAS, the Town adopted Bond Ordinance No. 9-2012 on July24, 2012 which authorized bonds or notes of the Town in the principal amount of \$1,368,000; and

WHEREAS, the Town of adopted Bond Ordinance No. 37-2008 on December 15, 2008, which authorized the issuance of Parking Utility Notes pursuant to which the Town issued \$352,114 bond anticipation note dated March 17, 2009 which matured March 16, 2010, which were redeemed by \$352,114 Bond Anticipation Note issued March 16, 2010 which matures March 15, 2011, which were redeemed by \$352,114 Bond Anticipation Note issued March 15, 2011 which matures March 14, 2012 (the "Prior Parking Utility Note" and together with the Prior Improvement Note, the

"Prior Note"); and

WHEREAS, the Town of adopted Bond Ordinance No. 4-2011 adopted April 12, 2011, which authorized the issuance of Parking Utility Notes pursuant to which the Town issued \$468,906 Bond Anticipation Notes dated August 9, 2011 which matures March 14, 2012 (the "Prior Parking Utility Note" and together with the Prior Improvement Note, the "Prior Note"); and

WHEREAS, the Town adopted Bond Ordinance No. 10-2012 on July 24, 2012 which authorized bonds or notes for Water Utility Purposes of the Town in the principal amount of \$270,750; and

WHEREAS, the Town has determined that it is in the best interest of the Town to authorize an issuance of bond anticipation notes to redeem the Prior Note, and to fund additional projects.

NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN OF DOVER, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-8, the following amounts of Bond Anticipation Notes (the "Notes") shall be issued at such dates and in such amounts as is determined by the Chief Financial Officer and/or acting Chief Financial Officer in accordance with this resolution:

- (I.) \$3,861,529 General Obligation General Improvement Bond Anticipation Notes:
 - a. pursuant to Bond Ordinance No. 14-2009, Notes in the principal amount of not to exceed \$929,879 shall be issued to redeem the Prior Improvement Note, and for the purposes stated therein.
 - b. pursuant to Bond Ordinance No. 16-2010, Notes in the principal amount of not to exceed \$706,750 shall be issued to redeem the Prior Improvement Note, and for the purposes stated therein.
 - c. pursuant to Bond Ordinance No. 5-2011, Notes in the principal amount of not to exceed \$180,500 shall be issued for the purposes stated therein.
 - d. pursuant to Bond Ordinance No. 18-2011, Notes in the principal amount of not to exceed \$676,400 shall be issued for the purposes stated therein.
 - e. pursuant to Bond Ordinance No.9-2012, Notes in the principal amount of not to exceed \$1,368,000 shall be issued for the purposes stated therein.
- (II) \$806,020 Parking Utility Bond Anticipation Notes:
 - a. pursuant to Bond Ordinance No. 37-2008, Notes in the principal amount of not to exceed \$337,114 shall be issued to redeem the Prior Parking Utility Note, and for the purposes stated therein.
 - b. pursuant to Bond Ordinance No. 4-2011, Notes in the principal amount of not to exceed \$468,906 shall be issued to redeem the Prior Parking Utility Note, and for the purposes stated therein
- (III) \$270,750 Water Utility Bond Anticipation Notes:
 - a. pursuant to Bond Ordinance No. 10-2012, Notes in the principal amount of not to exceed \$270,750 shall be issued for the purposes stated therein.

Section 2. Pursuant to the provisions of Section 40A:2-26 of the Local Bond Law of New Jersey, particularly paragraph (f) thereof, and in lieu of the sale of more than one (1) issue of bonds or notes as provided for in said Local Bond Law, the issues of bonds and notes of the Town authorized pursuant to the Ordinances of the Town hereinabove set forth shall be combined into three (3) concurrent issues of Notes in the aggregate principal amount of \$4,938,299.

Section 3. The following matters in connection with said Notes are hereby determined:

(a) All notes issued hereunder and any renewal thereof, shall mature at such times as may be determined by the Chief Financial Officer and/or acting Chief Financial Officer of the Town, provided that any note issued pursuant hereto shall be issued for a period not to exceed one (1) year, but all such notes, including renewals, shall mature and be paid in accordance with the Local Bond Law.

(b) All notes issued hereunder shall bear interest at such rate or rates as may be determined by the Chief Financial Officer and/or acting Chief Financial Officer of the Town.

(c) The notes shall be in a form as permitted by law and approved by Bond Counsel, and issued pursuant to the Local Bond Law, and any such notes or any renewal thereof, may be signed or sealed by officers of the Town in any manner permitted by Section 40A:2-25 of said Law notwithstanding what is otherwise set forth herein.

Section 4. The Chief Financial Officer and/or acting Chief Financial Officer of the Town is hereby authorized and directed to determine all matters in connection with said Notes or any renewal thereof, not determined by this or a subsequent resolution and his/her signature upon said Notes shall be conclusive as to such determinations.

Section 5. The Chief Financial Officer an/or Chief Financial Officer of the Town is hereby authorized to sell said Notes or any renewal thereof, from time to time at public or private sale in such amounts as he/she may determine at not less than par value and to deliver the same from time to time to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from the dated date of the Notes to the date of delivery thereof and payment therefor.

Section 6. Any instrument issued pursuant to this resolution shall be a general obligation of the Town, and the Town's faith and credit are hereby pledged to the punctual payment of the principal of and interest on said obligation and, unless otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget and a tax sufficient to provide for the payment thereof shall be levied and collected.

Section 7. The governing body of the Town hereby covenants on behalf of the Town to take any action necessary or refrain from taking any action in order to preserve the tax exempt status of the debt obligations authorized hereunder as is required under the Internal Revenue Code of 1986, as amended, including compliance with said Code with regard to the use, expenditure, investment, timely reporting and rebate of investment earnings as may be required thereunder.

Section 8. This resolution shall take effect immediately.

ANTONIO ACOSTA – 130 Madison Street – He noted that the last town meeting lasted twenty (20) minutes and then the following day there were several arrests in the town; he noted that it's a reactive thing. He expressed that the town

talks about hiring a police administrator and more police officers but if the town doesn't set the standard and tone on the way the town should be conducted, it won't matter how many officers you hire.

DEBBIE MANTINI – 305 E. McFarlan Street – She questioned the town administrator's residency and wanted to know why the ordinance was not followed. Mayor Dodd noted that an exemption was made when the administrator was hired. She feels the administrator should reside in the Town of Dover to know what happens in town. Mayor Dodd expressed that the administrator spends many hours in town hall more than any other administrator or Mayor.

ALICE FEOLA – Berry Street – She wanted to know why the Town of Dover doesn't have a swimming area for the kids. Mayor Dodd noted that there may be regulations that prohibit a swimming area.

DEBBIE MANTINI – 305 E. Mc Farlan Street – She expressed that the Mayor's comments were disrespectful towards other administrators.
