ORDINANCE NO. 10-2019

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS AND THE STATE OF NEW JERSEY AMENDING ARTICLE 28/28A, PARKING, OF THE REVISED ORDINANCE OF THE TOWN OF DOVER, 1969, AND ORDINANCES NO. 27-1980, 32-1993, 33-1996, AND 08-2007 LIMITING AND RESTRICTING PARKING ON A CERTAIN STREET WITHIN THE TOWN OF DOVER

WHEREAS, in the Town of Dover (the "Town") there is a need for amending and revising Article 28/28A, Parking, of the Revised Ordinance of the Town of Dover, 1969, and Ordinances No. 27-1980, 32-1993, 33-1996 and 08-2007, limiting and restricting parking on various streets within the Town of Dover; and

WHEREAS, the Town desires to amend and revise Article 28/28A, Parking, of the Revised Ordinance of the Town of Dover, 1969, and Ordinances No. 27-1980, 32-1993, 33-1996 and 08-2007, limiting and restricting parking on various streets within the Town of Dover; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris, State of New Jersey as follows:

Section 1

TWO (2) HOUR LIMITATION BETWEEN CERTAIN HOURS.

No person shall park a vehicle or vehicles for longer than two (2) hours between the hours of 8:00 A.M. and 6:00 P.M. except on Sunday and Legal Holidays on the following streets or portion of said streets as set forth hereinafter:

- (a) Blackwell Street: Both sides of street from South Salem Street to Dewey Street.
- (b) Bergen Street: Both sides of street from Dickerson Street to Clinton Street and then on the westerly side to Route 46.
- (c) Essex Street: Both sides of street.
- (d) Morris Street: Both sides of street from Route 46 to Dickerson Street. Easterly side of street from Dickerson Street to Mountain Avenue.
- (e) Warren Street: Both sides of street.
- (f) Bassett Highway: Both sides of street from Sussex Street to the westerly terminus.
- (g) Clinton Street: Both sides of street from Bergen Street to Morris Street. North side from Pequannock Street to Route 46 overpass.
- (h) Dewey Street: East side of street from W. Blackwell Street to Bassett Highway.
- (i) Chestnut Street: Both sides of street from Orchard Street to Prospect Street.
- (j) Thompson Avenue: West side of street from Chestnut Street to Legion Place.
- (k) Legion Place: South side of street form Orchard Street to Thompson Avenue.
- (l) Prospect Street Extension: Both sides of street from Blackwell Street to Bassett Highway.
- (m) Orchard Street: Both sides of street from Legion Place to Chestnut Street.

Section 2

FIFTEEN (15) MINUTE LIMITATION BETWEEN CERTAIN HOURS.

No person shall park a vehicle or vehicles for longer than fifteen (15) minutes between the hours of 8:00 A.M. and 6:00 P.M. except on Sunday and Legal Holidays on the following portion of said street as set forth hereinafter:

- (a) Blackwell Street: said fifteen (15) minute parking zone shall be located at Sal's Shoe Repair, 199 East Blackwell St., Block 1904, Lot 17, along the northerly curb line intersection of Mercer Street and East Blackwell Street, thence continuing in an easterly direction for 50 feet to a point.
- (b) North Sussex Street: On both the east and west side of North Sussex Street beginning at the northerly curb line intersection of Blackwell Street and North Sussex Street thence continuing in northerly direction for a distance of

475 feet along the westerly curb line.

(c) 68 W. Blackwell Street: Said parking space shall be located along the southerly curb line of W. Blackwell Street beginning at a point 140 feet west of the southwesterly curb line intersection of Prospect Street and W. Blackwell Street, thence continuing in a westerly direction for a distance of 20 feet.

Section 3

No person shall park a vehicle on certain areas of Sussex Street for longer than the times designated herein and in the areas designated herein between the hours of 8:00 A.M. and 6:00 P.M., except on Sundays and Legal Holidays:

- (a) All parking on the east and west side of South Sussex Street from Dickerson Street north to its intersection with West Blackwell Street shall be one (1) hour parking spaces.
- (b) Starting at a point 55 feet from the northeast corner of the intersection of North Sussex Street and West Blackwell Street along the east side of North Sussex Street in a northerly direction for 317 feet, all spaces shall be one-half (1/2) hour parking spaces. Thence along the east side of North Sussex Street to Clinton Street, all spaces shall be one (1) hour parking spaces.
- (c) Starting at a point 40 feet north of the northwesterly corner of North Sussex Street and West Blackwell Street, along the west side of North Sussex Street, thence northerly along the west side of North Sussex Street for 40 feet, said space being a proposed loading zone, thence to its intersection with Bassett Highway all spaces shall be one (1) hour parking spaces.
- (d) Starting at a point 65 feet from the northwesterly corner of the intersection of North Sussex Street and Bassett Highway, thence along a northerly direction along the west side of North Sussex Street 485 feet to its intersection with Clinton Street all spaces shall be one (1) hour parking spaces.
- (e) All parking on the east and west side of North Sussex Street from Clinton Street to its intersection with New Jersey State Highway Route 46 shall be two (2) hour parking spaces.

Section 4

Any person convicted of a violation or provision of this Ordinance or any supplement thereto shall be liable to a penalty expressly provided by New Jersey Statute.

Section 5

Any and all ordinances or sections thereof inconsistent with the terms of this ordinance are hereby repealed.

Section 6

This Ordinance shall take effect in accordance with law.

ORDINANCE NO. 11-2019

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS AND THE STATE OF NEW JERSEY AMENDING CHAPTER 236, SITE PLAN REVIEW, TO AMEND THE EXPEDITED WAIVER OF SITE PLAN COMMITTEE

WHEREAS, in order to properly regulate the administration of the Expedited Waiver of Site Plan procedure to continue its intent to provide an expedited process for waiver of site plans in the absence of the Town Engineer to better serve the property owners and businesses of the Town of Dover,

BE IT ORDAINED by the Mayor and Board of Alderman of the Town of Dover, County of Morris and State of New Jersey as follows:

Section 1

Chapter 236 Site plan review, subsection D(3)(a)[1] is replaced with the following:

- [1] The EWSP procedure shall be administered by a three-member EWSP Committee consisting of the following Town of Dover officials:
 - [a] The Planning Board Secretary.
 - [b] The Planning Board Attorney.
 - [c] The Town Engineer, or in his absence, a full time employee of the Engineering Department with a title of Principal Engineering Aide or higher.

Section 2

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

Section 3

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

Section 4

This ordinance shall take effect immediately upon final publication as provided by law.

ORDINANCE NO. 12-2019

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS AND THE STATE OF NEW JERSEY ADOPTING THE "TOWN OF DOVER REHABILITATION AREA: BASSETT HIGHWAY REDEVELOPMENT PLAN" AS THE REDEVELOPMENT PLAN FOR THE BASSETT HIGHWAY AREA IN NEED OF REDEVELOPMENT, WITH AMENDMENTS, PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW N.J.S.A. 40A: 12A-1 ET. SEQ.

WHEREAS, the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1, <u>et seq.</u>, as amended and supplemented (the "Act"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment; and

WHEREAS, pursuant to the Act on August 9, 2005, the Town of Dover adopted a Resolution designating the entire Town of Dover as an "Area in Need of Rehabilitation"; and

WHEREAS, pursuant to the Act on October 24, 2017, the Town of Dover adopted an amended "Town of Dover Rehabilitation Area: Bassett Highway Redevelopment Plan" for a defined area around Bassett Highway as the Redevelopment Plan for that portion of the Area in Need of Rehabilitation; and

WHEREAS, pursuant to the Act on June 11, 2019, the Town of Dover adopted Resolution 146-2019 designating certain parcels that fall within the area covered by the "Town of Dover Rehabilitation Area: Bassett Highway Redevelopment Plan" as an Area in Need of Redevelopment; and

WHEREAS, said Area in Need of Redevelopment necessitates a Redevelopment Plan prepared in accordance with N.J.S.A 40A:12A-7a; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

Section 1

Purpose & Intent; Background.

The purpose and intent of this Ordinance is to adopt by reference the amended Redevelopment Plan as prepared by Michael Hantson, PE, PP, CME – Town Planner dated September 27, 2017 entitled "Town of Dover Rehabilitation Area: Bassett Highway Redevelopment Plan" as the Redevelopment Plan for those parcels designated as an Area in Need of Redevelopment, more particularly,

Block 1201, Lots 6, 6.01 & 6.04; Block 1204, Lots 1 & 2; Block 1205, Lots 1, 2, 8, 9, 10, 11, 12 & 13; and Block 1206, Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 & 16

as amended herein. This Ordinance is adopted under the authority of the Act. This Ordinance and the Redevelopment Plan are in conformance with the requirements of N.J.S.A. 40A:12A-

Section 2

Adoption of Redevelopment Plan and Amendments.

The Mayor and Board of Aldermen hereby adopt the "Town of Dover Rehabilitation Area: Bassett Highway Redevelopment Plan" Last Revision dated September 27, 2017, which is adopted by reference, and incorporates the same herein as if set forth at length, as the Redevelopment Plan for those parcels designated as an Area in Need of Redevelopment by Resolution 146-2019, more particularly,

Block 1201, Lots 6, 6.01 & 6.04; Block 1204, Lots 1 & 2; Block 1205, Lots 1, 2, 8, 9, 10, 11, 12 & 13; and Block 1206, Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 & 16

as amended herein. In adopting said Redevelopment Plan, the governing body hereby declares and determines that said Redevelopment Plan meets the criteria, guidelines and conditions set forth at N.J.S.A. 40A: 12A-7; provides realistic opportunities for redevelopment in said Plan are; and is otherwise in conformance with the provisions of the Local Redevelopment and Housing Law, N.J.S.A.: 40A: 12A-1 et. seq. The Mayor and Board of Aldermen further find and determine that said Redevelopment Plan effectuates the objectives of the Town of Dover's Master Plan.

The following amendments are made to said redevelopment plan for only those parcels noted above that are in the Area in Need of Redevelopment.

Section 3.03.04 Bulk Requirements, Section a. Number of stories and height limitations, paragraphs 2 and 3. are replaced with the following:

- 2. Any portion of a building or structure that is situated within 50 feet of the Blackwell Street right-ofway shall be no taller than 5 stories or 60 feet in height above the grade of the street line.
- 3. Any portion of building or structure that is not situated in the areas as governed above shall be no taller than nine (9) stories or 100 feet in height above the grade of the street line.

Section 3.03.04 Bulk Requirements, Section d. Interior Yards/Setbacks, is replaced with the following: All buildings in the BHRPA may be attached; however, in the event that the buildings are not attached, the separation between buildings shall be a minimum of 10 feet in order to provide access to the rear of the property by fire apparatus. Such opening or alley shall be lighted and kept free of debris and may serve as pedestrian access to parking areas and streets.

Section 3

If any section or provision of this Ordinance shall be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this Ordinance as a whole or any other part thereof.
