## SPECIAL EVENTS

The Senior Picnic was held on Thursday, September 3, 2015 with 292 seniors in attendance. H.O. Baker was a major sponsor of the event with a $\$ 2,500$ donation. This donation supplied (5) 24 ", (3) 32 ", (2) 40 " flat screen televisions as door prizes. There was also a tricky tray with 36 baskets and 32 gift cards.

The Arthur Avenue Tasting Tour will be held on Thursday, October $17^{\text {th }}$.
Alderwoman Blackman suggested to shorten the time of the trips as a 9:00am to 5:00pm trip is too long for seniors. Vice-Chairman Garland asked if the trips are open to non-residents. Secretary Newkirk stated the trips are open to Dover residents and unsold seats are sold to non-residents closer to the trip date.

Chairman Rodriguez inquired if the Recreation Commission is sponsoring the Senior Casino Bus trip. Chairman Rodriguez stated that if any trip is paid out of Recreation funds, Recreation should be mentioned as a sponsor or co-sponsor on any further trips on notices and flyers.

Discussion was held among the Board in regards to the sports programs allocated funds. Commissioner Whelan asked for a copy of the Recreation budget. Chairman Rodriguez asked for copies of the budget to be sent to all commissioners. Commission Whelan agreed with Chairman Rodriguez that Recreation should be mentioned in all Recreation sponsored events.

Chairman Rodriguez stated the Recreation Commission would be purchasing a popcorn machine to have onhand for events and to also rent out to town organizations for fund raising events.

Chairman Rodriguez stated that the Commissioners all are volunteers and work a full-time job and the Commissioners have to take their personal time off to attend the events during the day. Chairman Rodriguez offered that for any assistance, to email the Commissioners the days that help is needed for the preparation of an event.

Vice-Chairman Garland asked if the Trunk or Treat event is being held this year. Secretary Newkirk stated that the event was still going to be held. Chairman Rodriguez and the Commission discussed dates to hold the Halloween Costume Contest and not have a Trunk or Treat. Chairman Rodriguez stated the event could be held at the small soccer field. Vice-Chairman Garland stated judging will start for 4 year-olds and infants to 3 yearolds can parade but no judging.
