MAYOR'S REPORT:

- Mayor Dodd noted that the town is in the process of designing variable message boards for JFK Park and the front of Town Hall. We are in the final stages and the board will be updated on the progress.
- Mayor Dodd noted several projects being worked on:
 - o Landscaping plan at Department of Public Works building (new fence & wall)
 - o Landscaping plan for the pavilion at Hurd Park,
 - o A Request for Proposal (RFP) is currently out for a new soccer field at Crescent Field Park
- The Youth Empowerment Impact Program held their basketball tournaments at the Crescent Field basketball courts and, publicly, thanked the Public Works Department and Mr. Travisano for their assistance in the maintenance of the courts. He also thanked Alderwoman Yzarnotegui, Hector Quinones and his wife Lisa for their time and effort with the tournament.
- He reminded the public that the last Movie Night of the year will be held on Friday.

ATTORNEY REPORT: Attorney Downs thanked Ms. Verga for assistance during her period as interim administrator. He also thanked Mr. Travisano for his assistance with some open projects.

RESOLUTION IDENTIFYING CDBG FAIR HOUSING OFFICER

WHEREAS, the Town of Dover has applied for two Small Cities Community Development Block Grants from the New Jersey Department of Community Affairs (hereinafter DCA) for public facilities reconstruction and housing rehabilitation projects within the Town of Dover; and

WHEREAS, the public facilities project will be constructed in the North Bergen Street, Richards Avenue, Hudson Street, Passaic Street and Union Street area; and

WHEREAS, the housing rehabilitation projects will be constructed throughout the Town and directly benefit qualified low to moderate income residents; and

WHEREAS, the Town of Dover must make efforts to affirmatively further fair housing; and

WHEREAS, the Town of Dover has made assurances in the grant agreements that:

- 1. It will comply with the Housing and Community Development Act of 1974, as amended, and regulations issued thereto; and
- 2. It will comply with the Civil Rights Act of 1964, and the regulations issued thereto it; and
- 3. It will comply with the Fair Housing Act of 1968 and will affirmatively further fair housing; and
- 4. It will comply with the Age Discrimination Act of 1975 and with the Rehabilitation Act of 1973.

NOW, THEREFORE, BE IT RESOLVED that Donald Travisano, Administrator shall be designated as the Fair Housing Officer for the Town of Dover.

BE IT FURTHER RESOLVED that the Fair Housing Officer shall contact the US HUD Regional Office of Housing and Equal Opportunity and the NJ Division of Civil Rights, inform those agencies of his appointment as Fair Housing Officer and request Fair Housing Information; and

BE IT FURTHER RESOLVED that the Fair Housing Officer shall provide fair Housing advisory services and assistance and referral advice to persons requesting such assistance from the Town of Dover; and

BE IT FURTHER RESOLVED that the Town of Dover will publish in the local newspaper of record and post at the Town Hall a public notice announcing the appointment of the Fair Housing Officer and the availability of local fair housing advisory services.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN TO JOIN WITH THE FRANCES FOUNDATION IN RECOGNITION OF THE NEED FOR INCREASED PEDIATRIC CANCER AWARENESS BY DECLARING THE MONTH OF SEPTEMBER 2014 AS "SEPTEMBER IS GO GOLD MONTH"

WHEREAS, each September across our great nation we commemorate National Childhood Cancer Awareness Month to bring attention to the caregivers, charities and groups, who spotlight the importance of the need for research and awareness to aid in finding cures for pediatric cancer; and

WHEREAS, childhood cancer spares no socioeconomic, ethnic, racial or geographic class and every year almost 13,000 children under the age of 21 are diagnosed with cancer; and

WHEREAS, although the causes of pediatric cancer are still largely unknown, statistics indicate that a quarter of those diagnosed will not survive the disease; and

WHEREAS, in the last 25 years only two drugs have been specifically developed for children's cancer, and during the last decade the funding for pediatric cancer has been going down with less than 5% of the federal government's total funding for cancer research dedicated to pediatric cancer, and only 3% of funds raised on behalf of the National Cancer Institute scheduled to go directly to pediatric cancer research; and

WHEREAS, in September we pay tribute to the families, friends, professionals, and communities who lend their strength to children fighting pediatric cancer, we remember the young lives taken and dedicate our energies to combating pediatric cancer; and

WHEREAS, in 1997 gold was chosen as the ribbon color for universal awareness of pediatric cancer, with the objective of putting a spotlight on the types of cancer that affect children, survivorship issues, and the importance of raising funds for research and family support.
