He said she could have 3 days at Crescent (Mondays, Wednesdays and Fridays from 5pm to 9pm and Saturday 9am-5pm) and 4 days at Water Works Park (Monday - Thursdays 5pm to dusk and Saturdays 9am to 3pm). He said baseball will be putting small kids on Crescent Field to practice.

- a. Senior Citizen Committee no report. Commissioner Bocchino spoke with Nancy Hagerich and she was happy that she got new tables which are light weight and easy for her to manage, so she does not need help moving them anymore.
- b. Sport Committees Chairman Rodriguez reported Basketball is in progress and going well.
- c. Monthly Maintenance Report/DPW DPW Superintendent Luis Acevedo reported that he has been busy with snow removal and water main breaks due to the weather. He did have good news to report. The PBA Local 107 has offered to donate a new scoreboard for Crescent Field. They will be sending a representative to make the presentation at the next Recreation Commission Meeting. It will be a wireless scoreboard and will look similar to the one at King Field. JCP&L will have to install a meter to supply power. Should be done in time for the Fall Season.
  Luis Acevedo also reported on the bids for Hurd Park exceeded estimates and will have to go out to be rebid. The median was \$90,000 and lowest bids were 60 to 70 thousand dollars.
  Luis Acevedo also will report back regarding the JFK Playground and whether or not that area will be able to be used for the Easter Egg Hunt. It may be getting new playground equipment.
  Commissioner Bocchino asked about the placement of Mark Jaeger's memorial plaque, why that spot chosen. Mr. Acevedo said it has the most visibility at that corner. Alice Gilbert asked if there was room to plant flowers. Luis Acevedo said yes, you can plant flowers there.
