The application is to remove existing aluminum & glass storefront on Blackwell Street and be replaced with insulated glass & trim to match façade that exists along Sussex Street. Change lettering on canopy, install projecting signs, new insulated windows and add wall mounted lighting fixtures. Received Planning Board approval on March 26, 2012 and Resolution was passed on April 25, 2012.

Attorney George Johnson represented the applicant

Architect Michael Kuybida who prepared the plans, explained to the board that he just wanted to clarify the lighting for the façade. The applicant will add fascia wash 440 series wall mounted

light fixtures to the façade of the building along West Blackwell and North Sussex Street. They will just cast a soft glow to the building.
