Discussion took place regarding the field use and improvements. Attorney Downs spoke on the improvement and bonding.

SPECIAL EVENTS: Chairman Rodriguez reviewed the following.

<u>9/11 Memorial & South Street Seaport Bus Trip on June 22, 2012</u> was a great success. Everyone enjoyed themselves and several people expressed interest in an adult trip to the Bronx Zoo in October when weather is cooler.

<u>Fireworks on July 3, 2012</u> went well \$2696.00 taken in at gate. Thanks to Vice Chairwoman Garland, Commissioners Jaeger and Bocchino and Alderwoman Blackman for all their help to make the event a success. Alderwoman Blackman discussed more volunteers are needed for next year. Vice Chairwoman Garland suggested revisiting the fees. Entertainment was also discussed.

<u>Summer Recreation Program</u> – June 25, 2012 through August 10, 2012. 67 children registered and 5 staff members were hired. Program about bullying for children is being scheduled through the Prosecutor's office.

<u>Senior Picnic</u> is scheduled for Thursday, September 6, 2012 with rain date of Friday, September 7, 2012. Does the Commission want to see if we can secure the American Legion for a rain location this year: Nick's will **not** be available to do the picnic this year. Alice has received price quotes from several caterers with NJ Bar & Grill coming in at \$10.99 per person, Picnics Unlimited is \$16.95 per person, House Party in Parsippany has package for \$13.95 per person, and Signature BBQs has a package at \$16.50 per person.

DJ Rockin Rod will play music at no cost. Senior Committee (M Garland & P. Gori) needs to decide on a theme as soon as possible, so that supplies can be ordered. Letters requesting donations will be sent out early next week. Commissioners tabled decision on food vendors to find a local vendor. Alderwoman Blackman spoke with the legion to secure the rain location. Vice Chairwoman Garland and Commissioner Gori to meet to discuss a theme for the picnic.

Radio City Christmas Show Bus trip will take place on Monday, December 3, 2012. Tickets are for the first two rows of the third mezzanine. Cost is \$55.00 per ticket.

Commissioner Bocchino suggested a recreation tax would solve some funding problems. She also discussed long term planning. She suggested contacting other towns to see how they deal with people using the fields without a permit.
