#### **UNFINISHED BUSINESS:**

Trevor Weigle, Health Officer, provided the board with the following COVID-19 update:

As of June 7<sup>th</sup> in the Town of Dover:

- 699 COVID cases and 64 COVID related deaths.
- 377 of the 699 cases were released from isolation.
- Gender breakdown approximately 50/50 male/female.
- Majority of COVID cases are between 41 60 years old.
- There are 13 public health workers handling Dover's case investigations.

Sandra Scarneo asked how many of the 64 deaths from COVID are from nursing homes. Trevor Weigle, Health Officer, responded approximately 40%.

Derrick Webb, Assistant Health Officer, provided the board with information regarding the reopening of business establishments.

On June 15<sup>th</sup>, the following businesses will be permitted to reopen:

- Child Care Centers.
- Youth Camps.
- Outside dining for restaurants.
- Non-essential businesses.

The health department is currently working with Zoning, Code Enforcement, and Administration to ensure proper reopening compliance.

On June 22<sup>nd</sup>, the following businesses will be permitted to reopen:

- Hair Salons (not nail salons or tattoo parlors) [must have a state certificate/license].
- Barber Shops [must have a state license].
- Public Swimming Pools.

### **NEW BUSINESS:**

#### THE MEETING WAS OPENED TO MEMBERS OF THE BOARD

Sandra Scarneo asked a question regarding the Animal Control Report. Ms. Scarneo noted several raccoon complaints and concerns with rabies. Don Costanzo responded stating the increased wildlife incidents were a normal part of the increase in springtime animal activity.
