Scott Mack
President, Dover Youth Football \& Cheerleading
Scott Mack discussed his concern about the demands put on volunteers and excess paperwork demanded by the Commission. He had two volunteers with him, Rashida and Tyrone Alston, and they have worked many hours trying to meet the requirements set by the Board. He expressed concern over losing volunteers.
Chairman Rodriguez explained all sports are being asked to meet the same conditions.
He suggested advertising in paper and on website for more volunteers to help out with the football program.
Scott Mack also discussed delayed payment of Riddell bill for reconditioning of helmets last season. The bill was submitted in October and was only just getting paid this week. Scott said the same thing happened last year with bill from Schutt and he had to switch to Riddell because of the delay in payment. Chairman Rodriguez said he would speak to Town Administrator to see that it does not happen again this year.
Discussion took place about having Luis Acevedo ship the equipment to Riddell; however Scott Mack explained that he already shipped the equipment to the company in February.

Mr. Timpani discussed the overtime paid to DPW workers for baseball and the neglect of the soccer fields. He said the soccer program has been in progress for six weeks and the fields are in poor condition. He expressed concern about the safety of children playing soccer on fields ridden with holes and rocks. Luis Acevedo, DPW discussed how the weather affected efforts to get the fields done and also stated there are plans in the future for another turf field.
Mr. Timpani said before plans go forward for another turf field, it needs to be taken into consideration that if another turf field is installed it will mean the town can no longer have events there, such as the Colombian Festival. This is the only location that can accommodate large festival type events.

Chris discussed feasibility of making an application for use of the Soccer fields from January 1 thru December $1^{\text {st }}$ to avoid conflicts in the future. She also discussed that permits are secured early and had the date of April $2^{\text {nd }}$ and fields should be ready for play. She invited Vice Chairwoman Garland (soccer liaison) to attend the soccer meetings which are held at 8:00pm at the American Legion on Wednesdays.

Ben discussed his concern over the possible discontinuation of the Summer Recreation Program and the possibility that price was a determining factor. He also was told the Neighborhood House in Morristown is sponsoring an inexpensive program in Denville, and some Dover parents were taking their children there.
