Officer Pritchard introduced himself as the Dover PBA President. He announced the Police Local would like to donate a much needed scoreboard to the Recreation Commission for Crescent Field, multi-purpose turf field. He passed around pictures of two options. Officer Pritchard will install it and obtain permits. Fees will be waived. Luis Acevedo will contact him with details and will get recommendations from Mr. Hantson, Town Engineer for location.

Luis Aguirre Dover Traveling Soccer

Mr. Aguirre asked about permits for Dover Traveling soccer to play on Crescent field. He was told they are not allowed to use the field. Chairman Rodriguez said he is meeting with Mr. Hoyt on Tuesday of next week to discuss utilizing the fields. Recreation Soccer already has been scheduled. He will have answers after meeting with Mr. Hoyt. There is a possibility the Town will be renting fields at Hedden Park. Discussion took place

regarding people who are using the field without a permit. Chairman Rodriguez said the police should be called. Mr. Aguirre said they call the police but they are too busy to come. Chairman Rodriguez said policing the fields has always been an issue.

Mr. Andrade said he was worried there will be no Travel Soccer and asked why the Recreation Commission does not give support to Travel Soccer to use the high school fields. Chairman Rodriguez said he is meeting with Travel Soccer Coach Jeff Hoyt next week and there will be travel soccer. Chairman Rodriguez said we support all programs, but priority is given to the Recreation programs. We are being charged by the Board of Education for use of property for all sports, including basketball, spring track and soccer. Space is limited. They may request three days and only receive one.
