b. Sport Committees

Football/Cheerleading - Commissioner Gori said Scott Mack is in good spirits and addressed some concerns about some of his players.
Soccer - Commissioner Jaeger reported the end of Soccer season is next week and a picnic will be at Water Works Park next Saturday.
c. Monthly Maintenance Report/DPW

DPW Superintendent Acevedo reported that Field Turf will be making repairs to the Turf Field at Crescent Field within the next two weeks. He also reported on cleanup of parks. Commissioners discussed planning a date to inspect Water Works Park before June $27^{\text {th }}$ (beginning of Summer Program) to see what needs to be done. Three Commissioners committed to meeting at the park at $3: 30 \mathrm{pm}$ on Thursday, June 16th. Vice Chairwoman Garland, Commissioner Fritch and Commissioner Bocchino will meet DPW Superintendent Acevedo at the park. Chairman Rodriguez will contact Mayor Dodd to have Community Service workers assigned to clean up of the park upon completion of the inspection.

Roll call vote was taken. Commissioner Bocchino abstained. All other Commissioners voted yes. ALL IN FAVOR MOTION CARRIED.

Application \#3 : Was tabled to end for discussion regarding insurance and fee for use of facility. Commissioners discussed a reasonable fee for 5 day use of the field, since training is being done by outside company, fee should be collected and insurance provided by the company.
MOTION: To approve application \#3 with stipulation that an insurance certificate must be provided naming the Town of Dover and Dover Recreation Commission as additionally insured and $\$ 750.00$ fee collected for use of facility was made by Vice Chairwoman Garland.

Commissioner Jaeger expressed his opinion that Crescent Field is being used illegally by adults who have no permits. He said no one is policing the fields and enforcing the " use by permit only" policy.

Commissioner Bocchino suggested he draft a letter to Chairman Rodriguez about people jumping the fence and using it illegally, and Chairman Rodriguez could forward it to the Town Administrator or Mayor and Board to have police enforce the policy.
