CAUCUS MEETING MINUTES October 13, 2015 7:00 PM

The Caucus Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

Mayor Dodd called the meeting to order at 7:00 pm

All joined in the Pledge of Allegiance to the Flag.

In accordance with the provisions set forth in the Open Public Meeting Law, notification of this meeting has been sent to all officially designated Town newspapers and notice is posted in the Town Hall.

DISCUSSION: BEST PRACTICES INVENTORY

Mayor Dodd noted that the town received a 92% on the Best Practice Inventory. Mayor Dodd explained that the questions are different every year which range from human resources, insurance, driver's accountability, etc. He noted that he is extremely happy with the 92% and that state aid will continue.

Alderman Visioli thanked the administration for their hard work.

ORDINANCE FOR INTRODUCTION/FIRST READING

ORDINANCE NO. 23-2015 AN ORDINANCE REPEALING ORDINANCE NO. 26-1995 ESTABLISHING A LOADING ZONE IN THE TOWN OF DOVER

BE IT ORDAINED, by the Mayor and Board of Aldermen of the Town of Dover, County of Morris, as follows:

SECTION 1.

Ordinance No. 26-1995 created a Loading Zone on the West Side of North Sussex Street 36 Feet South of Bassett Highway, starting at a point of the westerly curb line of North Sussex Street said point beginning 36 feet south of the curb line intersection with Bassett Highway. Thence continuing in a southerly direction for a distance of 21 feet to a point.

SECTION 2.

This ordinance is repealed and replaced to create additional off-street parking spaces as described below:

At this location the last space next to the existing loading zone shall be expanded from 20' wide to 22' wide and a new 22' space shall be created were the existing Loading Zone currently exists.

SECTION 3. This Ordinance shall take effect in accordance with law.

ORDINANCE NO. 24-2015 AN ORDINANCE ESTABLISHING A LOADING ZONE IN THE TOWN OF DOVER ON BASSETT HIGHWAY

BE IT ORDAINED, by the Mayor and Board of Aldermen of the Town of Dover, County of Morris, as follows:

SECTION 1. Definitions - Loading Zone

A loading zone, for the purpose of this ordinance shall be an area along the side line of a public street reserved solely for use during specific hours for vehicles for the purpose of loading and unloading goods, records and passengers, and in which said area any vehicle shall not stand, stop or park for more than fifteen (15) minutes.

SECTION 2. Bassett Highway

Said Loading Zone shall be created along the southerly curb line of Bassett Highway beginning at a point 35'east of the southeasterly curb line intersection of Warren Street and Bassett Highway, thence continuing in an easterly direction for a distance of 32'. End Description

SECTION 3. Utilization of a Loading Zone

Between the hours of 10:00 A.M. and 6:00 P.M. Monday through Friday, vehicles will be permitted to stop, stand or park within the Loading Zone described in Section 2 above and no vehicle shall stop, stand or park for more than fifteen (15) minutes.

SECTION 4. Violation and Penalties

Every person convicted of a violation of a provision of this Ordinance or any supplement thereto shall be liable to a penalty of not more than fifty (\$50.00) dollars or imprisonment for a term not exceeding fifteen (15) days or both.

SECTION 5. This Ordinance shall take effect in accordance with law.

RESOLUTION TO AUTHORIZE AN AMENDMENT TO THE MUNICIPAL SHARED SERVICES DEFENSE AGREEMENT FOR AFFORDABLE HOUSING CONSTITUTIONAL COMPLIANCE

WHEREAS, the Mayor and Board of Aldermen of the Town of Dover entered into the Municipal Shared Services Defense Agreement ("MSSDA") for the purpose as set forth therein, which included retaining a common expert in the Declaratory Judgment action ("Litigation") that was filed in accordance with <u>In the Matter of the Adoption of N.J.A.C.</u> 5:96 and 5:97 by the New Jersey Council on Affordable Housing, 221 N.J. 1 (2015) ("Decision"); and

WHEREAS, the MSSDA identified Dr. Robert Burchell, a distinguished professor at Rutgers University, as the expert to be retained; and

WHEREAS, Dr. Burchell became ill and has been unable to complete the obligations under the Research Agreement as set forth in the MSSDA; and

WHEREAS, as a result, Rutgers University has exercised its right to terminate the Research Agreement as permitted under its terms; and

WHEREAS, the MSSDA requires modification to allow the members to retain one or more alternative experts, consultants and/or other professionals for the Litigation; and

WHEREAS, an Amendment to the MSSDA ("Amendment") has been prepared to effectuate the modification; an

WHEREAS, the Mayor and Board of Aldermen of the Town of Dover recognize that the Litigation requires immediate action and may require further expedited actions by its counsel determined to be necessary and appropriate; and

WHEREAS, the Mayor and Board of Aldermen of the Town of Dover have determined that it is in the best interests of the citizens of the Town of Dover to approve the Amendment, and/or to affirm and ratify the Amendment, and to authorize their designated counsel to take actions on behalf of the municipality with regard to the multiplicity of issues raised and associated with the continued implementation of the MSSDA;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Aldermen of the Town of Dover, as follows:

- 1. The terms and conditions of the Amendment to MSSDA attached hereto are hereby approved, and/or ratified and confirmed.
- 2. The Mayor and Town Clerk or Deputy Clerk, be and are hereby authorized to execute the aforesaid Amendment.
- 3. The Mayor and Board of Aldermen of the Town of Dover hereby authorize Jeffrey R. Surenian, Esq., to execute an agreement on behalf of the Town of Dover with Econsult Solutions, Inc.
 - The Mayor and Board of Aldermen of the Town of Dover hereby authorize Jeffrey R. Surenian, Esq., to execute on behalf of the Town of Dover with the approval of the Town of Dover's designated counsel such other agreement(s) as are advisable to effectuate the purposes of the MSSDA as amended.
- 4. The Mayor and Board of Aldermen of the Town of Dover further authorize its designated counsel to approve such other changes to the MSSDA as may be necessary to effectuate its purposes, and to take action on behalf of the municipality with regard to the multiplicity of issues raised and associated with the implementation of the MSSDA provided that the action will not require the municipality to appropriate and commit any additional funding for the MSSDA.
 - In the event such changes and actions require the municipality to appropriate and commit any additional funding for the MSSDA, the Town of Dover shall only be responsible for such funding if it authorizes same.
- 5. If additional monies are needed to effectuate the intent and purpose of the MSSDA, no such services shall be authorized by designated counsel without further action from the Town of Dover.
- 6. This Resolution shall take effect immediately.

WHEREAS, a serious threat to the public health, safety and welfare presently exists in the Town of Dover. This threat has existed for years and has now reached epidemic proportions; and

WHEREAS, in order to circumvent local regulatory laws governing taxicabs, many transportation companies choose to license their vehicles as limousines, the regulation of which, falls outside the scope of authority of municipalities. Furthermore, many transportation companies fraudulently register their vehicles in order to pay a lower insurance premium. This act of fraud results in inadequate or under insured coverage and a clear threat to the passengers, pedestrians and other vehicles on the road; and

WHEREAS, many transportation companies engage in unlawful employment practices, including, but not limited to, illegal and undocumented leases and subleases; nonpayment of taxes; and fraudulent ownership and insurance documentation; and

WHEREAS, the Town of Dover, which 2.2 square miles, presently has 168 licensed limousines, approximately twenty limousine applications pending and numerous unlicensed and unregulated passenger cars for hire; and

WHEREAS, this glut of limousines, which operates as rogue taxicabs, are impeding the flow of vehicular and pedestrian traffic in their search to illegally hail fares; and

WHEREAS, the New Jersey Legislature has done little to allow municipalities to enforce applicable laws against limousines; and

WHEREAS, these vehicles have seriously jeopardized the public health, safety and welfare of the residents of the Town of Dover, by excessive speeding, erratic driving, sudden stopping, failure to yield to pedestrians, and other infractions; now, therefore, be it

RESOLVED by the Mayor and Board of Aldermen of the Town of Dover that because of the numbers of limousines operating in the Town of Dover and because of the State of New Jersey's failure to adequately regulate them, a public health, safety and welfare emergency is hereby declared; and be it

FURTHER RESOLVED that due to said emergency, the Town of Dover will no longer issue limousine permits to businesses seeking licensure; and be it

FURTHER RESOLVED that the Mayor and Board of Aldermen of the Town of Dover requests that this Resolution be sent to the Office of the Governor, and the members of the New Jersey Legislature, with the hope that action will be taken.
