Mayor Dodd recommended Mr. Hector Quinones as Municipal Alliance Coordinator. He noted that Mr. Quinones is very involved with the youth in the community and runs the "Get to It" Program which is very active in the church.

Mayor Dodd has been in discussion with the Administrator regarding the amounts of limousines in the Town of Dover. He noted that by the next meeting, he will appoint members to a limousine and taxi committee. Mayor Dodd explained the difference between limousines and taxi cabs and feels that limousines are acting in the capacity of a taxi cabs. He noted that taxi/limousine owners will be notified seeking their cooperation and then the ordinance will be updated. Mayor Dodd noted that this has become a safety issue for the public.

REGULAR MEETING MINUTES September 23, 2014

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:06 pm

Municipal Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened the meeting to the public on any agenda items. Seeing no hands and hearing no voices, Mayor Dodd closed the meeting to the public.

MAYOR'S REPORT: Mayor Dodd commented on the following items:

*The town has changed their notification system to the "Everbridge" program which is a new and improved system that's customizable to the town's needs. The program should be up and running within the next two weeks and the link will be provided on the town's website and Facebook page. Mayor Dodd encouraged all residents to sign up to receive alerts about emergencies and other important community news.

*Starting next week, the parking lot users will have access to the Whoosh application (app) which will allow them to pay for their parking time through their phones, tablets or their computers. Mayor Dodd noted that the application is at no cost to the town.

*Mayor Dodd promoted the following events: Halloween Trunk or Treat on October 25th, Senior Bus Trip to the Mount Airy Casino Trip on October 8th, Dover Fire Department Inspection on October 11th and the flu shot clinic on October 15th.

*Mayor Dodd expressed that redevelopment is a priority in the town and the Sussex Street redevelopment proposal is moving forward.

*Mayor Dodd noted that the FMBA (fire department) has put together a Breast Cancer Awareness Campaign and encouraged all board members to purchase a pink shirt. He noted that all employees will take a picture in front of the Fire Department to show their support.

*Mayor Dodd encouraged all board members to attend a fundraiser at the Black River Barn for the Loeys Dietz Syndrome on October 9th.
