Mr. Timpani voiced his concerns about the Summer Program and the decline in enrollment which he feels was directly related to the increase in fees and hopes the Board will take this into consideration when deliberating over the fee schedule for 2011.

Mr. Timapani also discussed the possible elimination of Spring Soccer and said he believes the parents in the Town of Dover should be permitted to vote on the decision.

She said the Soccer program shapes the character of the children and makes them become better adults. She said it would be a disservice to the community to take away soccer. If any sport should be cancelled it should be one that is not as high in demand.

Mr. Martinez also expressed his concern about the soccer program. He said he has his daughter's best interest in heart and mind and she wants to play soccer. He said if there is a demand for the sport, it should be available to them.

The proposal included fee of \$325.00 to join Lakeland Junior Track & Field League, fee must be paid 2 years in advance. \$650.00 must be paid by February 2011. No home meets will take place in Dover during the first two years as a new team. The Dover track will be used for practice only. Registration fee is \$25.00 per child. Registration will be open to children from age of 9 to 15, excluding high school students. T-shirts will be provided for meets.
