## COMMITTEE REPORTS

Football - Commissioner Peter Gori reported on Scott Mack's undefeated team and a great season so far. He said parents were very supportive to the program this year. Discussion took place regarding the vendors getting paid in a timely fashion. Commissioner Gori referred to the reconditioning of helmets, and said the vendor was having difficulty with getting paid on time. Chairman Rodriguez explained next year the reconditioning of the helmets would be done through the Town, using the Morris County Coop. He stated that the town would pack up and ship the helmets to a company for the football program and showed Commissioner Gori a booklet from the Morris County Cooperative Pricing Council.

## Items for Discussion

1) Sports Sponsorship - Discussion took place regarding revision of the Resolution for determining Recreation sponsored organizations, sport groups and events. Chairman Rodriguez said a resolution will be created at the beginning of every year listing the groups and events which are Recreation Commission sponsored. The Commissioners determined the following events are non-sports related Recreation sponsored events: Halloween Costume Contest, Halloween Fun Run, Holiday Tree Lighting Ceremony, Santa Letter Writing Contest, Easter Egg Hunt, Summer Recreation Program, July 3rd Fireworks

Celebration, Dover Recreation/Renaissance Concert Series, and Senior Picnic. Commissioners also discussed and determined the following sports were Recreation sponsored organizations: Dover Strikers Recreation Fall Soccer and Spring Soccer; Dover Recreation Youth Football and Cheerleading, Dover Recreation Wrestling, Dover Recreation Basketball, Dover Little League Baseball and Softball - tabled for further discussion at next meeting.
Tabled for next meeting: Discussion regarding sponsorship of Dover Strikers Traveling Soccer. Commissioner Mark Jaeger asked the Commissioners to consider that the only reason they requested sponsorship from Recreation is for obtaining Board of Education permits. He explained that both programs have coexisted before and made use of the field space.
2) Discussion of whether or not to sponsor Spring Soccer took place. Commissioner Fritch said he felt that Recreation is about equal opportunity for all sports; however he also suggested that if Spring Soccer were to be eliminated, another sport such as Cross Country or Tennis should be offered. Commissioner Gori agreed stating the high enrollment in soccer does take away from participation in other sports.
Commissioner Carmona suggested other sports like volleyball or golf also be considered. Commissioner Jaeger said that 27 out of 33 towns have Spring Soccer.
Chairman Rodriguez suggested this discussion also be tabled and continued at the next meeting.
