ORDINANCE FOR INTRODUCTION/FIRST READING

ORDINANCE NO. 19-2016

OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY AMENDING CHAPTER 254-2 OF THE CODE OF THE TOWN OF DOVER ENTITLED "NOISE; ENUMERATION OF PROHIBITED ACTS AND NOISES."

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey, that Chapter 254-2 of the Code of the town of Dover is hereby amended to read as follows:

SECTION 1. Chapter 254 Noise 254-2 Enumeration of prohibited acts and noises.

F. Construction, repair or alteration of buildings. The erection (including excavation), demolition, alteration or repair of any building other than between the hours of 7:00 a.m. and 6:00 p.m. on weekdays and 8:00 am and 6:00 pm on weekends (Saturday and Sunday).

In cases of emergency and/or urgent necessity or in the interest of the public health, safety and welfare, as determined by the Town Administrator or Construction Official, as applicable, work may be conducted outside of the above-stated hours provided that all other applicable laws are adhered to.

SECTION 2.

All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.

SECTION 3.

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4.

The Ordinance shall take effect in accordance with law.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER DESIGNATING AN AREA OF THE TOWN OF DOVER, AS MORE PARTICULARLY DESCRIBED HEREIN, AS "AN AREA IN NEED OF REDEVELOPMENT", PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW

WHEREAS, on May 10, 2016, the Mayor and Board of Alderman adopted Resolution # 2016-115, requesting and authorizing the Planning Board to undertake a preliminary investigation to determine whether the properties identified as:

Block 2018, Lot 1; Block 2019, Lot 1; as identified on the Official Tax Map of the Town of Dover (the "Study Area") to determine if such properties qualify as a "non-condemnation" area in need of redevelopment pursuant to the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1, et seq. (the "Redevelopment Law"); and

WHEREAS, the Planning Board retained the services of Maser Consulting, P.A., a professional engineering, planning and design firm ("Maser") to assist in conducting the necessary investigations and analysis to determine whether the Study Area does or does not qualify as an area in need of redevelopment under the criteria set forth in the Redevelopment Law; and

WHEREAS, Maser conducted such investigations and prepared a report of its investigations entitled "*Redevelopment Study Area Determination of Need, Guenther Mill Site : Block 2018, Lot 1; Block 2019, Lot 1*" dated July 6, 2016 (the "Redevelopment Investigation Report"); and

WHEREAS, the Redevelopment Investigation Report concludes that the Study Area and the properties therein exhibit conditions which conform with various redevelopment criteria, including criteria a, b, d, and e under Section 5 of the Redevelopment Law, *N.J.S.A.* 40A:12A-5, as more specifically set forth in the Redevelopment Investigation Report; and

WHEREAS, on July 27, 2016, the Planning Board conducted a duly-noticed public hearing, pursuant to *N.J.S.A.* 40A:12A-6, at which time it heard a presentation of the Redevelopment Investigation Report by David G. Roberts, AICP/PP, LLA, RLA, the primary author of the Redevelopment Investigation Report, as well as comments from Michael Hantson, PE, PP, CME, the Town Engineer and Planner and members of the public in attendance; and

WHEREAS, Mr. Roberts and Mr. Hantson responded to questions from the Planning Board members and members of the public; and

WHEREAS, based upon the Redevelopment Investigation Report, Mr. Roberts' testimony concerning the Redevelopment Investigation Report and the comments from the public, the Planning Board accepted the findings of the Redevelopment Investigation Report and concluded that the Study Area meets the criteria for designation as a "non-condemnation" area in need of redevelopment under the Redevelopment Law as detailed in the Redevelopment Investigation Report and recommending that the Mayor and Board of Alderman designate the Study Area as an area in need of redevelopment, pursuant to the Redevelopment Law; and

WHEREAS, the Mayor and Board of Alderman accept the conclusions of the Redevelopment Investigation Report and the Planning Board's recommendation and wish to designate the Study Area as a "non-condemnation" area in need of redevelopment.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Alderman of the Town of Dover that the Study Area described herein be and hereby is designated as a Non-Condemnation Redevelopment Area, pursuant to *N.J.S.A.* 40A:12A-5 and *N.J.S.A.* 40A:12A-6.

BE IT FURTHER RESOLVED, that the Dover Planning Board prepare a Redevelopment Plan for said properties in accordance with NJSA 40A:12A-7.

WHEREAS, the budget of the Town of Dover could not be fixed due to delays in the State of New Jersey providing information and approving of same; and

WHEREAS, this has caused an issue with the cycle of tax bills as they could not be printed and distributed in a timely fashion; and,

WHEREAS, additional grace time must be granted to taxpayers to pay their tax bills as taxes are due on the first day of August, 2016; and

WHEREAS, the new recommended grace period for third quarter taxes is August 18, 2016;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

- 1. There is hereby approved an extension of the grace period to August 18, 2016, during which time period payments received will not be considered delinquent.
- 2. The tax collector is hereby authorized to receive tax payments through August 18, 2016 without the imposition of a penalty, but all payments received after August 18, 2016 will receive the penalty for interest charges from August 1, 2016 to the date of payment.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AWARDING A CONTRACT PURSUANT TO N.J.S.A. 40A:11-5(1) (a)(ii) AND N.J.A.C. 5:34-2.1 ET SEQ., TO DOWNTOWN DECORATIONS, INC. FOR EXTRAORDINARY UNSPECIFIABLE SERVICES

WHEREAS, the Town of Dover has determined that a need exists for the provision of the design, purchase, installation, removal and storage of winter holiday decorations at JFK Commons Park, in the Town of Dover; and

WHEREAS, the Town has determined that the scope of material and services contemplated is extraordinary and unspecifiable and meets the definition of an EUS in accordance with N.J.S.A. 40A:11-5(1) (a)(ii), known as the Local Public Contracts Law and the rules and regulations set forth by the New Jersey Department of Community Affairs, Division of Local Government Services in N.J.A.C. 5:34-2.1, et seq.; and

WHEREAS, the Town Administrator has certified that these services meet the criteria established by law and the regulations governing the award of contracts for EUS; and

WHEREAS, the Town has determined that Downtown Decorations, Inc. can provide the materials and services that the Town desires; and

WHEREAS, pursuant to the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.), as an award of a contract for "extraordinary, unspecifiable services" without competitive bids, this resolution and subsequent contract will be maintained on file in the office of the municipal clerk and available for public inspection; and

WHEREAS, the Chief Financial Officer has certified that available funds exist and the project will be funded from Capital Accounts C-04-55-928-001, C-04-55-930-003, C-04-55-932-001 and C-04-55-932-007 and said certificate of availability of funds has been prepared and is on file in the office of the municipal clerk; now, therefore, be it

RESOLVED by the Mayor and the Board of Aldermen of the Town of Dover, Morris County, New Jersey as follows:

- 1. The Mayor and the Board of Aldermen hereby authorize the execution of a Contract with Downtown Decorations, Inc., 672 Joy Road, East Syracuse, New York 13057 for the provision of the design, purchase, installation, removal and storage of winter holiday decorations at JFK Commons Park, in the Town of Dover, for a period of up to two years in an amount not to exceed \$215,000.00.
- 2. This contract is awarded without competitive bidding as an "extraordinary unspecifiable service" in accordance with N.J.S.A. 40A:11-5(1) (a)(ii), known as the Local Public Contracts Law and the rules and regulations set forth by the New Jersey Department of Community Affairs, Division of Local Government Services in N.J.A.C. 5:34-2.1, et seq.

PUBLIC COMMENTS

Ennette Boyiatyis – 59 Spring Street – Ms. Boyiatyis requested "no parking signs" at the corner of Spring Street and Elizabeth Street. Mayor Dodd noted that they will look into the request.

Antonio Acosta – 130 Madison Avenue – Mr. Acosta asked for an update on the redevelopment project at Dickerson and North Sussex Streets. Mayor Dodd explained that there have been some issues with the project, noting an issue with the electrical design, the relocation of transformers and funding for the property. He also explained that when the redevelopment company approached the bank for funding, the bank requested additional parking spaces which require them to make changes to the plan. However, Mayor Dodd expressed that the project will continue to move forward. Mr. Acosta made a suggestion for town to participate in events, like National Night Out, to help promote the town. He asked the town to seek funding for trees to be planted. Mr. Acosta's home was recently burglarized and requested an increase in police patrol in the area. He was lead to believe that there would be an increase in patrol however when he reviewed the security system there where only four visits to his area. Mr. Travisano noted that he has emails to show that the request was made and he's disappointed with the number of patrols that were made.

Karen Gorski – 9 Summer Avenue – Mrs. Gorski's neighbor left a cabinet on their front yard and then was placed at the curb without a sticker. She noted that this occurred for 6 weeks and there was no follow up with the town. She also commented that people park on their front lawns which she thought was illegal. Mayor Dodd noted that they will look into the garbage complaint and the police will stop by regarding the parking concern.

Marie Tambini - E. Blackwell Street – Ms. Tambini made the board aware that there's a lady selling new merchandise on Blackwell Street every weekend. The board was under the impression that it was a garage sale and will make changes for weekend enforcement.
