Nature of work: The existing ramp from Route 46 WB to Route 15 NB will be widened to accommodate two-way traffic and Route 15 will now terminate at a temporary signalized intersection at Route 46 while the new permanent intersection and associated structures are constructed. ## Anticipated Traffic Impacts:
