- (3) The minimum lot depth shall be 300 feet.
- (4) No side yard shall be less than the height of the building or structure.
- (5) Value represents a minimum for any side yard
- (6) The cluster development option exists in the R-1S Zone. See §236-21.1.I for requirements.
- (7) See the "Steep Slope" Ordinance for various adjustments to Lot Coverage and Building Coverage.
- (8) Parking Requirements for Residential Uses before the Planning Board or Board of Adjustment shall be in accordance with the "Residential Site Impeovement Standards NJAC 5:21 et. seq. (RSIS).
