#### **NEW BUSINESS ITEMS**

Interim Administrator Bennett reported that the Town officially received a grant from the NJDCA Local Government Emergency Fund for COVID related expenses in the amount of \$334,939. He also reported that the Town received an NJDOT grant for White St. in the amount of \$411,700.

He also reported that the Town received a grant from the North Jersey Planning Authority to assist in developing a Business Director. Mr. Bennett also reported that on November 10, 2020 a meeting was held with the Library Trustees to discuss the renovation process and a follow-up meeting is scheduled. He also reported that there was a meeting with the West Orange BA about a Shared Service for CFO Services.

Mr. Bennett also stated that Budget meetings for next year's budget are occurring. He also provided an update that open positions in the Water Commission have been filled as well as other personnel actions. Mr. Bennett also reported on other meetings which are coming up including a meeting with St. Clair's hospital, the Police Department Records Room, and the Fire Committee concerning revamping the Fire Department.

Mr. Bennett also reported that a new COVID clinic is opening by Zufall at Sacred Heart and is being sponsored by the County of Morris and that there will be an increase Police presence on Blackwell Street and in the downtown area by our Class II officers.

Mayor Blackman reported about the COVID fair which was sponsored by our Health Department in conjunction with MetLabs. The Mayor stated that it was well attended and over 300 COVID tests and antibody tests were administered. The Mayor also stated that over 500 educational flyers were handed out.

The Mayor also spoke about the seasonal leaf collection, which ends on December 11, 2020. The Mayor also stated that the Christmas Tree Lighting will occur on Thursday at 6:00p.m. and will be livestreamed this year. Starting on Friday the public can visit and walkthrough the park. Fire Chief Filosa spoke about the tree lighting on Thursday night and reported that the Fire Department along with the Police Department will be coordinating with Santa to bring him around town.

Deputy Chief Delaney reported the PBA and the Department raised funds from No Shave November for Cancer research. Information will also be posted if anyone in the public wishes to donate.

Alderman Correa asked for a report concerning the new financial deal between Meridia and the Town of Dover. Specifically, how the new deal benefits the Town. Redevelopment Counsel Fran Regan introduced himself and provided a report. The first part of the deal is introducing the Ordinance tonight. The agreement will restructure the PILOT to the Town which was based on 2% of the construction costs of the project per year, which is roughly \$217,000 and is being changed to a percentage to annual gross revenues, which is the normal PILOT. The PILOT will be 10% of the gross revenues for Year 1 to 10 and will increase 1% each additional five year period up to 30 years. It is anticipated that the PILOT revenue may be around \$400,000 once the building is at full occupancy and believes the PILOT deal is better. He also stated that at the time a Capital Grant was made by the Town in the amount of \$6.8 Million dollars which will be repaid to the Town . Additionally, a \$350,000 payment will be made to the Town which be received by the closing. Mr. Regan stated that the \$350,000 can be used for expenses which the Town covered in relation to the work for the grant.

Alderwoman Rugg spoke about the COVID Health Fair this past weekend. Alderwoman Rugg stated that she attended and commented how organized it was and spoke about not only how well attended it was but how peoples of age groups attended, including children who came with their parents.

#### **PUBLIC COMMENT:**

Acting Municipal Clerk Schmidt read the procedures for public comment and the meeting was opened to the public.

No member of the public wished to address the governing body and Mayor Blackman closed that portion of the meeting.

Mayor Blackman stated that there will be a Table of Hope Food Drive this Friday.

Mayor Blackman then asked for a Motion to adjourn at 8:26p.m. A motion was made by Alderwoman Wittner, second by Alderwoman Cruz to adjourn the meeting at 8:26p.m. with the following members in favor: Aldermembers Correa, Tapia, Ballesteros, Rugg, Cruz, Valencia, Quinones, Wittner and Mayor Blackman.
