Alderman Picciallo will abstain from the bills list (item # 11-02729 &11-02665/line #2)

Mayor Dodd commented on #2, noting that a resignation letter was received from Robert Young, our longtime construction official. He thanked Mr. Young for his years of service. (Resolution #2 on Agenda Items)

Mayor Dodd commented on #6 which is a salary resolution for the Chief of Police and noted that by law the Chief's salary must be higher than the next lower ranking officer.

Mayor Dodd commented on #7, noting that the contract will allow for the policy and procedures manual to be updated. He explained that the towns' insurance company (JIF) requires the manual to be updated every two (2) years. Mr. Close provided additional information on the procedure.

Mayor Dodd commented on #8 explaining that the phone system is antiquated and it's necessary for the system to be replaced.

Mayor Dodd commented on #9. He noted that the town entered into an agreement with the County of Morris for dispatch services in July, and at that time, the town made it known that the town would no longer provide positions for dispatchers in the community. The plan is to receive approval from the NJ Civil Service Commission to go ahead with the layoff.

Mayor Dodd noted that there's a resolution to enter into executive session which can be entered into prior to voting on the agenda items.

REGULAR MEETING MINUTES December 13, 2011

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:50 pm

ROLL CALL

Present: Aldermen Delaney, Poolas, Visioli, Picciallo, Timpani, Romaine, Blackman, Downs and Mayor Dodd

Also present were Attorney Pennella, Administrator Close and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened the meeting to public.

JOHN BARBARULA, ESQ. – Butler, NJ – (Representing the Chief of Police) Mr. Barbarula wanted to know when the discussion for the need of ordinance #21-2011 took place. He also wanted to know the legislative intent on the two affects listed in the ordinance ("to better the police department" and "to service those customers and clients who utilize the service"). Mayor Dodd noted that the concept came out of a personnel committee meeting and it was also discussed at a finance committee meeting along with the resolution on the use of municipal vehicles, in a way to improve efficiency in the community and reduce expenses. Mayor Dodd explained that they looked at the cost of officers on outside detail (superior officers vs. police officers) noting that it's a higher expense to pay for a superior office than a police officer. Mayor Dodd noted that the idea behind the ordinance is to reduce the cost while still allowing police officers to provide a service (outside detail) to the community. He noted that the chief of police is a non-union position so the board has the ability to address it through ordinance. He explained that the intent is to have an ordinance which applies to all superior officers not just the chief of police. Mr. Barbarula wanted dates of the meetings where the discussions took place. He also wanted to know if there were any complaints from outside vendors. It was noted that complaints were received constantly but there were no records on file.

DANIEL MARTINEZ – 57 Spring St. – Mr. Martinez wanted to know if the layoff was automatic or if it was decided as a board. Mayor Dodd explained that when the board decides to take an action, it requires an approval from the NJ Civil Service Commission. The resolution allows for the layoff plan to be sent to the state for their approval. Discussions continued on the position of dispatcher. Mr. Martinez is concerned that a police officer would be taken off the road to address the public, when they come in to headquarters, during regular business hours.

EMILIANO LEMOS – 48 Second St. – Mr. Lemos wanted to know how long the town has been receiving complaints. Mayor Dodd explained for a very long time. Mr. Lemos commented that he finds it very strange and believes the ordinance to prohibit the chief from working outside detail was established due to political reasons. Mayor Dodd disagreed with Mr. Lemos's comments. Mr. Lemos noted that the community would be affected since (seventy) 70% of the population is Latino. Mayor Dodd expressed that there are several bilingual police officers in the police department. Discussion continued on the dispatcher's position

MAYOR'S REPORT: Mayor Dodd will postpone his report till the next meeting.

ATTORNEY'S REPORT: Attorney Pennella wished the public a happy holiday and prosperous New Year. There has been no change in the status of litigation since the last report.

Attorney Pennella provided the board with a definition on "abstention" from a resolution or an ordinance.

ORDINANCE FOR SECOND READING

ORDINANCE NO. 21-2011 AN ORDINANCE AMENDING CHAPTER 57 OF THE CODE OF THE TOWN OF DOVER, ENTITLED "POLICE DEPARTMENT"

WHEREAS, the Town Code of the Town of Dover (the "Town") currently contains Chapter 57, entitled "Police Department," which authorizes the outside employment of Town police officers while off duty; and

WHEREAS, the Town desires to amend Chapter 57 (Police Department) of the Code to limit outside employment while off-duty to all officers below the rank of Chief of Police; and

WHEREAS, the goal of said ordinance is to allow the Police Department to operate in a more efficient and cost-effective manner and to better serve the residents and guests of the Town.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Board of Aldermen of the Town of Dover, County of Morris, State of New Jersey, that Chapter 57 of the Town Code entitled, "Police Department" is hereby amended as follows (additions underscored):

1. Chapter 57, Section 16 (Purpose) shall be amended as follows:

For the convenience of those persons and entities which utilize the services of off-duty law enforcement officers of the Dover Police Department and to authorize the outside employment of

Town police while off duty, the Town hereby establishes a policy regarding the use of said officers:

4

All members of the Police Department, below the rank of Chief of Police, shall be permitted to accept police-related employment for private employers or school district only during off-duty hours and at such time as will not interfere with the efficient performance of regularly scheduled or emergency duty for the Town.

В.

Any person or entity wishing to employ off-duty police shall first obtain the approval of the Chief of Police, which approval shall be granted if, in the opinion of the Chief, such employment would not be inconsistent with the efficient functioning and good reputation of the Police Department and would not unreasonably endanger or threaten the safety of the officer or officers who are to perform the work.

2. Chapter 57, Section 18 (Rates of compensation; administrative fee; payment) shall be amended as follows:

Α.

Rates of compensation for contracting the services of off-duty law enforcement officers shall be based on the regular rates of the officer working the detail.

B.

An additional 20% per hour for any person or entity and 10% per hour for non-profit organizations is hereby established to cover administrative costs, overhead and out-of-pocket expenses of the Town of Dover. The Town of Dover Board of Education is exempt from the administrative fee.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect upon passage and publication in accordance with applicable law.

Mayor Dodd opened the meeting to the public for a hearing and the following comments were made.

DANIEL MARTINEZ – 57 Spring St. – Mr. Martinez asked if the Board of Education can be exempt from the fees. Mayor Dodd noted that it would have to be discussed during contract negotiations.

JOHN BARBARULA, ESQ. – He wanted to know how the ordinance would make the department operate in a more efficient and cost effective manner.

Attorney Pennella commented that the public has the right to comment but the Mayor is not under cross examination and suggested that Mayor Dodd just thank Mr. Barbarula for his comments.

EMILIANO LEMOS – 48 Second St. – Mr. Lemos wanted clarification on ordinance #21-2011. Mayor Dodd has made his comments in previous response.

Mr. Close commented that section 2B of ordinance #21-2011 eliminates the 20% administrative for the Board of Education.

Seeing no hands and hearing no voices Mayor Dodd closed the meeting to the public and called for the vote.

RESOLUTION APPROVING TERMINAL LEAVE FOR CONSTRUCTION CODE OFFICIAL

WHEREAS, the Construction Code Official/Fire Sub Code Official/Building Inspector has notified the Mayor and Board of Aldermen of his intention to retire as of December 31, 2011; and

WHEREAS, established town policy is that 75% of accumulated sick time be granted as time off with pay plus 100% accumulated vacation time; and

WHEREAS, under current policy the Town will be required to pay the accumulated sick time and vacation time as well as the salary of the replacement for the Construction Code Official/Fire Sub Code Official/Building Inspector; and

WHEREAS, in order to lessen the financial impact of the Construction Code Official/Fire Sub Code Official/Building Inspector, he has offered to accept compensation for the accumulated sick time and vacation time over a period of years after he is off the payroll rather than requiring that the Town pay this amount out over a period of approximately 12 months, as per the current town policy, which would thus cause a significant financial hardship to the Town in dealing with its budget in 2012.
