## **Board of Trustees of the Dover Free Public Library** Minutes of the Regular Meeting – April 14, 2011

## **Regular Monthly Meeting:**

Board President Alan Bocchino called the April 14, 2011 meeting of the Board of Trustees to order at 7:08 PM.

#### Roll call:

**Previous Meeting Minutes:** The minutes of the March 10, 2011 regular meeting of the Board of Trustees were submitted and approved by the Board. Motion to approve: Carolyn Bishop, seconded by Carol Walker.

#### **Treasurer's Report:**

• Checking account balance is \$12,789.82. CD balance \$59,250.94.

### **Director's Report:**

- Director's report submitted to the Board via email prior to the meeting.
- Krista questioned whether we could offer more programs in the library. Rob stated that we do not have sufficient staff to increase the number of programs.
- It was suggested that we do a brain-storming session for ways to let people know what the Library has to offer.
  - o More publicity at Town Hall
  - o Table at the Dover Fair coming up in June
  - o Make up a flyer to be sent out via each of the schools
  - o Send out a flyer to Dover homeowners; use 3<sup>rd</sup> class bulk rate mail

#### **Old Business:**

- Books and DVDs have been donated to us by other libraries
- Helen suggested having a fishing program
  - o Knee Deep Club may be a good group to do the program
  - o Irene to provide Rob with the contact information
- Alan checked on the rates for our CD at Sovereign Bank

- o 18 month CD may be worth looking into as the rate is higher than for a 12 month CD
- o Will also look into transferring our checking account to Sovereign Bank
- Alan suggested that we have an election for Secretary and Treasurer
  - o Currently 2 people on the board hold 2 positions each
  - o Next meeting we will have elections for Secretary and Treasurer
  - o Motion to hold elections next meeting:
    - Heather Carlton, seconded by Helen Pennella
- Rob reiterated the announcement of a new countywide ILS
  - o All actions will be different
  - o Staff will be trained
  - o Installation to begin in October
  - o Changeover will be completed by end of 2011
  - $\circ$  There may be 6-8 weeks disruption during the changeover period
- Budget
  - o Krista created a spreadsheet showing the spending so far for the year; 2011 Budget, YTD, Over/Under
  - o Goal is to make it easier to view our total spending
- Attendance by members of the public
  - o Seating away from the board table will be provided at all future meetings
