CAUCUS MEETING MINUTES April 28, 2009 7:00 PM

The Caucus Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

Mayor Dodd called the meeting to order at 7:00 pm

REGULAR MEETING MINUTES April 28, 2009

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:13 pm

ROLL CALL

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only.

JIM MULLIN – 150 Ann Street – Mr. Mullin wanted to know if an update would be provided on the letter from the State of NJ, Council on Affordable Housing (COAH) regarding the waiver from the 20% Affordable Housing Obligation for Highlands Municipalities (correspondence section). Mr. Close stated the application has been removed from the agenda and there's no action pending. Mr. Mullin wanted to know if there's a budget to be placed on the agenda. Mayor Dodd commented we do not have the final numbers for the budget.

Seeing no hands and hearing no voices Mayor Dodd closed this portion of the meeting to the public.

<u>ADMINISTRATOR CLOSE</u> – Administrator Close stated the finance committee met last night. He explained that the Mayor and several departments had a meeting concerning Club Columbia's request for the use of Crescent Field for the Columbian festival. He noted that the police department is working on grant applications.

<u>MAYOR DODD'S REPORT</u> –Attended various events and or meetings: Little League, Fishing Derby. Also attending the grand opening of the Hilton Hotel and was very pleased that it is decorated with a Dover theme.

ALDERMEN/COMMITTEE REPORTS

<u>ALDERMAN TIMPANI</u> – Alderman Timpani reminded the public that the Mayor's Fishing Derby is scheduled for May 30th. He commented that he has received assistance for the fishing derby from a few of the board members (Aldermen Poolas, Delaney and Picciallo).

<u>ALDERMAN DELANEY</u> – Alderman Delaney received a copy of the fire report and noted calls have increased. Portions of Alderman Delaney's comments are inaudible due to static from the microphone. Alderman Delaney attended the PBA Beefsteak event.

<u>ALDERWOMAN BLACKMAN</u> – Alderwoman Blackman reminded the public about Regency Grande's screening event. She has walked her neighborhood regarding several concerns and thanked Mr. Close for his assistance. She attended the ribbon cutting ceremony and breakfast for the Rotary club.

<u>ALDERMAN VISIOLI</u> – Alderman Visioli is researching taxi-limo ordinances from other municipalities and has been in contact with several towns to obtain feedback from many of their professionals.

<u>ALDERWOMAN ROMAINE</u> – Alderwoman Romaine thanked Administrator Close for the quick response on her concerns regarding housing and street/road issues. She noted that the committee has been working on the budget and several personnel meetings have been scheduled for the future.

<u>ALDERMAN DONOFRIO</u> – Alderman Donofrio attended the Little League Parade. He thanked Administrator Close for addressing his concerns. Alderman Donofrio recommended the representative from the county that provided the board of health with a flu presentation be brought to the town meeting for a public presentation. Alderwoman Blackman commented that the information has been placed on the website and brochures have been placed in the health office.

ALDERMAN PICCIALLO – Alderman Picciallo thanked and recognized the police officers for their quick action in the incident that occurred in the Fox Hill area. He also thanked the Police and Fire Department for their quick response to the fire in the third ward. He attended the ribbon cutting ceremony for the new Hilton Hotel and commented on their well decorated building. He thanked Administrator Close, Recreation, Police, Fire and Public Works Departments for their assistance with the parade. He provided the public with a code enforcement update. He will be assisting Alderman Timpani with the Mayor's Fishing Derby. He also noted that the finance committee did a wonderful job with the budget.

ORDINANCE FOR INTRODUCTION

ORDINANCE NO. 09-2009

OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY IMPOSING A TAX ON HOTEL/MOTEL OCCUPANCY

Be it ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

- 1. <u>Imposition of Tax</u>. Pursuant to <u>N.J.S.A</u>. 40:48F-1, the Town of Dover hereby imposes a tax of three (3%) percent on charges of every rent for every occupancy of a hotel or motel located within the municipal borders of the Town of Dover, Morris County, New Jersey. The imposition of this tax is in addition to any other tax or fee imposed pursuant to statute or local ordinance or resolution by any governmental entity upon the occupancy of a hotel room.
- 2. <u>Payment of Tax</u>. All taxes imposed under this ordinance shall be paid by the purchaser. The vendor shall not assume or absorb any tax imposed by this ordinance. The vendor shall not in any manner advertise or hold out to any person or to the public in general, in any manner, directly or indirectly, that the tax will be assumed or absorbed by the vendor, that the tax will not be separately charged and stated to the customer, or that the tax will be refunded to the customer.

3. Collection of Tax.

- A. The tax imposed pursuant to this ordinance shall be collected on behalf of the municipality by the person collecting the rent from the hotel customer.
- B. Each person required to collect a tax imposed by this ordinance shall be personally liable for the tax imposed, collected or required to be collected hereunder. Any such person shall have the same right in respect to collecting the tax from a customer as if the tax were a part of the rent and payable at the same time; provided however, that the chief financial officer of the municipality shall be joined as a party in any action or proceeding brought to collect the tax.

4. Returns.

- A. A person required to collect a tax imposed pursuant to this ordinance shall, on or before the dates required pursuant to N.J.S.A. 54:32B-17, forward to the director of the Division of Taxation in the Department of the Treasury, the tax collected in the preceding month and make and file a return for the preceding month with the director in any form and containing any information as the director shall prescribe as necessary to determine liability for the tax in the preceding month during which the person was required to collect the tax.
- B. If the director permits or requires returns to be made covering other periods and other dates as the director may specify, the person required to collect a tax imposed under this ordinance shall abide by the director's requirements.
- 5. **Governing Law**. A tax imposed herein shall be governed by the provisions of the "State Uniform Tax Procedure Law," R.S. 54:48-1, *et .seq*.
- 6. <u>Penalties</u>. If a vendor assumes or absorbs the tax being charged under this ordinance, each assumption or absorption shall be deemed a separate offense and each representation or advertisement by a vendor for each day the representation or advertisement continues of an assumption or absorption shall be deemed a separate offense. Such offense shall be punishable by a fine of not more than \$1,250.00, imprisonment for 30 days, or both.
 - 7. Filing of Ordinance. A copy of this ordinance once adopted shall be transmitted to the state treasurer.
- 8. **Effective Date**. This ordinance shall be effective upon second reading and publication in the official newspaper of the State of New Jersey and 90 days after the transmittal of the adopted ordinance to the State treasurer.
- 9. **Repealer.** All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 10. **Severability**. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER APPROVING APPLICATION FOR 2008 TONNAGE GRANT

WHEREAS, the Mandatory Source Separation and Recycling Act, P.L.1987, c.102, has established a recycling fund from which tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, it is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs; and
