# ORDINANCE NO. 15-2017 AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS, NEW JERSEY ESTABLISHING A STOP SIGN ON WHITE STREET AT THE INTERSECTION OF HILLSIDE AVENUE

**WHEREAS**, pursuant to *N.J.S.A.* 40:48-2, the governing body of a municipality may make, amend, repeal, and enforce such other ordinances, regulations, rules and by-laws not contrary to the laws of this State or of the United States, as it may deem necessary and proper for the good government, order and protection of person and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any law; and

**WHEREAS**, the Municipal Engineer investigated the limited sight distance at the intersection of White Street and Hillside Avenue within the Town of Dover; and

**WHEREAS**, the Municipal Engineer prepared a report entitled "Investigation of Three Way Stop Condition, White Street at Hillside Avenue" (the "Report") dated May 4, 2017; and

**WHEREAS**, pursuant to *N.J.S.A.* 39:4-8(b)(1) the Town of Dover is permitted to designate any intersection as a stop intersection and erect appropriate signage if the intersection is located within 500 feet of school without the need for approval from the New Jersey Department of Transportation; and

WHEREAS, the intersection is located less than 250 feet from Dover High School; and

**WHEREAS**, the Report sets forth the Municipal Engineer's professional opinion that in the interest of safety and the expedition of traffic on the public highways, that a stop sign be erected on westbound White Street at its intersection with Hillside Avenue, thereby creating an All Way Stop at the intersection; and

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

- 1. Pursuant to *N.J.S.A.* 39:4-8b(1)c, there is hereby established a stop intersection on White Street at its intersection with Hillside Avenue. The proposed stop sign shall be located on westbound White Street at its intersection with Hillside Avenue.
- 2. There shall be installed signage and markings at the intersection of White Street and Hillside Avenue. Specifically, the required signage and striping shall be installed as set forth on the plan entitled "Signage & Marking for White Street & Hillside Avenue" prepared by the Municipal Engineer and annexed to the Report.
- 3. This ordnance shall be submitted to the Municipal Engineer and he shall, under his seal as a licensed professional engineer, certify to the governing body of Dover that the sign and its placement have been approved by the engineer after investigation of the circumstances, and that it appears to the engineer to be in the interest of safety and

expedition of traffic on the public highways and conforms to the current standards prescribed by the manual of the uniform traffic control devices for streets and highways as adopted by the Commissioner of Transportation, all as required by *N.J.S.A.* 39:4-8.

- 4. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 5. If any section, subsection, sentence, clause, phrase, or portion of the ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
- 6. This Ordinance shall take effect upon passage and publication as provided by law.

WHEREAS, the project may require the construction of new and or the protection, relocation and/or adjustment of facilities of the existing Sewer System and Water System which is owned and operated by the Town of Dover; and

### RESOLUTION AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$4,750,000 BOND ANTICIPATION NOTES OF THE TOWN OF DOVER, IN THE COUNTY OF MORRIS, NEW JERSEY

### BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

Pursuant to a bond ordinance of the Town of Dover (the "Town") entitled: "Bond ordinance providing for the improvement of the Meridia Transit Plaza in and by the Town of Dover, in the County of Morris, New Jersey, appropriating \$2,000,000 therefor and authorizing the issuance of \$1,900,000 bonds or notes of the Town for financing such appropriation", finally adopted on July 12, 2016 (#17-2016), bond anticipation notes of the Town in a principal amount not exceeding \$1,900,000 shall be issued for the purpose of temporarily financing the improvement or purpose described in Section 3 of said bond ordinance, including (to any extent necessary) the renewal of any bond anticipation notes heretofore issued therefor.

Pursuant to a bond ordinance of the Town of Dover (the "Town") entitled: "Bond ordinance appropriating \$3,000,000, and authorizing the issuance of \$2,850,000 bonds or notes of the Town, for various improvements or purposes authorized to be undertaken by the Town of Dover, in the County of Morris, New Jersey", finally adopted on May 9, 2017 (#09-2017), bond anticipation notes of the Town in a principal amount not exceeding \$2,850,000 shall be issued for the purpose of temporarily financing the improvement or purpose described in Section 3 of said bond ordinance, including (to any extent necessary) the renewal of any bond anticipation notes heretofore issued therefor.

All bond anticipation notes (the "notes") issued hereunder shall mature at such times as may be determined by the treasurer, the chief financial officer or the acting chief financial officer of the Town (the "Chief Financial Officer"), provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer and shall be signed and sealed by officials and officers of the Town in any manner permitted by N.J.S.A. §40A:2-25. The Chief Financial Officer shall determine all matters in connection with the notes issued hereunder, and the Chief Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. §40A:2-8. The Chief Financial Officer is hereby authorized to sell part or all of the notes at not less than par from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price. The Chief Financial Officer is directed to report in writing to the governing body of the Town at the meeting next succeeding the date when any sale or delivery of the notes hereunder is made. Such report must include the principal amount, interest rate and maturities of the notes sold, the price obtained and the name of the purchaser.

Any note issued pursuant to this resolution shall be a general obligation of the Town, and the Town's faith and credit are hereby pledged to the punctual payment of the principal of and interest on the notes and, unless otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget and a tax sufficient to provide for the payment thereof shall be levied and collected.

The Chief Financial Officer is hereby authorized and directed to do all other matters necessary, useful, convenient or desirable to accomplish the delivery of the notes to the purchasers thereof as promptly as possible, including (i) the preparation, execution and dissemination of a Preliminary Official Statement and Final Official Statement with respect to the notes, (ii) preparation, distribution and publication, if necessary, of a Notice of Sale with respect to the notes, (iii) execution of a Continuing Disclosure Undertaking, with respect to the notes in accordance with Rule 15c2-12 promulgated

by the Securities and Exchange Commission and (iv) execution of an arbitrage and use of proceeds certificate certifying that, among other things, the Town, to the extent it is empowered and allowed under applicable law, will do and perform all acts and things necessary or desirable to assure that interest paid on the notes is not included in gross income under Section 103 of the Internal Revenue Code of 1986, as amended.

All action heretofore taken by Town officials and professionals with regard to the sale and award of the notes is hereby ratified, confirmed, adopted and approved.

This resolution shall take effect immediately.
