Minutes of the regular meeting held on June 13, 2006

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 North Sussex Street, Dover, New Jersey.

Mayor Dodd called the meeting to order at 7:53.

ROLL CALL

Clerk Verga stated adequate notice has been provided and this meeting is in compliance with the Open Public Meetings Act.

Mayor Dodd opened this portion of the meeting to the public. Seeing no hands and hearing no voices Mayor Dodd closed this portion of the meeting.

MAYOR'S REPORT

Mayor Dodd met with the Skyliners and Recreation Department as well as Police Chief to iron out details of the Skyliners upcoming event. A Taxi and limo update meeting was attended. Mayor's Scholarship awards were given out to Dover High School students. Renovations in Town Hall continue. Mayor Dodd thanked resident John Rich for donating the new sign in front of Town Hall supporting our troops. A three day seminar will be attended at Princeton University – Mayor's Institute.

ALDERMEN/COMMITTEE REPORTS

Alderman Poolas: Reported on the success of the Mayor's First Annual Fishing Derby. Board of Health meeting was attended and reported on same.

Alderwoman Burbridge: Attended Head Start Volunteer Recognition luncheon and reported on the continued success of this program. She also attended the Library Board Meeting and reported on same.

Alderman Ryan: Attended the Board of Education meeting and reported on same.

Alderman Delaney: Has been attended regular committee meetings for which he is a member of. A Bike Safety course was held at Academy Street School. Plans for a Town Wide Neighborhood Watch meeting to be held in July were discussed and he will advise this board when a date is set.

Alderman Fahy: Recreation Commission meeting was cancelled due to lack of quorum. July 4th celebration plans are underway.

Alderman Visioli: Hoping to have a CARE presentation at next meeting. Fire Committee meeting was attended and reported on same. Delivery of new ambulance will be in September. Five new applications for Fire fighters have been received, would like Town Attorney to check into legality of performing background checks. The need for consistent guidelines needs to be established relating to the issue of how do we treat those individuals that refuse emergency service by Police, Fire or EMT's.

ATTORNEY REPORT: A trial date of June 20th is set for the case of the Town of Dover vs Lt. Cappello regarding his request for salary increase as he claims he has attained his Master's Degree. Investigation by Attorney indicates it was not approved in advance and that the degree was actually received from a "diploma mill" and class attendance was not required.

ORDINANCE(S) FOR INTRODUCTION

ORDINANCE #17-2006

BOND ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS AND APPROPRIATING THE SUM OF \$1,475,598 THEREFOR, AND AUTHORIZING THE ISSUANCE OF \$1,363,817 OF BONDS OR NOTES FOR THE PURPOSES SET FORTH HEREIN AUTHORIZED TO BE UNDERTAKEN IN AND BY THE TOWN OF DOVER, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DOVER, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The improvements and purposes described in Section 3 of this bond ordinance are hereby authorized as general improvements to be made or acquired by the Town of Dover, County of Morris, New Jersey (hereinafter referred to as the "Town"). For said improvements or purposes stated in Section 3 of this bond ordinance, there is hereby appropriated \$1,475,598, said sum being inclusive of all appropriations heretofore made therefore and including the sum of \$111,781 as the aggregate down payment from the Capital Improvement Fund or other funds of the Town which sum is now available by virtue of a provision in the currently adopted budget or a previously adopted budget of the Town and is currently available for down payment or capital improvement purpose, as required by the Local Bond Law of New Jersey N.J.S.A. 40A:2-1 et seq.(the "Local Bond Law").

Section 2. For the financing of said improvements or purposes and to meet the part of said \$1,475,598 appropriation not otherwise provided for hereunder, negotiable bonds of the Town are hereby authorized to be issued in a principal amount not to exceed \$1,363,817 pursuant to the Local Bond Law. In anticipation of the issuance of said bonds, negotiable notes of the Town in a principal amount not exceeding \$1,363,817 are hereby authorized to be issued pursuant to and within the limitations prescribed by said Law. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed \$1,363,817, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding, at maturity. Each bond anticipation note issued pursuant to this ordinance shall be dated or about the date of its issuance and shall be payable not more than one (1) year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within the limitations prescribed by the Local Bond Law. Each of said notes shall be signed and shall be under the seal of said Town and attested as permitted by law. The appropriate Town officers are hereby authorized to execute said notes and to issue said notes in such form as they may adopt in conformity with law. The power to determine all matters in connection with this ordinance and also the power to sell said notes is hereby delegated to the Chief Financial Officer of the Town (the "Financial Officer"), who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law, and the Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. The Financial Officer is authorized and directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of notes pursuant to this ordinance is made, such report to include the principal amount, description, interest rate and maturity of the notes sold, the price obtained and the name of the purchaser.

Section 3. The improvements hereby authorized and the purposes for the financing for which said obligations are to be issued are:

Alderman Fahy requested an explanation on the need for an incident command vehicle as well as the non-passenger vehicle. An explanation by Aldermen Delaney, Visioli as well as Mayor Dodd and Fire Department representative was given as to the need for this equipment. Alderman Fahy also questioned a line item for town hall improvements. The Mayor explained that this building has not been updated for many years and it is important we have an improved town hall for our residents.

Alderman Fahy questioned the lack of detailed information regarding both town improvements and the need for additional fire equipment.

Alderman Visioli explained that this information was available at Administrator Garvin's office. Mayor Dodd stated that 99% of this information was presented to every board member prior to this meeting – and asked why Alderman Fahy did not question this before tonight. Alderman Fahy said this was an open public meeting and he had a right to publicly question these items.

ORDINANCE #18-2006 ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER OF THE TOWN OF DOVER ESTABLISHING A STOP SIGN ON ELIZABETH STREET AT LAWRENCE STREET

Be it ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

Section 1. A stop sign shall be installed on Elizabeth Street at its intersection with Lawrence Street in the Town of Dover, New Jersey.

Section 2. This Ordinance shall be submitted to the Municipal Engineer for revision pursuant to N.J.S.A. 39:4-8.

Section 3. A certified copy of the adopted Ordinance shall be transmitted by the Clerk of the Town of Dover to the Commissioner of Transportation within 30 days of adoption together with the certification of the municipal engineer.

Section 4. All ordinances or parts of ordinances contrary to or inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

Section 5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

Section 6. This ordinance shall take effect in accordance with law.
