

TOWN OF DOVER MAYOR AND BOARD OF ALDERMEN CAUCUS MEETING MINUTES

July 13, 2010 7:00 PM

The Caucus Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

Mayor Dodd called the meeting to order at 7:00 pm

All joined in the Pledge of Allegiance to the Flag and prayer was given asking for guidance and strength to do what is right for our town and our citizens.

Clerk Verga stated adequate notice was given to the official newspaper.

David Evans, Nisivoccia & Co., LLP attended to answer any questions the board or public had pertaining to Ordinance No. 09-2010. Mr. Evans noted that with the water rate increase, Dover is still below Mine Hill and Wharton and about equal with Randolph.

Mayor Dodd opened the meeting to the public for a hearing, seeing no hands and hearing no voices Mayor Dodd closed this portion of the meeting to the public.

ORDINANCE NO. 09-2010

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER COUNTY OF MORRIS AND STATE OF NEW JERSEY AMENDING THE SUBSECTION OF THE REVISED GENERAL CODE OF THE TOWN OF DOVER ENTITLED, "WATER CHARGES FOR DOMESTIC, COMMERCIAL, PUBLIC, AND INDUSTRIAL USE IN THE TOWN OF DOVER, BOROUGH OF VICTORY GARDENS, AND PORTIONS OF THE TOWNSHIP OF RANDOLPH, TOWNSHIP OF ROCKAWAY, TOWNSHIP OF MINE HILL AND BOROUGH OF WHARTON"

WHEREAS, the Water Utility provides water service in the Town of Dover, Borough of Victory Gardens, portions of the Township of Randolph, Township of Rockaway, Township of Mine Hill and Borough of and Wharton; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey, as follows:

SECTION 9. This ordinance shall take effect upon final publication as provided by law.

Mr. Evans noted that the next order of business is to have the hearing for the 2010 Municipal Budget prior to the amendment that will take place later on.

Mayor Dodd asked for questions or comments from the board.

Alderman Visioli complimented Alderwoman Romaine, Mayor Dodd, Administrator Close and Alderman Picciallo for their assistance on the Finance Committee. He noted that countless hours, emotional drain and significant thought process went into the budget. He thanked the Finance Committee and the Administrator for pulling all the ends together.

Mayor Dodd opened the meeting to the public for a hearing on the 2010 Municipal Budget. Seeing no hands, hearing no voices Mayor Dodd closed this portion of the meeting to the public

Alderman Picciallo asked for clarification on the percentage when the budget was first introduced. Administrator Close stated it was 6.7% and went down to 5.65% and was 4.1 tax points.

Mayor Dodd asked if any council member would like to explain to the public as to why they voted "no" on 2010 Budget Alderman Delaney explained that received the amendment a few seconds prior to the meeting and fifteen minutes realized that the budget is on the agenda and he is unprepared. Alderwoman Romaine expressed that the adoption date had been set, back on June 1st, for July 13th. Alderman Visioli expressed that it should be no surprise to anyone on the board because the budget was introduced at the last meeting and normal protocol is to adopt at the next normally scheduled meeting. Alderwoman Romaine noted that no one expressed any issues during that time. Alderman Visioli expressed that if someone had a concern they should've called Mr. Close, he's in his office from 8:00 am to 7:00 pm (at least).

Alderwoman Romaine asked if there's a particular item or is there an issue on the budget that the board would like clarification on. She noted that the town is down 5.6% and if there wasn't an increase in the pension obligations, insurance obligations and the loss of state aid there would not be an increase in the municipal budget. She expressed that the budget was in the works since February and if anyone had concerns they should have come forward with their issue. She explained that Dover is within 4.1 tax points when other municipalities are looking 7, 8 and 9 tax points and Dover is doing the best they can without losing services.

Mr. Evans explained that when Governor Christie announced his tax cuts, he made a statement that he felt that the average residential taxpayer would be hurt by no more than \$250 annual and Dover is at \$120 which is far below under the state estimate.

Alderman Picciallo commented that he's been beating up the budget since March and has been communicating with Mr. Close with questions on the budget. He noted that Mr. Close did respond and he was satisfied with the answers which is why he voted "yes" on the budget. Alderman Picciallo thanked Mr. Close and CFO Kelly Toohey for answering his emails and also thanked Mr. Evans.

Alderwoman Blackman expressed similar comments as Alderman Picciallo, she to had questions that were answered by Mr. Close.

Mayor Dodd commented that he sat on the board for many years and had to face voting on budgets with 14, 15 and 16 tax point increases. He noted that this year was not an easy task, it's not easy to ask employees to take furlough days, it's not easy to make cuts in departments knowing that department heads and employees are affected by it. He explained that the result of the budget is many, many hours of hard work and dedicated people to pull it off. Mayor Dodd thanked CFO Kelly Toohey, the Finance Committee, Administration and Mr. Close.

Alderwoman Romaine commented that the salary ordinance goes into effect to January 1, 2009 to reflect the contractual obligations that Mr. Close was able to negotiate with the unions for three years. She noted that as part of contractual agreement that town was able to obtain lifetime benefits as a give back for new hires which is a major expense to the town and the increase is a 1.5% per year for three years. She expressed the agreement brings all the unions to renewal at the same time in 2012.

REGULAR MEETING MINUTES July 13, 2010

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:33 pm.

ROLL CALL

Present: Aldermen Delaney, Poolas, Visioli, Donofrio, Picciallo, Timpani, Romaine Blackman and Mayor Dodd

Also present were Administrator Close, Attorney Pennella and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only.

JON SPERRY - 58 No. Essex Street – Mr. Sperry wanted to know the acceptable level for a noise permit and expressed that in the past the noise level at the Salvation Army has been excessive (consent agenda #8). Mr. Close noted that the current ordinance shows the level at 50-60 but expressed that a review of the ordinance might be needed since the current levels are low. Mr. Sperry suggested getting a reading at a function to have data to compare. Alderman Timpani asked for the times of the events. Alderman Visioli noted that Saturday, August 14th is the longest in duration from 2:00 pm to 7:00 pm and the other dates are shorter.

<u>WARREN DARNULC</u> – 151 Grant Street – Mr. Darnulc commented that he was appreciative to see the agenda on the website. He would like to see more of the financial ordinances to provide more details.

MAYOR'S REPORT - Mayor Dodd noted that the Route 46 Bridge was closed this past Friday at 9:00pm by the NJ Department of Transportation (DOT) and alternate traffic routes are in effect. He noted that the Administration along with the Police and Engineering Departments are continuing to work with NJDOT to ensure a seamless transition as possible in an effort to minimize the impact upon the downtown area and town in general. He expressed that it's going to be difficult during the bridge closure but it's something that has to be done. He noted that the Police Department is monitoring the construction area daily to minimize the impact especially in the residential areas which are a major concern. He noted that the town held its annual firework display on Saturday, July 3rd at Hamilton field. He thanked the Recreation, Police, Public Works, Health & Fire Departments for their efforts in pulling the event together. Mayor Dodd read a letter from a resident complimenting the Police Department on the way they handled the fireworks. Mayor Dodd commended the Police Department for an excellent job done. Mayor Dodd is pleased to inform the public that the fence issue that was raised by Alderman Timpani has been addressed by the property owner at the Richards Avenue Park. He explained that the town has inspected the fence work and feels that its safety concern has been alleviated. Mayor Dodd noted that there are still some improvements that the town is looking to make for the safety of the children. He noted that the pedestrians' crosswalks in the downtown business district were restriped. He reminded the public that the Colombian Day Festival is scheduled for Saturday, July 17th at the Crescent Field Complex. He encourages everyone to attend to help celebrate the diversity of the community. Mayor Dodd thanked the Dover Housing Authority for making their community room available as a cooling center during the recent power outage. He thanked the Administration, Police & Fire Departments and Office of Emergency Management. Mayor Dodd announced that the Morris County's Freeholders have been generous to the Town of Dover's Municipal Alliance with an allocation of \$28,161 for the basics of implementing the formula concept to equally distribute Morris County's Total Allocation from the Governor's Council on Alcoholism and Drug Abuse. Mayor Dodd expressed that it's a great program that raises awareness of the youth in the community.

ADMINISTRATOR CLOSE – He re-iterated about the Route 46 bridge detour, the fireworks and the line-striping in the downtown area. He thanked the Housing Authority especially Maria Tchinchinian for the use of their community room as a cooling center, and also Aldermen Poolas, Delaney, Timpani and Blackman, who volunteered to work at the cooling center. He also noted the town is sharing services with the Borough of Wharton for paving Ford and Walnut Streets and Randolph for paving Ann and Glenwood Streets. Dover is only paying the cost of the asphalt; the other municipalities went out to bid the project.

ATTORNEY'S REPORT – Attorney Pennella noted that the Jersey City suit continues and the process is held up because the document production stage is much more massive than originally anticipated. He noted that disposition is pushed to September. Attorney Pennella noted that the tax appeals continue with about eight cases pending. He noted the three subordination requests on the agenda and explained that two requests are fairly standard. He noted that the Ruiz's request is different which requires an assumption of mortgage and then the subordination.

Mayor Dodd noted that there are two amounts \$34,000 and \$4,300 for 1998 & 1999 and wanted to know how a second loan could be issued if the first one was not paid. Attorney Pennella is not aware of the program procedures. Clerk Verga stated that when the program started residents could apply for more than one loan. Now it is one loan which does not exceed \$25,000.

<u>**BEATRIZ RUIZ**</u> – 306-308 E. Blackwell Street – Ms. Beatriz explained that the mortgage was transferred into her name because her mother was diagnosed with cancer. She expressed that she was unaware of the housing rehabilitation loans. She noted that she has been making the mortgage payments and would like to refinance to make additional repairs.

Commissioner's approval of the Ordinance.

5. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.

6. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

7. The Ordinance shall not take effect until it is approved by the Commissioner of Transportation of the State of New Jersey.

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

7. The Ordinance shall not take effect until it is approved by the Commissioner of Transportation of the State of New Jersey.

PUBLIC COMMENTS – Three Minutes per Person

<u>ANTONIO ACOSTA</u> – Mr. Acosta commended the fireworks in town and noted that they are the best in Morris County. Mr. Acosta stated that the property maintenance is not where it needs to be. He feels that the town is not connecting the dots and is embarrassed about some properties in his area. He noted that during previous conversations it was discussed that there would be inspectors canvassing the wards and suggested inspectors driving through town would get a better visual as opposed to walking. He suggested an action plan be implemented with zero tolerance and a better job has to be done.

JON SPERRY – 58 North Essex Street – Mr. Sperry wanted to know if the fines quadruple in the construction zone since Route 46 is considered a safe corridor. Attorney Pennella is not aware of any statues pertaining to the question.

<u>WILLIAM GILBERT</u> – 30 Linwood Avenue – Mr. Gilbert expressed that the fireworks and traffic flow were great. He noted that there were two letters to the editor in the paper noting Dover had the best fireworks. Mr. Gilbert stated his pet peeve is with bicycles tied to the trees, street lamps, and street signs and suggested bike racks for certain areas.

<u>LUIS GOMEZ</u> – 172 South Morris Street – Mr. Gomez filed a complaint with the Chief of Police regarding a police officer's comments and has not received a response. Mr. Gomez is looking for a phone call. Mr. Gomez wanted to know when the police department started, not accepting calls with blocked phone numbers. He expressed that people would not be able to make anonymous phone calls. Mayor Dodd expressed that he would have to look into the blocked phone numbers issue.

<u>WARREN DARNULC</u> – 151 Grant Street – Mr. Darnulc mentioned that the bicycle racks are mentioned in, what he believes, is the Historical District/Preservation Area. Mayor Dodd expressed that there are bicycle racks at the train station and at Crescent Field. Mayor Dodd noted that he will look into the ordinance regarding bicycle racks.

EDWARD CORREA – 88A E. Blackwell Street – Mr. Correa expressed that we are experiencing a worldwide economic crisis and there are deficits at all levels (budget, savings, trading and leadership deficits). He noted that at the local level in New Jersey we are also suffering a financial crisis. He noted that the crisis is due to many factors, one of them being a decade long law, known as the "home rule." He expressed that the issues should not to be blamed on teachers, police, firefighters or basic social service. He explained that the crisis is due to the "home rule" which allows New Jersey to be divided into 566 municipalities which created bureaucracy and redundancies. He expressed that NJ is one of the most corrupt states in the union. He noted that we are all victims of the "home rule" but must put individual agendas aside and strive for common and greater good for Dover and New Jersey as a whole. Mr. Correa commended the Mayor and Board of Aldermen for allowing Dover to become a part of

the regional core system with four municipalities (Municipal Shared Court Services) bringing savings to all. However, he wanted to know where are the savings? He referred to the articles about several lawsuits and noted that risk management is needed but wanted to know who is being held responsible. He wanted to know how individuals were paid, was it by the Joint Municipal Fund? Mr. Correa explained the increase differences between the Board of Education and Local Municipal Budget. He noted that the increase is affecting his complex because they are paying more in taxes and are paying for garbage collection. He wanted to know when the Town of Dover was going to reimburse Dover Park Plaza for the garbage collection expense.
