

TOWN OF DOVER MAYOR AND BOARD OF ALDERMEN

CAUCUS MEETING MINUTES July 27, 2010 7:00 PM

The Caucus Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

Mayor Dodd called the meeting to order at 7:00 pm

All joined in the Pledge of Allegiance to the Flag and prayer was given asking for guidance and strength to do what is right for our town and our citizens.

Mr. Edward Correa (88A E. Blackwell Street) announced that he will be videotaping the meeting.

Clerk Verga stated adequate notice was given to the official newspaper.

NEW APPLICATIONS FOR THE YEAR 2011 HOUSING REHABILITATION PROGRAM & PUBLIC FACILITY SMALL CITIES COMMUNITY DEVELOPMENT BLOCK GRANT

- Oak, Beech and Maple Street
- Rehabilitation of housing in targeted areas of the community

Mrs. Carol Hertweck-Lowy is representing the Town of Dover and will provide a presentation on the Small Cities Program that is offered by the State of NJ Department of Community Affairs (DCA), each year, with money that is funded by the US Department of Housing and Urban Development (HUD). She noted that the funding comes from the National Housing Act and specifically the Community Development Program and fortunately the Town of Dover has participated in the program for a number of years which has resulted in 31 completed projects. Tonight, Mrs. Hertweck-Lowey is reporting on the open projects and two additional grants that she will be seeking in the fall. She noted that handouts have been provided to the public; white copy explains the status information on the most recently awarded projects, blue copy speaks to the application course for street improvements which funding will be seek in 2011 and the yellow copy addresses the housing rehabilitation program which funding will also be seek in 2011.

Mrs. Hertweck-Lowy explained that there are two open street projects which include the streets (1) Segur, Sanford, Hinchman, Hoagland & No. Sussex off of Mt. Hope Avenue and the second project includes (2) Harrison, Harding, Taft & Wilson. She noted that the first project was awarded in January and needs to be completed by December 31, 2011. She expressed that the town will see the start of the project in spring 2011. She noted that Harrison, Harding, Taft, & Wilson Streets will be underway and optimistically completed in 2010. She explained that the Housing Rehabilitation Project that was awarded in 2009 has been completed and no further information is available because money has been spent. The project that was awarded in January 2010 will be starting and must be completed by December 31, 2011. She explained that, in each case, the Housing Rehabilitation Project seeks to assist 10 homeowners, that goal was reached in 2010 and the same will be addressed in 2011.

Mrs. Hertweck-Lowy explained that the blue handouts describe the Community Development Program and the types of programs that can be funded with federal money. She explained that the State of NJ is the regulatory for the funds and they have determined that the projects performed by Dover are basically housing rehabilitation and public facilities infrastructure. She noted that in the past, the town has traditionally sought funding for infrastructure projects. She noted that in fall they will be seeking funding for Oak, Beech & Maple Streetsfor road construction to bring them up to standard condition. She explained that the program is seeking a \$500,000 grant which requires a 10% match of \$50,000 which covers total administration, design and construction.

Mrs. Hertweck-Lowy explained that they are seeking funding for the Housing Rehabilitation Project which assists low to moderate income homeowners with repairs and maintenance issues for their dwellings. She noted that the program has a policy 1

that requires a lien on the property which can be as much as \$24,999 and it's a repayment with a zero interest at the time the property is sold or the deed is transferred. She noted that essentially when money is repaid, it is utilized to continue the program, as well as, to match the funding that is necessary under the state program regulations.

Mrs. Hertweck-Lowy noted that the public has the opportunity to comment, as well as, to write to the State of New Jersey (address can be found on the handouts).

Mayor Dodd noted that through Mrs. Hertweck-Lowy's efforts the Town of Dover has been very successful over the years in obtaining the grants with a lot of projects being completed. He commended Carol Hertweck-Lowy for her efforts and noted that many homeowners have benefited from the program.

Alderwoman Romaine wanted to know how many homes have been completed over the past years. Mrs. Hertweck-Lowey noted about 400 homes have been rehabilitated. She noted that anyone can apply, as long as, they fall within the income guidelines.

Mayor Dodd opened the meeting to the public for comments on the Small Cities Grants. Seeing no hands, hearing no voices Mayor Dodd closed the meeting to the public.

Alderman Donofrio noted that the program was introduced by Alderman Milonas and expressed that surrounding towns don't seem to avail themselves to the program. Mrs. Hertweck-Lowey noted that the board is a wise governing body.

PRESENTATION: NEW JERSEY HIGHLANDS COUNCIL

Eileen Swan, Executive Director and Thomas Borden, Deputy Executive Director & Chief Counsel provided a presentation to the public on the NJ Highlands Council. Ms. Swan pointed out that Alderman Visioli is a member of the Highlands Council and they are very fortunate to have him as a member.

Ms. Swan noted that it's extremely important to protect the Highlands Region because 5.4 mil residents receive their water from the region. Ms. Swan explained that the Highland Act was signed in 2004 and parts are in seven (7) counties and eighty-eight (88) municipalities in full. She noted that the Town of Dover does not fall within the preservation area.

Ms. Swan expressed that Dover is a leader in the Highlands Region and noted that she has spoken to other towns about what Dover is doing.

Ms. Swan provided information by describing the map that was available to the board and the public.

Mayor Dodd thanked Ms. Swan for the informative presentation. He noted the comment that Ms. Swan made, "that the Town of Dover is a leader in the region." He expressed the leadership is because of the true professionals that Dover has on staff like Town Engineer Michael Hanston and Administrator Bill Close. Mayor Dodd expressed that it's important to protect the region and commended them for their efforts. He expressed that they look forward to working with the Highlands Council.

Alderman Visioli thanked them for their input and efforts.

Alderman Donofrio wanted to know if added consideration would be given to town centers that subsequently lost there designation, which included Dover, if they are considered again.

REGULAR MEETING MINUTES July 27, 2010

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:53 pm

ROLL CALL

Present: Aldermen Visioli, Donofrio, Romaine, Blackman and Mayor Dodd Absent Alderman Delaney, Poolas, Picciallo and Timpani

Also present were Administrator Close, Attorney Pennella and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only.

<u>WARREN DARNULC</u> – 151 Grant Street – Mr. Darnulc commented that he didn't see the last meetings minutes on the agenda. Clerk Verga explained that the office was short on staff but minutes will be on the next meeting agenda.

MAYOR'S REPORT – Mayor Dodd commented that the traffic regarding the Route 46 detours is less than most people anticipated. He noted that traffic has been monitored during on and off-peak hours. Mayor Dodd recommended keeping the flea market in downtown area since it appeared there wasn't any difference in traffic without or without the flea market. He noted Morris County is okay with it. Mayor Dodd publicly thanked Prosecutor Bianchi and his staff for the wonderful presentation given to the children attending Dover's Recreation Program. Mayor Dodd noted that the Town of Dover will be reimbursed by FEMA for the March 2010's flooding (75% of the total expense). He commended the Office of Emergency Management regarding their efforts with the flooding and for reimbursement submission. Mayor Dodd reminded the public that Dover has merged with Victory Garden for fire and EMS services and read the statistical report regarding their calls. He announced that the 29th Annual Senior Citizen's Picnic will be held on September 2nd.

Alderwoman Blackman commented that everyone has worked really hard to get volunteers and donations for the Senior Picnic. She noted that Disc Jockey "Dr. J" will be donating his time for the picnic. She also attended the Ronald McDonald event at the library and found it to be very entertaining. She also commented the Dover Library has a lot of functions for the children throughout the summer. Mayor Dodd announced that on September 23 the Health Department will be hosting a Stroke Screening Clinic at Saint Clare's Hospital.

ADMINISTRATOR CLOSE – Mr. Close noted that a letter has been sent to the State of NJ appointing Richard Cloughley as the Interim Fire Official to replace Nicolas Best.

ATTORNEY'S REPORT – Mr. Pennella commented that there has been no change in status of any litigation. He's meeting with Certified Valuations, this week, to discuss pending tax appeals. He noted that about 50 tax appeals have been filed and expressed it's a large number.

ORDINANCES FOR FIRST READING

ORDINANCE No. 10-2010 OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER ESTABLISHING A ONE-WAY STREET ON DAVIS AVENUE AMENDING AND SUPPLEMENTING THE REVISED ORDINANCES OF THE TOWN OF DOVER, 1969, SAVED FROM REPEAL

Be it **ORDAINED** by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey that the Revised Ordinances of the Town of Dover, 1969, Chapter 38, G, entitled "One Way Street," Saved From Repeal under the Code of Dover is amended and supplemented as follows:

- 1. Pursuant to <u>N.J.S.A.</u> 39:4-197, there is hereby established a one way street at David Avenue northerly between the northerly side of the driveway at 2 Davis Avenue to Lemar Street.
 - 2. No Parking on Davis Avenue between the northerly side of the driveway at 2 Davis Avenue to Lemar.
- 3. This ordinance shall be submitted to the Municipal Engineer and he shall, under his seal as a licensed professional engineer, certify to the governing body of Dover that the sign and its placement have been approved by the engineer after investigation of the circumstances, and that it appears to the engineer to be in the interest of safety and expedition of traffic on the public highways and conforms to the current standards prescribed by the manual of the uniform traffic control devices for streets and highways as adopted by the Commissioner of Transportation, all as required by N.J.S.A. 39:4-8.
- 4. A certified copy of the adopted ordinance shall be transmitted by the Clerk of the Town of Dover to the Commissioner of Transportation within 30 days of adoption together with the certification of the Municipal Engineer, requesting the Commissioner's approval of the Ordinance.
- 5. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 6. ORDINANCE NO. 15-2010 OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY REGULATING VIDEOTAPING OF OPEN PUBLIC MEEETINGS BY MEMBERS OF THE GENERAL PUBLIC

Be it ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

Section 1. **Purpose**

Members of the general public have the right to videotape portions or all of an open public meeting of the governing body – excluding closed or executive discussions. These guidelines are intended to ensure that the right of the public to videotape official public meetings of the governing body does not interfere with the business of the governing body or other citizens' right of access to the proceedings.

Section 2. **Regulations**

To minimize the possibility of disrupting the public meeting of the governing body, any member of the public (a "citizen") who wishes to videotape portions or all of the public meeting must do so in accordance with the following guidelines:

- 1. The citizen must provide the Clerk of the municipality no less than five minutes verbal notice prior to the public meeting of his/her intention to exercise his/her right to videotape.
- 2. The citizen must have completed setup of his/her videotape recorded and any related equipment prior to the official start time of the public meeting. As to the location of the videotape recorder and equipment, the same may only be set up by the citizen in the rear of the meeting room, as such location will be specifically identified to the citizen by the Clerk.
- 3. The video recorder and any associated equipment utilized by the citizen must be compact, quiet, and generally unobtrusive. No more than one videotape recorder, and no added lights may be used by any citizen. The videotape recorder and all associated equipment may not take up more than three square feet of space. No citizen is permitted to use any videotape recorder or associated equipment that makes any beeping sounds or other noises. Should beeping sounds or any other noise emanate from the videotape recorder or associated equipment at any time during the public meeting, the citizen shall be required to cease videotaping immediately.
- 4. The citizen may not disrupt the public meeting with his/her recording equipment. The citizen may not set up or use the videotape recorder or equipment in such a way as to block or obstruct the view of other members of the public of the governing body proceedings. The videotaping by the citizen may only be done in a manner that does not violate the disorderly conduct ordinance, and must be generally orderly and unobtrusive. The citizen may not continually exist and re-enter the meeting room, or continuously move around within the meeting room, during the public meeting. The citizen may not "narrate" the proceedings, or speak into any videotape recorder or microphone. The citizen may not engage in any verbal conversation, discourse or comment whatsoever, unless the citizen is making a formal comment in his/her turn during any public comment portion of the public meeting.
- 5. If the citizen chooses to cease videotaping at any time during the public meeting, he/she may do so; provided that the citizen may not commence removal except for a hand-held videotape recorder, or begin to disassemble any videotape recorder or associated equipment until there is a break of at least five minutes of the public meeting or until the public meeting has concluded.
- 6. Upon request of the governing body of the Town of Dover, the citizen making the videotape shall immediately make available for copying the videotape disc or other devise used for recording which copying shall be at the expense of the municipality. The Municipal Clerk shall receive the original and shall return it no later than three business days after receipt.
- 7. The above regulations do not apply to ceremonial proceedings such as the distribution of sporting awards to children or young adults, presentation of proclamations, or other awards or honors.
- Section 3. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- Section 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
 - Section 5. The Ordinance shall take effect in accordance with law.

Mayor Dodd asked Alderman Donofrio if he wanted to explain to the public why he voted "no." Alderman Donofrio commented that the videotaping at the previous meeting didn't bother him and rather than creating laws that didn't seem to have a need to be created, he's not saying that the ordinance wasn't well crafted but it should be parked on a shelf until there's a need for such a thing. Alderwoman Romaine noted that it's important to recognize that in the ordinance there's a section that addresses ceremonial proceedings that have youth present. She expressed that even though she's not a parent, she wouldn't want her child videotaped at a public event without her written consent or permission. Attorney Pennella noted that ceremonial proceedings insert is directed to the parents and newspapers taking pictures of ceremonial events. He clarified that the ordinance recognizes the public's right to tape and to basically addresses it that's it's done in such a matter that it does not interfere with the proceedings.

PUBLIC COMMENTS – Three Minutes per Person

MARIA TAMBINI – 10 E. Blackwell Street - Ms. Tambini wanted to know if there is a theme for the Senior's Picnic. Alderwoman Blackman noted that she believes the theme with be the 50's (Oldies but Goodies). She noted that the library runs an ad in the "Out of Town" magazine, since it's free, with an itinerary of the children's events. She specifically noted that the Mayor fought hard for the residents of the Dover during the NJ Department of Transportation public hearing. Ms. Tambini thanked the Mayor and Board of Aldermen for the time they put into the town.

EDWARD CORREA – 88A E. Blackwell Street – Mr. Correa disagrees with many parts of ordinance 15-2010. He believes the energy and the time spent researching or drafting the piece of legislation should have been utilized in creating an innovative local open government policy that goes beyond what current law dictates, Open Public Meetings Act and Open Records Act (OPRA). He expressed that it is time to get innovative and it is time to utilize tools to inform the public. He agrees that there must be a space in noise restrictions, so the public is not disturbed. He wanted to know if the policy includes the members of the press. Attorney Pennella noted that the press can not videotape unless they follow the same ordinance. Mr. Correa expressed that the

town hall meeting videotaping is part of a solution and an answering to an old concern of many members of the community. He noted that the several community organizers have identified that there's a communication gap. He noted that the videotaping is a way to inform and give knowledge to the community. He noted that the resolution puts to many constraints and regulations. He noted that in this age of real time information, an innovative government, he believes that the resolution is a step back.

Mayor Dodd commented that the board has an obligation to create legislation when they see a need to protect the best interest of the public. He noted that the ordinance that was introduced for videotaping public meetings is in the best interest of the public. He explained that what the ordinance does is create regulations to prevent people from coming in with large lights, amplification, and/or be an annoyance. He explained that people come to the meetings to understand what's going on in the community not to be disrupted by someone that is videotaping a meeting. He noted that the video recorder that is on in the back of the room is perfectly fine. He noted that they are trying to prevent issues in the future and doesn't believe the ordinance prohibits anyone from videotaping. He believes the ordinance serves a purpose and he commends Alderman Visioli for introducing the ordinance and he supports it.

ED RIDNER – 33 Knickerbocker Avenue – Mr. Ridner wanted to know what happens if he doesn't want to be taped during a public meeting. Attorney Pennella stated that if someone chooses to speak at the meeting they are subject to public view. He expressed that if someone wishes to videotape a meeting they should advise the board and the public. Attorney Pennella explained that the ordinance requires the person video taping the meeting to notify the clerk and the original videotape must be given to the clerk. Mayor Dodd noted that he will announce, when he opens, the meeting that the meeting is being taped.

<u>KEITH BEST</u> – 57 North Beverick Road, Parsippany – Mr. Keith Best (brother of Nick Best) expressed a huge "thank you" to the town, police department and especially the fire department. He noted that they all went out of their way to provide anything that was needed. He appreciates the kind words and believes the board did the right thing by hiring the two firefighters, Nick had a lot of trust in the two people that were hired, and he knows it would make Nick proud. Mayor Dodd expressed that Nick was a valued employee in the town and will be greatly missed.

EDWARD CORREA – 88A E. Blackwell Street – He noted that by no means, form or shape did they intend to disrespect the public and noted that they are just trying to inform the community. He noted that many members of the community are not able to attend the town hall meetings. He reminded the public that the meetings are recorded by hardcopy, written meeting minutes where everyone's name and address are transcribed, as well, as audio recordings. He noted that what they are trying to do is to take government to the next level, to engage people, inform people here in Dover to what is going on in town. He explained that prior to his campaigning he noticed that people in the community want to be informed and noted that people can't get involved because of daily responsibilities. He noted that the video will be published on "You Tube" along with different tools to help people understand what is happening in the community. He extended an invitation to Mayor Dodd and Board to discuss ideas on how the community could be informed using new media and technology.

Alderman Donofrio asked Mr. Correa the name of his website. Mr. Correa expressed that the website is under construction but will advertise once it's completed. Alderman Donofrio wanted to know if he's looking to link the website to Dover's website. Mr. Correa noted that he would like too, with the Mayor's approval.
