REGULAR MEETING MINUTES August 14, 2007

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:11 pm

ROLL CALL

Present: Aldermen Delaney, Poolas, Ryan, Visioli, Picciallo, Timpani and Mayor Dodd

Absent: Aldermen Fahy and Donofrio

Also present were Administrator Garvin, Attorney Pennella and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for any items on the agenda

Kay Walker -72B East Blackwell Street spoke of issues regarding the ordinance pertaining to garbage pick-up and the effects on the East Blackwell Street condominiums. Mayor Dodd responded the governing body is trying to create consistency amongst all residents for garbage collection. Mayor Dodd mentioned other alternatives were discussed for the condominiums but to no avail. Mrs. Walker expressed that the condominium associations should have been included in the negotiations of the garbage contract.

Seeing no hands, nor hearing no voices, Mayor Dodd closed this session to the public.

Presentation by Steven Nicholl, Community Relations, from St. Clare's Hospital – Mr. Nicholl updated the town on the progress of the hospital and the renegotiation of the Aetna contract.

Mr. Nicholl also discussed the hospital searching for a national partner to aide in the operation of the hospital. Catholic Health Initiatives, 2nd largest Catholic health care system in the country, was chosen due to their similarity of the vision and mission of St. Clares' values and St. Clare's was comfortable with their management, structure and style. Local leadership will continue to run St. Clare's and the CEO will report to Catholic Health Initiatives, who are based in Denver, CO. Mr. Nicholl expressed that Dover General will be able to expand and bring in more programs, such as the Behavioral Health program moving in from Boonton.

Mayor Dodd commended Mr. Nicholl on the progress of the hospital and encouraged residents to tour the hospital. Alderman Fahy addressed the security issues for the Behavioral Heath program coming to Dover. Mr. Nicholl stated that the behavioral center is not a criminal behavioral center and measures will be taken to ensure security with renovations and upgrades. The delay in the move from Boonton is due to the 14-15 million dollar upgrades and renovations and the construction of the children's crisis center.

Mayor Dodd opened this portion of the meeting to the public on agenda items only.

Michael Cicchetti -130 S. Salem Street voiced his disapproval on the Catholic Health Initiatives merge with St. Clare's.

Seeing no hands, nor hearing no voices, Mayor Dodd closed this portion of the meeting to the public.

Administrator Garvin's Report – Administrator Garvin discussed that the administration has had several meetings regarding the water department operations and are looking into proposal to create one system. Administrator Garvin stated the East McFarlan Street Roadway Improvement project will commence tomorrow to create a one-way street.

Mayor Dodd's Report – Mayor Dodd expressed condolences to the Dunn family for the passing of Barbara Dunn, who donated the two dog statues in front of town hall. Mayor Dodd informed that Dial-A-Ride has expanded its services to go to the Farmer's Market on Thursdays from 4-6pm. Mayor Dodd received the Interim Report on the bridges in need of repair in NJ. The Route 46 Bridge is regarded in said report. Mayor Dodd sent a letter of concern to the Governor's office regarding the Route 46 Bridge to ask for inspections every 60 days in the interim until the construction begins in the summer of 2008. The Route 46 Bridge has

been rated a 17 which is extremely low in a deficiency rating.

Mayor Dodd asked the Town Engineer to review and report on all the town bridges in this report. Mayor Dodd asked the Administrator and Code Enforcement Department to review the 2-hour parking on E. Blackwell Street regarding complaints received that commuters are parking on the street near station.

Mayor Dodd announced that the case regarding the taxi companies from 6/12/2006 alleging unlawful discrimination on national origin selective enforcement based upon race has been dismissed for lack of probable cause. The investigation found when issues where brought to the Administration's attention efforts have been made to review the situation and correct if warranted.

ALDERMEN/COMMITTEE REPORTS

Alderman Patrick Fahy arrived at 7:15 pm and Alderman Donofrio at 7:35 pm.

Alderman Timpani – announced that the 2nd annual Employee Appreciation picnic will be held on 8/31/07 and the Dover Senior Citizens picnic will be on 9/10/07.

Alderman Delaney –stated that he is handling ward complaints

Alderman Fahy – thanked the Personnel Committee and Administrator for filling some of the vacancies at Town Hall (Tax Collector and Tax Assessor). Alderman Fahy attended the Salem Street Block party and expressed how these events build community spirit. Alderman Fahy stated he met with Pastor Martinez to go over ideas to benefit the communication and education of safety issues. Alderman Fahy reached out to the Board of Education to secure additional crossing guards for Salem Street Bridge area while under construction.

Alderman Visioli – sent an e-mail to the Dover/Victory Gardens Municipal Alliance Steering Committee regarding the meeting on 10/10/07 at Sacred Heart Parish Center for a drug and gang education seminar. Alderman Visioli stated the Department of Public Works and Dover Water Commission organization chart is being studied by the committee. Alderman Visioli also has been handling a sundry of issues in his ward.

Alderman Donofrio - No report

Alderman Ryan – stated residences of Claredon Terrace requested a review of the snow ordinance for that area.

Alderman Poolas—stated that the DPW downtown sidewalk sweeper has been out from 7am-2:30pm, different road repairs have been made and street sign replaced. Alderman Poolas attended the Dover Area Chamber of Commerce Board of Directors meeting to update the organization on town progress. Alderman Poolas stated that a committee should be formed for a town calendar and map. Alderman Poolas announced that Diane Worth is the new manager at Bassett Highway.

Alderman Picciallo – attended the Dover Renaissance concerts at JFK Park and commends the organization for their efforts and entertainment they secure for this event. Alderman Picciallo stated that our budget is on target and commended the department heads for monitoring their line items in their budgets. Alderman Picciallo also met with the superiors in the Police Department to inquire how the department functions to rely to the public on these functions.

Mayor Dodd asked the Administrator to have the taxi stands completed by 8/24/07. Mayor Dodd has received numerous written and verbal complaints regarding the Dover Diversity Day at JFK Park. Mayor Dodd expressed his displeasure regarding the agenda associated with this event having his name as a guest speaker without permission and the music played over the loud speakers with children present was unacceptable. Mayor Dodd stated that he will speak with the Recreation Commission to suggest not authorizing the use of our parks with such loud music and language is unacceptable.

Article 28 A entitled "Parking" is hereby amended and supplemented to permit parking on both sides of the street on East McFarlan Street between Conger Street and Perry Street except that there shall be no parking on the south side of East McFarlan Street beginning at a point at the southeasterly curb line intersection of East McFarlan Street and Jackson Avenue continuing in an easterly direction a distance of 265 feet which described area is hereby designated as a school bus pick up and discharge area.
- 2. This ordinance shall become effective upon the approval by the Commissioner of the Department of Transportation of the one-way designation of East McFarlan Street between Conger Street and Perry Street.
- 3. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
 - 5. The Ordinance shall take effect in accordance with law.

- A. East McFarland Street is hereby established as a one-way street eastbound between Conger Street and Perry Street. This ordinance shall take effect upon approval of the Commissioner of the New Jersey Department of Transportation.
- 2. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 3. RESOLUTION ADOPTING CORRECTIVE ACTION PLAN

WHERAS, the Chief Financial Officer has prepared a Corrective Action Plan for the findings and conditions;

NOW THEREFORE, it is hereby RESOLVED by the Mayor and Board of Aldermen that the following Corrective Action Plan be adopted:

DEPARTMENT - LIBRARY

Finding/Condition:

- 1. Vouchers were not prepared for disbursements from the Library account.
- 2 Overall, there appears to be inadequate control over incoming receipts. Prenumbered receipts are only issued for collections over \$1. Specifically, during audit procedures, it was discovered that there was \$101 of rolled coins that had been left in an employee's desk and not deposited as of the date of audit procedures.
- 3. The petty cash fund is not maintained at the authorized fund amount or closed out at year end.

Recommendation:

- 1. Vouchers be prepared for all disbursements from the Library account.
- Prenumbered receipts be issued for all collections; or, a cash register be obtained and utilized for all receipts. All funds should be kept in at least a locked cash drawer or a safe and should be deposited in a timely manner.
- 3. The excess in the petty cash fund be turned over to the fines and fees account. The petty cash fund be closed out at year end.

Explanation and Corrective Action:

- 1. Vouchers will be prepared for all disbursements from the Library account.
- 2. Consideration will be given to issuing pre-numbered receipts for all collections. Due to an oversight, the rolled coins were not deposited in a timely manner. More care will be taken in the future to ensure that all Library collections are maintained in a locked cash drawer and deposited in a timely manner.
- 3. The excess in the petty cash fund will be turned over to the fines and fees account and the petty cash fund will be closed out at year end in the future.

Implementation Date: 8/6/07

DEPARTMENT - MUNICIPAL COURT

Finding/Condition:

During the review of the Municipal Court records it was noted that the regular and bail bank reconciliations at December 31, 2006 contained miscellaneous reconciling items of \$1,640.46 and \$1,220.00, respectively. It was determined that these reconciling items were not valid so the bank reconciliations were adjusted to remove these items.

Recommendation:

Regular and bail bank reconciliations only contain valid reconciling items in the future. Additionally, all reconciling items should be resolved in a timely manner or written off.

Explanation and Corrective Action:

The general and bail journals are proven daily. The minor errors in reconciling seem to be with entries, or lack of, into the ATS/ACS System (i.e. refunds, reversals, etc.). Spreadsheets have been set up to help alleviate any future problems with reconciling and notes are being kept in journals regarding adjustments of any type. The General and Bail Accounts have been reconciled up to and including June 2007.

Implementation Date: 6/20/07

DEPARTMENT - MUNICIPAL CLERK

Finding/Condition:

Although the resolutions and ordinances for all 2006 meetings of the Mayor and Board of Aldermen were available for audit review, the formal typed and approved minutes were only available through June 2006. The Town had contracted with an outside service provider to prepare the formal minutes of the Town meetings.

Recommendation:

It is recommended that the older outstanding minutes be brought up to date and that the Town minutes be prepared on a timely basis in the future.

Explanation and Corrective Action:

Minutes were prepared by an outside service provider until the provider suffered an illness and could no longer provide services. A 7 month span passed before another outside service provider was contracted with.

The Town has hired an employee to assist with the Clerk's duties on June 4, 2007, which will enable minutes to be done in house and in a timely manner. All minutes will be prepared in a timely manner.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AUTHORIZING THE APPLICATION TO THE NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR THE 2007 STATE AID FOR MUNICIPALITIES PROGRAM

WHEREAS, the Town of Dover desires to prepare an application to the New Jersey Department of Transportation for the 2007 State Aid for Municipalities Program; and

WHEREAS, there is a need for roadway improvements including milling and paving, partial curb replacement, handicap access ramps and drainage structure upgrades on Thompson Avenue between Prospect Street and Chestnut Street; and

WHEREAS, the Town Engineer estimates that the total cost for the improvement is \$180,025.00; and

WHEREAS, the Town of Dover desires to seek \$130,000.00 from the New Jersey Department of Transportation under their State Aid for Municipalities Program; and

WHEREAS, the Town of Dover will fund the balance of the cost of the project with local money; and

Mr. Acosta stated that Hamilton Field needs to be updated. Mayor Dodd stated that there has been a meeting with Board of Education regarding this issue. The Board of Education is waiting on preliminary drawings on conceptual ideas for the field. Mayor Dodd stated that discussions were held to have a shared agreement for the field with the town, but the Board of Education would have to give up some ownership for the town to maintain the field.

Connie Sibona-Foster, 90 Penn Avenue, supported Mayor Dodd's decision to have the Recreation Commission not approve an event such as Dover Diversity Day. Mrs. Foster stated she would attend the next Recreation meeting due to the disappointment in the Dover Diversity Day. Mrs. Forster stated the name should be change to Dover Cultural Day.

Michael Cicchetti- 130 S. Salem Street stated he has issues with Mr. Mesmer comparing Parsippany with Dover in regards to the taxes on the apartment complexes.

Seeing no hands, nor hearing no voices, Mayor Dodd closed this portion of the meeting to the public.

Alderman Poolas stated there is a program called I.C.E. (In Case of Emergency) that can be placed on your cell phone contact list. You place in your contact ICE and the number of the person you wish to have called in an emergency. Alderman Poolas stated that he also is disappointed in the Dover Diversity Day and the person in charge from the Recreation Commission with this event should be removed from the board.
