

TOWN OF DOVER MAYOR AND BOARD OF ALDERMEN

CAUCUS MEETING MINUTES September 23, 2008 7:00 PM

The Caucus Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

Mayor Dodd called the meeting to order at 7:00 pm

All joined in the Pledge of Allegiance to the Flag and prayer was given asking for guidance and strength to do what is right for our town and our citizens.

DISCUSSION ON ORDINANCE #32-2008 REGULATING GARAGE SALES

Alderman Poolas commented on the ordinance of regulating garage sales. Alderman Poolas is in favor of this ordinance however he feels the town should not get in the business of selling garage sales signs. The ordinance should specify the specifications of the signs (ex. size and information about the garage sale, time limits of the posted sign) which should be followed but the town should not sell signs.

Attorney Pennella noted that signs specifications are not required for this ordinance. Some towns have garage sale ordinances but do not mention anything about signs.

Aldermen Visioli reviewed the ordinance and he's concerned with the enforcement of the removal of the signs. Garage Sales usually take place on the weekend when Code Enforcement employees are not on the job. The Police Department

would be the main department able to enforce this ordinance.

Mayor Dodd mentioned that the signs should specify the dates (start and completion of the garage sale) which are usually on weekends, then when Monday comes around Code Enforcement will be able to enforce the ordinance.

Attorney Pennella noted that some of the other property code provisions, where a notice of violation is given to the resident; which gives the resident an opportunity to remove the signs and if the signs are not removed a summons would be issued.

Alderwoman Romaine wanted to know how the public would be notified if the ordinance was approved. Mayor Dodd mentioned that it would be advertised in the newsletter.

Alderman Poolas commented on resolution #5, Approving Municipal License for Mambo's Café (Billiard Hall). Alderman Poolas is in favor of approving the billiard license. He noted that taverns in town have billiard & dart leagues. Billiard Halls help out in the lean months for paying the bills and he's against taking someone's livelihood away. The licenses are not cheap and he always thought pinball machines and billiard tables should not be restricted on the number that an establishment has, as long as it meets the fire department code so people can enter and exit the building safely. He feels that having a billiard hall is not detrimental to the town and believes in giving the person a chance. Billiard Halls have been trouble but you have to run them correctly just like anything else.

Alderwoman Romaine wants clarification on the diagram that was provided.

Mayor Dodd noted that representatives from Mambo's Café were present. He noted that he sat on the board a few years back when the billiard hall was discussed for Mambo's. There had been some concerns about the loud music and some issues that weren't done appropriately. Mayor Dodd still continues to receive complaints (loud music) and he will weigh his decision on the number of call made to the Police Department concerning Mambo's. Mayor Dodd is not against a billiard hall and he's not against anyone making a living. The establishment is in a residential neighborhood and it certainly affects the residents of that area; which weighs heavily on our decision whether or not to grant this license. Alderwoman Romaine brings a valid point regarding the layout. Mayor Dodd recalls having Mambo's in front of the board regarding the loud music and a vestibule was to be installed to prevent loud music from offending residential neighbors in that area. Mayor Dodd is curious to know if the vestibule was installed. Mayor Dodd needs input from the police department before he makes his decision.

Attorney Nelson Gonzalez represents Jhon Freddy Cardona, owner of Mambo's. The purpose of the application is to expand what Mambo's is offering more so than a restaurant. Mr. Cardona is trying to remove the aspect of the restaurant and provide two separate services. During the week it will be the gaming area which will be the pool hall. There will be a dividing wall with access to the gaming area only on weekdays and on the weekends it will continue to be the dance area that has been in operation for quite sometime. Mr. Cardona doesn't desire to mix both and given the competition for food and restaurants, it becomes quite lean in terms of maintaining the business. By offering the billiard tables, Mambo's will be

catering more to families who would enjoy a meal and they can now play pool and on weekends they can partake to the music.

Attorney Gonzalez commented on Mayor Dodd's concern about the vestibule. He explained that there is a vestibule with dual doors. You must enter through one set of doors that will bring you into a foyer and a second set of doors that will allow you into the dance floor. Mr. Cardona is mindful of the concerns of the board with regards to the complaints. He wants to taper off the concerns of the restaurant folks sitting around and allow them to partake in an activity. This will allow him not only to maintain his business in full service but also provide the gaming aspect. His idea is three billiard tables and his hopeful that he will be able to expand that but this is a work in progress. The restaurant business in town has taken a difficult turn given the economy and the make up of the town. Currently, it's very difficult to sustain a business just by way of the restaurant and dance area. Mr. Cardona would like to offer more. Mr. Gonzalez noted that complaints that have been levied in the past will not be the same complaints or will be diminished given the different complexion of the establishment assuming that the billiard tables are installed.

Mayor Dodd has a concern with Mr. Gonzalez's statements in the aspect that he feels that the complaints will be diminished. Mayor Dodd finds it odd that a restaurant environment will receive more complaints than billiard hall. Mr. Cardona's removing aspect of a restaurant and putting in billiard tables, Mayor Dodd feels that it would invite larger amount of complaints. His concern is that if it's a permitted use in that zone. Secondly, the conditions that where applied to the last application need to be reviewed. Mayor Dodd needs to have police and fire departments input, as well as construction and zoning officials' input, to know if a wall is built that it doesn't create a fire hazard for patrons in that restaurant. Mayor Dodd has a concern with the direct access exterior door which is ingress (in the sketch) to the billiard which then will open to the public on the front side of the building. Mayor Dodd noted that the permit will be contingent upon the comments that were stated. Mayor Dodd suggested that the resolution be tabled until the needed information is gathered to make a decision.

Attorney Nelson Gonzalez noted that the layout is just a sketch so that the board could have an idea as to what is proposed. If the board required further schematics it could be provided. Mayor Dodd noted that the construction or zoning department would require that information. Attorney Gonzalez also noted that appropriate security would be provided during the billiard and dance portion. Attorney Gonzalez noted that the billiard hall will be open from 2:00pm to 1:30am. Mayor Dodd asked if Mambo's intention was to remove the entire (kitchen) restaurant and turn it into a billiard hall. Attorney Gonzalez noted that the entire kitchen facility would be removed. The restaurant aspect would be completely abolished which would require a great deal of investment.

Attorney Pennella noted that if the permit for a billiard hall is approved, the ABC (liquor license) application would have to be amended because they require schematics to be attached to all their application. Attorney Gonzalez agreed that it will be their intent to notify ABC.

Alderman Visioli agreed with the Mayor's approach. He agreed that input from different departments will be needed prior to voting on the permit. Attorney Gonzalez noted that the complexion of the establishment will be changed however we don't want to create a hazard and they welcome the input from the different departments.

Alderman Donofrio noted that last time a pool hall was above the Harry Loorie Building it didn't have a liquor license. He's wondering if when the police review the application if they'll take into consideration whether or not the security would be ample enough for gambling occurring in that scenario. Attorney Gonzalez noted that gambling will not be allowed and security shall be provided to maintain the order of the establishment.

Alderman Timpani noted that the attorney mentioned that it will be a family oriented place. However, you're taking away the restaurant establishment and keeping the liquor and dancing, how is that a family oriented place? He explained that if you drive by the establishment the music could be heard from the vehicle and by taking the restaurant out which would keep it quiet could change things. Attorney Gonzalez noted that the music remains at a steady continuous tone and doesn't believe that the change of the establishment has anything to do with the music level.

Mayor Dodd noted that the request will be tabled until further information is gathered.

Mayor Dodd commented on the above resolution #16 - Committing to petition with a Third Round Affordable Housing Plan and to expend affordable housing trust fund monies on the development of a housing element & fair share plan. Awhile back the Town of Dover had entered into a professional service contract with Heyer Gruel to draft the fair share plan. Unfortunately, the State of NJ came out with Second-Third Round Ruling regarding COAH. The town stopped Heyer Gruel from drafting the share plan until the COAH Third Round came out. The Town is required by law to have a fair share housing plan and this is continuance of what was originally started. Alderwoman Romaine commented that Heyer Gruel was the consultant firm that did the Master Plan and they are extremely familiar with what the town has and what is

planned for Dover's future, so they'll be very knowledgeable with COAH.

Alderman Visioli will be abstaining from Resolution 7 & 8 (Raffle License for Sacred Heart).

Mayor Dodd noted that the board will break at 8:00pm to enter into executive session to discuss personnel issues and action may be taken at the conclusion of the meeting.

REGULAR MEETING MINUTES September 23, 2008

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:37pm

ROLL CALL

Present: Aldermen Fahy, Poolas, Visioli, Picciallo, Timpani, Romaine and Mayor Dodd

Absent: Alderman Delaney

Also present were Attorney Pennella and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only. Seeing no hands and hearing no voices this portion of the meeting was closed.

Mayor Dodd's Report – Mayor Dodd has been involved with personnel related issues, the committee continues to interview for the positions for DPW Director and Administrator. He commended Alderman Visioli and the personnel committee for their efforts. Mayor Dodd also has met with surrounding towns regarding shared services. He explained that many of the surrounding towns are in the same situation regarding fiscal constraints and noted that we need to look into different areas for cost savings to the taxpayers. Mayor Dodd and Alderman Poolas attended the Red, White and Blue Sunday event that was sponsored by the First Baptist Church of Dover-Rockaway. It was an event to honor local law enforcement officers, fire departments, EMTs and paramedics. He noted that Reverend John Hackworth does a phenomenal job with the First Baptist Church. Mayor Dodd noted that the Mayor & Board of Aldermen meeting minutes are up to date and commended the staff in the administrative office for working diligently. Mayor Dodd commended Attorney Pennella for his efforts regarding the taxi litigation; recently the town had a victory in the taxi case. He also thanked and complimented Captain Ugalde for his hard work with the taxi situation in the community. Mayor Dodd notified the public that the tax assessor will be in the office on Friday mornings and no longer on Thursdays. Mayor Dodd acknowledged that Carol Walker, a long time educator in the town has expressed interest and will be appointed to the Library Board. Mayor Dodd thanked the Mayor & Council of Victory Gardens for allowing the town to use their ambulance while Dover's ambulance is being repaired.

ALDERMEN/COMMITTEE REPORTS -

Alderman Fahy – He received complaints about King Field and the geese. There's also concern regarding the volleyball court location in Crescent Field and possibly securing another porta-potty due to the number of people in that area.

Alderman Picciallo – Last week, Alderman Picciallo addressed a garbage issue on Fairview Avenue regarding residents putting more than two bags out for pick-up. This morning Alderman Picciallo met with Bill Isselin, Don Costanzo, and a representative from Blue Diamond (solid waste hauler) to re-enforce the two bag limit per household. The representative of Blue Diamond will notify his employees about the two-bag rule. If more than two bags are put out on the curb, they will not be picked-up. If there's a severe violation, the board of health will be notified. If a resident needs to put out more than two bags a sticker can be purchased for \$2.50. Alderman Poolas received a request for the increase of the lumens for a street light on Baker and Fairview which has been forwarded to Luis Acevedo. Alderman Poolas and Alderman Picciallo have been addressing the issue on Davis Avenue/Rt. 15 regarding the request to turn it into a one way street. On September 30th, Attilio's Tavern will be starting a craft night once a month at Millpond Towers titled "Bridging the Gap". Alderman Poolas has been notified by the road superintendent that an area of Crescent Field has been cut down and that some citizens

had some concern regarding the JFK mulch which has been special ordered.

Alderman Poolas – Alderman Poolas complimented Club Colombia for always having a nice store-front window display. Alderman Poolas noted that North Highland Avenue and North Street is being developed by Mr. Doyle and he should be notified about the sidewalk that was taken out by the small box truck. He noted that these sections should be repaired immediately especially since it's near the school and children walk on them. Alderman Poolas acknowledge the Davis Avenue request for a one-way street. He attended the Red, White and Blue Sunday event. Complaint was received regarding Kings Field and the geese.

Alderman Donofrio – Alderman Donofrio received a complaint on Van Nostrand and Overlook regarding the erosion and the problem was remediated by the county.

Alderman Timpani – Alderman Timpani emailed DPW Street regarding some complaints regarding town property. Some of the issues were corrected however for the items that were not completed there were no explanations. Alderman Timpani mentioned that on Prospect Street and Warren Street the walking lights are not working. Alderman Timpani noted that the street lights on Blackwell Street are still not fixed. Mayor Dodd noted that JCP&L has been advised. Alderman Timpani commented that the street sweeper should not be going down the street every single day and it should be the owner's responsibility to maintain their property.

Alderman Delaney - Absent

Alderman Visioli – The work continues with JCP&L regarding the lumens being increase at the South Morris Street railroad crossing from 60 to 100 lumens. There has been some interaction with Randolph and Victory Gardens regarding some the replacement of fences, maintenance and housing issues. Alderman Visioli noted that the personnel committee has been very busy with the interviews and he complimented them for their efforts.

Alderwomen Romaine – Alderwoman echoed the same, that they have been conducting a interviews for the DPW Director and Administrator positions. She attended the Recreation Meeting and there was discussion regarding changes for next years summer recreation program, for example requiring permission slips for the children if they require leaving the grounds. Attorney Pennella noted that it would not be required since the children are free to come and go, the program is a supervised play area and not a day care facility. Other changes included program enhancements and possibly working with the Board of Education to use their media room.

Attorney Pennella Report – No additional comments to report, the Mayor reported on the taxi litigation.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AUTHORIZING DOVER CHILD CARE CENTER, INC. TO CROSS MUNICIPAL PROPERTY

WHEREAS, Dover Child Care Center, located at the corner of North Morris Street and Clinton Street in the Town of Dover, County of Morris and State of New Jersey, has been required by the New Jersey Department of Environmental Protection (DEP) to perform an investigation of ground water on its property; and

WHEREAS, the Town of Dover petitioned COAH for substantive certification of a third round Housing Element and Fair Share Plan on December 20, 2005; and

WHEREAS, pursuant to <u>N.J.A.C.</u> 5:94-6.2(c), a municipality under the Council's jurisdiction shall not spend development fees unless the Council has approved a plan for spending such fees and until the municipality has received substantive certification or a judgment of compliance; and

WHEREAS, on March 25, 2008, COAH issued a blanket waiver from N.J.A.C. 5:94-6.2(c) for municipalities with COAH approved development fee ordinances and an established housing trust fund account to allow the expenditure of up to 20 percent of housing trust funds prior to the grant of certification and/or approval of a spending plan, on the cost of developing a revised Housing Element and Fair Share Plan in accordance with COAH's new third round rules; and

WHEREAS, the waiver issued by the Council requires that the Town of Dover shall pass a resolution stating the current balance in the municipal housing trust fund account and the amount proposed to be spent on developing a Housing Element and Fair Share Plan in accordance with COAH's proposed third round rules, shall not exceed 20 percent allowed for administrative costs.

NOW THEREFORE BE IT RESOLVED by the Board of Aldermen of the Town of Dover, in the County of Morris, State of New Jersey, that the Town of Dover commits to petition COAH for substantive certification of a newly adopted Housing Element and Fair Share Plan in accordance with COAH's new third round regulations; and

PUBLIC COMMENTS – Three Minutes per Person

Mr. Palanchi – Address inaudible- Mr. Palanchi noted that on the ice cream trucks do not have garbage receptacles which should be noted when the ordinance is reviewed. Mr. Palanchi wanted to know on what side the crossing guard has to be stationed when crossing the children at the East Dover School. He noted that the crossing guarded should be stationed

nearest from where the children are exiting or entering. For example, when the children are walking towards the school the crossing guard should be on the eastside of Rt. 46 and when the children are exiting the crossing guard should be on the Westside of Rt. 46. Mayor Dodd noted that they will look into the matter. He also wanted to know how many times a person can receive a noise complaint until further action is taken. Mayor Dodd explained that it is police department's discretion. Attorney Pennella explained that the police will make an inquiry and ask the resident to reduce the sound level and if the resident complies they typically do not issue a ticket. However, if there has been repeated offenses they may charge but the officer do have some discretion to charge.

Antonio Acosta – 130 Madison Street – Mr. Acosta congratulated the town with the (taxi) judgment. Mr. Acosta has some concern with what he believes was once a baseball field behind Spruce Street. He noted that it's becoming an eyesore with the grass growing over the sand. He noted that a decision should be made if the field should be a baseball or soccer field. Mr. Acosta is concerned with the property maintenance and downtown aesthetics. He doesn't understand why it's so difficult to control and enforce the rules. He noted that there are numerous violations that are so clear and he doesn't understand why they are not addressed.

Connie Sibona-Foster – 90 Penn Avenue – Ms. Foster noted that the Salvation Army building (which is really not the Salvation Bldg.) has become an eyesore. She noted that if you pass by there on Sunday nights or Monday morning you can see the problem. People drop off huge bags of clothing and then others rip through it and the clothing is scattered all over the property. She asked if the town (code enforcement) could talk with them to solve the problem.

Seeing no hands and hearing no voices, Mayor Dodd closed this portion of the meeting.
