REGULAR MEETING MINUTES August 12, 2014

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:02 pm

ROLL CALL

Present: Aldermen Picciallo, Blackman, Rutan, Noriega, Yzarnotegui, MacDonald and Mayor Dodd

Absent: Alderman Visioli and Alderwoman Romaine

Also present were Deputy Municipal Clerk Maria Coppinger, Administrator Donald Travisano and Attorney Mason

Deputy Clerk Coppinger stated adequate notice was given to the official newspaper.

Mayor Dodd opened the meeting to the public on any agenda items.

Seeing no hands and hearing no voices, Mayor Dodd closed the meeting to the public.

MAYOR'S REPORT: Mayor Dodd mentioned the following in his report:

- Mayor Dodd welcomed our new administrator, Don Travisano and expressed that Mr. Travisano has his work cut out for him but he's confident that it will be accomplished.
- Mayor Dodd noted that they have a list of capital projects for 2014 and this year they will approach things differently. Typically, when streets are paved, it's usually done from top to bottom (curb, drainage, etc.). However, due to the harsh winter and a lot of streets in terrible condition, the town will focus more on milling and paving and will not perform curb and drainage repairs due to the cost. Next week, the engineer and assistant engineer will tour the town for streets in need of repair.
- There's a meeting on Thursday to discuss landscaping plans for Hurd Park
- Mayor Dodd noted that the equipment for JFK Park has been ordered and hopes to have it installed before the end of the year.
- A Request for Proposal (RFP) is currently available for a new soccer field at Crescent Field Park.
- A meeting with County Administrator Mr. John Bonanni has been scheduled to discuss some county issues.
- A meeting with a Risk Management Consultant has been scheduled.
- A meeting has been scheduled for a new message board for JFK Park and Town Hall (front entrance).
- Mayor Dodd mentioned the passing of previous board member and Mayor, Charles Whitehead. He expressed his thoughts
 and prayers to his family.
- Mayor Dodd welcomed Mr. Mike Obremski from Jersey Central Power and Light (JCP&L) and thanked him for all of his assistance.

Alderwoman Yzarnotegui reminded the public about the movie night on Friday.

CORRECTIVE ACTION PLAN

WHEREAS, THE 2013 Annual Audit of the Town of Dover, conducted by Nisivoccia LLP, contained certain recommendations requiring action; and

WHEREAS, these recommendations have been reviewed by the Town's Chief Financial Officer; and

WHEREAS, the Chief Financial Officer has prepared a Corrective Action Plan for the findings and conditions of the 2013 Audit;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover that the Correction Action Plan for the 2013 Annual Municipal Audit, hereto attached, is hereby approved and accepted; and

MUNICIPAL COURT

Finding/Condition:

There were instances in which funds were turned over to agencies after the 15th day of the following month.

Recommendation:

It is recommended that all funds be remitted to the agencies by no later than the 15th day of the following month in which the funds are collected.

Explanation and Corrective Action:

This occurred due to employee absences (vacations/illnesses). The Court will continue to get the checks out as soon as the reports are printed to avoid delays.

Implementation Date: 7/2014

LIBRARY

Finding/Condition:

- 1. Overall, there appears to be inadequate control over incoming receipts. Prenumbered receipts are only issued for collections over \$1.
- 2. The petty cash fund is not maintained at the authorized fund amount or closed out at year end.
- 3. A reconciliation of the bank account for the library was not performed on a monthly basis during the year.

Recommendation:

- 1. Prenumbered receipts be issued for all collections; or a cash register be obtained and utilized for all receipts.
- 2. The excess in the petty cash fund be turned over to the fines and fees account. The petty cash fund be closed out at year end.
- 3. Bank reconciliations be performed on a monthly basis.

Explanation and Corrective Action:

- 1. The library will be replacing its cash register, which had been damaged beyond repair in the microburst storm of 7/7/13. In the meantime, the library will continue to issue prenumbered receipts.
- 2. The library will close-out the petty cash fund at year-end, with any excess turned-over to the fines and fees account.
- 3. Bank reconciliations will continue to be done on a monthly basis.

Implementation Date: 7/30/14

Accounting Procedures

Clerk's receipts were not being deposited within the forty-eight hour statutory guideline.

It is recommended that all receipts be deposited within 48 hours for the Clerk.

Community Development Block Grant

Expenditure records for the Community Development Block Grant maintained by the Town of Dover do not agree with the records of the third party grant administrator.

It is recommended that all requests for reimbursements match the respective expenditure lines as they are charged in the accounting software.

The Town will reconcile the information provided to them by the third party grant coordinator, to ensure that all expenses are properly accounted for and are in agreement with the Town's accounting records.

RESOLUTION OF THE GOVERNING BODY CERTIFICATION OF THE ANNUAL AUDIT

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have an annual audit of its books, accounts and financial transactions, and

WHEREAS, The Annual Report of Audit for the year 2012 has been filed by a Registered Municipal Accountant with the Municipal Clerk as per the requirements of N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall, by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the Annual Audit entitled "Comments and Recommendations; and

WHEREAS, the members of the governing body have personally reviewed, as a minimum the Annual Report of Audit and specifically the sections of the Annual Audit entitled "Comments and Recommendations" as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB -52- to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

SECTION 4. The Ordinance shall take effect in accordance with law.

WHEREAS, the Town of Dover, New Jersey (the "Issuer") has previously issued one or more series of bonds, including in the past five (5) years pursuant to one or more preliminary and final official statements (collectively, the "Bonds"); and

WHEREAS, in connection with the issuance of such Bonds, the Issuer covenanted with Bondholders to provide certain secondary market information on an annual basis to the Nationally Recognized Municipal Securities Information Repositories (pre-2009) and to the Municipal Securities Rulemaking Board's Electronic Municipal Market Access Data Port (2009 to present) ("EMMA"), including, but not limited to, audited financial statements, municipal budgets, other financial and operating data and ratings changes; and

WHEREAS, the Securities and Exchange Commission (the "SEC") has recently focused attention on what it alleges is widespread failure of local government issuers across the nation to meet their continuing disclosure obligations and misrepresentation through material misstatements in an official statement (innocently, inadvertently or otherwise) of past compliance with continuing disclosure obligations; and

WHEREAS, in an effort to remedy these perceived issues, the SEC has implemented the Municipalities Continuing Disclosure Cooperation Initiative (the "SEC Initiative"), a limited-time program ending at 12:00 a.m. on September 10, 2014, that encourages issuers of municipal bonds, including the Issuer, to self-report possible material misstatements or omissions, made in the past five (5) years in an official statement regarding compliance with prior continuing disclosure obligations; and

WHEREAS, by participating in the SEC Initiative, issuers agree to accept certain non-monetary penalties, in lieu of unknown, and, by all accounts, hefty monetary and non-monetary penalties the SEC has threatened on issuers that do not participate in the SEC Initiative, should the SEC determine than an issuer has made material misstatements in an official statement regarding compliance with prior continuing disclosure obligations; and

WHEREAS, by participating in the SEC Initiative, issuers agree to accept the following penalties, if imposed by the SEC (i) compliance with a cease and desist order in which the issuer neither admits nor denies the findings of the SEC, (ii) implementation of policies, procedures and training regarding continuing disclosure obligations, (iii) compliance with all existing continuing disclosure undertakings, (iv) cooperation with any further SEC investigation, (v) disclosure of settlement terms in any final official statement issued within five years of the date of institution of the proceedings, and (vi) production to the SEC of a compliance certificate regarding the applicable undertakings on the one year anniversary of the proceedings; and

WHEREAS, on July 24, 2014, the Division of Local Government Services issued Public Finance Notice (i) alerting New Jersey local governments to the SEC Initiative, (ii) strongly recommending that local governments examine their continuing disclosure contractual obligations and past official statements in order to determine if it is advisable for an issuer to participate in the SEC Initiative and (iii) cautioned that local governments that fail to complete a disclosure assessment in connection with the SEC Initiative will likely have difficulty accessing capital markets, difficulty in receiving timely approvals of the Local Finance Board or Director of the Division of Local Government Services, as applicable, and decreased scores on the future "Best Practices Questionnaires"; and

WHEREAS, the Issuer desires to conduct a disclosure audit which will (i) summarize the results of the Issuer's prior compliance with its secondary market disclosure obligations and (ii) compare those results to the statements made by the Issuer in its official statements regarding past compliance (the "Disclosure Audit"); and

WHEREAS, the Issuer further desires to retain the services of disclosure specialist to conduct the Disclosure Audit; and

WHEREAS, based on the results of the Disclosure Audit, and weighing heavily the known, non-monetary penalties that may come through the Issuer's participation in the SEC Initiative versus the unknown, and, by all accounts, hefty monetary and non-monetary penalties the SEC has threatened on issuers that do not self-report, the Issuer further desires to delegate to the Chief Financial Officer, in consultation with the Issuer's general counsel, bond counsel, auditor and other finance professionals, the power to prepare and submit all documentation required to enter the Issuer's Bond issues into the SEC Initiative, as necessary;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE ISSUER, AS FOLLOWS:

- **Section 1.** The Issuer hereby authorizes completion of the Disclosure Audit.
- **Section 2.** The Issuer hereby authorizes the Chief Financial Officer to engage the services of a disclosure specialist to complete the Disclosure Audit; provided that the award of any contract in connection therewith meets the requirements of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.).
- <u>Section 3.</u> In the event the Disclosure Audit reveals that the Issuer <u>may</u> have made a material misstatement regarding the Issuer's compliance with prior continuing disclosure undertakings, the Issuer hereby authorizes and directs the Chief Financial Officer to prepare and submit all documentation necessary to enter the Issuer's applicable Bond issues into the SEC Initiative.
- **Section 4.** Any action taken by the Chief Financial Officer, or any other officer of the Issuer, with respect to the Disclosure Audit, the engagement of a disclosure specialist and participation in the SEC Initiative is hereby ratified and confirmed.

Section 5. This resolution shall take effect immediately.
