RESOLUTION TO PROVIDE FOR THE MANDATORY DIRECT DEPOSIT OF NET PAY FOR ALL EMPLOYEES

WHEREAS, P.L. 2013, Chapter 28, approved March 12, 2013, addresses the concerns for the use of State, county, county college, municipal and school district employee compensation; and

WHEREAS, on or after July 1, 2014 this act allows for a municipality to adopt a resolution to provide for the mandatory direct deposit of net pay for all employees of the municipality. Compliance by an employee shall be mandatory. This act allows for an exemption for seasonal and temporary employees.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris, State of New Jersey, that mandatory direct deposit of net pay for all employees of the municipality shall be required. An exemption shall be granted for seasonal or temporary employees.

RESOLUTION OF THE TOWN OF DOVER FOR THE APOINTMENT OF IMAC INSURANCE AGENCY LLC AS RISK MANAGEMENT CONSULTANT

WHEREAS, the Town of Dover is a member of the Municipal Excess Liability Joint Insurance Fund, (hereinafter known as the MEL), a public entity established under Public Law 1983, c.372 of Title 40A enabling local contracting units to join together for the purpose of self-insuring for excess coverage's as defined by statute; and

WHEREAS, the Bylaws of the MEL provide for appointment of a Risk Management Consultant by the municipality or authority to advise the municipality or authority on matters relating to the MEL's operation and coverage's provided; and

WHEREAS, the Risk Management Consultant's specific duties include, but are not limited to:

- 1.) Evaluation of the town's or authority exposure
- 2.) Explanation of the various coverage's available from the MEL and assisting the municipality or authority in the selection of proper coverage.
- 3.) Preparation of applications, statement of values, etc., required by the MEL
- 4.) Review of the town's or authority's assessment and assisting in the preparation of the town's or authority's insurance budget.
- 5.) Review of losses and engineering reports and providing assistance to the town's or authority's safety committee
- 6.) Assistance in the claims settlement process.
- 7.) Attendance at the majority of meetings of the MEL's Commissioners/Board of Fund Commissioners and the performance of such other services as required by the municipality or authority of the MEL.

WHEREAS, the Bylaws of the MEL further provides for said Risk Management Consultant to be paid a fee of six percent (6%) of the municipality's or authority's assessment for the current fund year; and

WHEREAS, the Bylaws of the MEL allows a member municipality or authority to waive such services and elect to perform all or any portion of the duties normally assigned to the Risk Management Consultant provided it notify the MEL in writing and further agrees to indemnify and hold harmless the MEL and certain of its agents.

WHEREAS, the municipality wishes to contract with the Risk Management Consultant itself and pay same directly.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Dover elects to have its six percent (6%) fee for Risk Management Services returned by the MEL, if applicable;

RESOLUTION ACCEPTING OWNERSHIP AND MAINTENANCE OF THE TRAFFIC SIGNAL KNOWN AS "TRAIN PREEMPTION FOR TRAFFIC SIGNALS NORTH II" INSTALLED BY THE NEW JERSEY DEPARTMENT OF TRANSPORTATION AND LOCATED PROXIMATE TO THE INTERSECTION OF E. DICKERSON STREET AND S. MORRIS STREET

WHEREAS, the County of Morris and the New Jersey Department of Transportation ("NJDOT") have embarked on a project to improve the flow of traffic and to create safer pedestrian crossings near the railroad right-of-way on S. Morris Street; and

WHEREAS, the full cost of the project will be borne by the County of Morris and NJDOT and said improvements will result in a direct benefit to the residents of the Town of Dover and to those passengers who utilize the Dover train station; and

WHEREAS, in order for this project to proceed, it is required that the Board of Aldermen of the Town of Dover accept ownership and maintenance of the traffic signal designated in the title of this Resolution; and

WHEREAS, the project plans are on file in the offices of the municipal clerk and the municipal engineer;

NOW, THEREFORE, BE IT RESOLVED that the Town of Dover hereby accepts ownership and maintenance of the traffic signal known as "Train Preemption for Traffic Signals North II" installed by the New Jersey Department of Transportation and located proximate to the intersection of E. Dickerson Street and S. Morris Street, as set forth in the plans for construction on file in the offices of the municipal clerk and municipal engineer.

RESOLUTION AUTHORIZING THE TOWN ADMINISTRATOR TO REQUEST

PERMISSION FROM THE ADMINISTRATIVE OFFICE OF THE COURTS TO COMMENCE THE COMPETITIVE CONTRACTING PROCESS FOR THE PURPOSES OF ISSUING A REQUEST FOR PROPOSALS AND SELECTING A QUALIFIED ENTITY FOR PRIVATE COLLECTION OF DISTRESSED MUNICIPAL COURT DEBT PURSUANT TO L. 2009, C. 233 AND ONCE PERMISSION IS RECEIVED, TO COMMENCE THE COMPETITIVE CONTRACTING PROCESS.

WHEREAS, pursuant to N.J.S.A. 40A:11-4.1, the Local Public Contracts Law, the Town of Dover desires to begin the competitive contracting process in order to issue an RFP and to select a qualified entity to for private collection of distressed municipal court debt as authorized by L. 2009, C. 233; and

WHEREAS, prior to the release of an RFP, the Town of Dover must receive permission from the New Jersey Supreme Court Administrative Office of the Courts to commence said process; and

WHEREAS, this process should result in increased revenue to the Town of Dover with no capital outlay; and

WHEREAS, this authorization is only to commence the process and selection of an entity to collect the debt, once permitted by the AOC, must be done by future action of the governing body;

NOW, THEREFORE, BE IT RESOLVED that the Town Administrator is authorized to request permission from the New Jersey Supreme Court Administrative Office of the Courts to commence the competitive contracting process for the purposes of issuing an RFP and selecting a qualified entity for private collection of distressed municipal court debt pursuant to L. 2009, c. 233;

BE IT FURTHER RESOLVED that upon permission of the AOC, the Town Administrator, pursuant to N.J.S.A. 40A:11-4.1, the Local Public Contracts Law, will issue an RFP and begin the competitive contracting process in order to select a qualified entity for private collection of distressed municipal court debt;

BE IT FURTHER RESOLVED that selection of the qualified entity to collect the debt shall be done by future action of this Honorable Body.
