

WARD No. 3
Town of Dover
Morris County, New Jersey

Beginning at the most westerly corner of Ward No. 3, said point being the intersection of the centerline of Penn Avenue, a 50-Foot Wide Right-of-Way, with the common municipal line with Randolph Township, Morris County, and from said point of beginning running, thence

Along the various lines with Ward No. 2, the following six (6) courses;

- 1) Northeasterly along said centerline of Penn Avenue to the intersection with the centerline of Madison Street, a 45-Foot Wide Right-of-Way, thence
- 2) Northwesterly along said centerline of Madison Street to the intersection with the centerline of Academy Street, a 40-Foot Wide Right-of-Way, thence
- 3) Northeasterly and easterly along the centerline of Academy Street to the intersection with the centerline of Second Street, a 40-Foot Wide Right-of-Way, thence
- 4) Southerly along said centerline of Second Street, a 40-Foot Wide Right-of-Way, to the intersection with the centerline of Byram Avenue, a 40-Foot Wide Right-of-Way, thence
- 5) Easterly along said centerline of Byram Avenue to the intersection with the centerline of South Morris Street, a.k.a. Morris County Route No. 643, a Variable Width Right-of-Way, thence
- 6) Northerly along said centerline of South Morris Street to the intersection with the centerline of East Blackwell Street, a 75-Foot Wide Right-of-Way, thence

Along the various lines with Ward No. 4, the following five (5) courses:

- 7) Easterly along said centerline of East Blackwell Street, a 75-Foot Wide Right-of-Way, to the intersection with the centerline of Mercer Street, a 50-Foot Wide Right-of-Way, thence
- 8) Northerly along said centerline of Mercer Street, a 50-Foot Wide Right-of-Way, to the intersection with the centerline of Richards Avenue, a 50-Foot Wide Right-of-Way, thence
- 9) Easterly along said centerline of Richards Avenue, a 50-Foot Wide Right-of-

- Way, to the intersection with the centerline of North Salem Street, a 40-Foot Wide Right-of-Way, thence
- 10) Southerly along said centerline of North Salem Street, a 40-Foot Wide Right-of-Way, to the intersection with the centerline of East Blackwell Street, a Variable Width Right-of-Way, thence
 - 11) Easterly along said centerline of East Blackwell Street, a Variable Width Right-of-Way, to the intersection with the municipal line with Rockaway Township, Morris County, thence
 - 12) Southerly along said municipal line with Rockaway Township and continuing along the municipal line with Randolph Township, Morris County, to an angle point in said municipal line, thence
 - 13) Southwesterly along said municipal line with Randolph Township and continuing along the municipal lines with the Borough of Victory Gardens and Randolph Township, Morris County, to an angle point in said municipal line, thence
 - 14) Westerly along said municipal line with Randolph Township to the point and place of beginning.
