Ordinance 2-2007

Alderman Ryan asked what the advantage is for amending Section 2-8 of the Town of Dover Code. The Mayor stated this board would have more authority and oversight on spending, for which he thinks double over-sight is an advantage.



Alderman Donofrio asked what other towns were doing. It was answered that it depended on the form of government.

Alderman Ryan asked if there were any other changes.

Mayor Dodd stated the Administrator or appointing authority may only hire, fire and give pay increases or promotions with this board's approval.

Alderman Donofrio asked if these were the powers that Paul McDougall had. Mayor Dodd answered that the process has been looked at for a couple of years now.

Alderman Poolas asked if we could look into having uniform containers for garbage and recycling and if necessary add this to the bid for solid waste and recycling removal. That would stop the hauler from picking up more than two bags, which they do now.

Mayor Dodd said he met with the MUA and posed the same question and the containers would have to be supplied by the municipality at a cost of \$10.00 per container.

Alderman Donofrio asked if we could revisit the cost for a town wide cleanup.

Mayor Dodd stated he is not of the opinion that senior citizens should have to pay for multi-house pick-ups at a cost of \$50 to \$100 per house.

Alderman Donofrio feels other reasons far outweigh that.

Alderman Poolas commented residents are allowed to go to the transfer station three times per year and pay by the ton just like the town does.

Mayor Dodd appointed a committee to go over the bid specs with Asst. Engineer William Isselin to include Alderman Visioli (Chair), Alderman Donofrio and Poolas.

Aldermen Fahy and Donofrio questioned if we should put a cap on the amount we would have to pay Joseph Maraziti, Esq. and David Roberts, Planner for the Bassett Highway Redevelopment Project.

Mayor Dodd explained the developer would have to put money in an escrow account for which Dave Roberts gave an estimate. The professionals would be paid out of that account at no cost to the tax payers.

ORDINANCE(S) FOR INTRODUCTION

ORDINANCE NO. 01-2007 OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AUTHORIZING AWNING ENCROACHMENT FOR BLOCK 2017, LOT 16

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover County of Morris and State of New Jersey as follows:

- 1. There is hereby approved, pursuant to <u>N.J.S.A.</u> 40:67-1, the installation of an awning being 22 feet in length, 42 inches high and 24 inches in depth, which awning encroaches into the public right of way along King Street for property known as Block 2017, Lot 16 as shown on the tax maps of the Town of Dover and also known as 145 King Street, Dover, New Jersey.
 - 2. The awning must be of canvas or cloth material and may not be plastic.
- 3. An application must be made to the Uniform Construction Code Official for a Building Permit and the Zoning Officer for a Zoning Permit, and is subject to conforming with the Uniform Construction Code and Zoning Ordinance.
- 4. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
 - 6. The Ordinance shall take effect in accordance with law.

ORDINANCE 02-2007 OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AMENDING AND SUPPLEMENTING SECTION 2-8 OF THE CODE OF THE TOWN OF DOVER

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

- 1. Section 2-8, G is amended and supplemented as follows:
- G. Powers and Duties
- (1) The Administrator shall be the chief administrative officer of the Town, and shall be responsible to the Mayor and Board of Aldermen for the proper and efficient administration of the affairs of Dover. The Administrator shall be accountable to the Mayor and Board of Aldermen. The Administrator shall answer all questions posed by the Mayor or Board of Aldermen in a timely fashion. In addition to reporting to the Mayor and Board of Aldermen at all meetings, the Administrator shall keep the Mayor fully and promptly advised of all municipal business.
- (2) The powers and duties of the Municipal Administrator shall include the following. The Administrator shall:
- (a) Supervise and be responsible for the activities of all municipal departments, boards and agencies of government.
- (b) Submit a budget for the calendar year to the Mayor and Board of Aldermen by the second week in January or on such alternate date as set by the governing body. In preparing the budget, the Administrator shall obtain from the head of each department, agency, board or officer estimates of revenues and expenditures and other supporting data as needed. The Administrator shall review and approve such estimates and may revise them before submitting the budget to the Mayor and Board of Aldermen for amendment and final approval.
- (c) Upon the approval of the Mayor and Board of Aldermen, hire and, when necessary for good cause, suspend or discharge any employee under the Administrator's supervision; provided that persons shall be hired, suspended or discharged in accordance with provisions of civil service (where applicable). No person shall be discharged without just cause, and the discharged employee shall have the right to appeal such discharge to the Mayor and Board of Aldermen. The Administrator may also, subject to the approval of the Mayor and Board of

Aldermen, promote an employee or increase an employee's salary within the range established by the Mayor and Board of Aldermen by Salary Ordinance.

(d) Supervise purchasing and see that goods and services are properly purchased for the departments, boards and agencies of the Town. The Administrator shall also

establish and enforce rules and regulations governing the requisition and purchase of all municipal supplies, equipment and services. The Administrator shall, before making any purchase of goods or services over One Thousand Dollars (\$1,000.00), obtain the approval of the Finance Committee of the Mayor and Board of Aldermen. Such approval may be obtained electronically or by a meeting of the committee. Following the purchase of any goods or services under an emergency purchase, the Administrator must notify the Finance Committee within 24 hours of the nature and amount of such purchase.

- (e) Hold such other municipal offices or head one or more of the municipal departments as the Mayor and Board of Aldermen may from time to time direct.
- (f) Attend all meetings of the Mayor and Board of Aldermen and its committees with the right to take part in the discussion.
- (g) Keep the Mayor and Board of Aldermen informed as to the conduct of Town affairs and the condition of Town finances and such other reports as the Mayor and Board of Aldermen may request. The Administrator shall make recommendations to the governing body as the Administrator deems necessary or as requested by the Mayor and Board of Aldermen.
- (h) Be responsible for continually improving communications among all Town employees, departments, agencies, boards, the Mayor and Board of Aldermen and the community as a whole (i.e. Chamber of Commerce and other service groups). The Administrator will constantly try to upgrade the image of the Town of Dover.
- (i) See that terms and conditions imposed in favor of the Town or its inhabitants in any statute or contract are faithfully kept and performed and, upon knowledge of any violation, call the same to the attention of the Mayor and Board of Aldermen.
- (j) Continually review and supervise the Town's insurance program and work with the person or people designated by the Mayor and Board of Aldermen as the representative for Dover to the Joint Insurance Fund, the health insurance fund and the municipal excess fund, so as to obtain the lowest possible rates and adequate coverage.
- (k) Be responsible for the overall supervision and maintenance of real property owned by the Town of Dover.
- (l) Act as liaison between the Town of Dover and the various county, state and federal agencies, with respect to all applications for funds and/or services needed or required by the Town of Dover.
- (m) Review daily any complaints concerning the functions and obligations of the Town of Dover made by any of its residents or the Mayor or Board of Aldermen and have a permanent record of complaints and the disposition made.
 - (n) Negotiate all collective bargaining agreements for the Town of Dover
- (o) . At a minimum on an annual basis, review, organize and updated as needed all ordinances, policies and procedures. All changes to policy and procedures shall be subject to the approval of the Mayor and Board of Aldermen.

- (p) Perform such other duties as may be assigned from time to time by the Mayor and Board of Aldermen
- 2. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
 - 4. The Ordinance shall take effect in accordance with law.
