PRESENTATIONS, MUNICIPAL CORRESPONDENCE

The Board of Aldermen then received the below correspondence.

- 1) Correspondence from JIF 2020-2021 Elected Officials Risk Management Seminar: Employment Practices Liability
- 2) Correspondence from Mayor Carolyn Blackman nominating John O. Bennett III to be Administrator of the Town of Dover / Presentation of Nomination

Mayor Carolyn Blackman stated the Town had been asked by the public to interview candidates for Business Administrator position and hired a firm to assist the Town. Both of these actions took place. The Town ran an ad and turned over all the applicants that were received to the firm to help us get the best candidate. She recognized Joe Hartnett from Government Strategies Group. Mr. Hartnett introduced himself and explained his background. He was appointed the youngest Administrator in the country at age 26 and retired in 2011 as the Administrator in Montclair, then worked as Vice President for St. Peter's University. He provided a summary of the work that was performed with preparing and placing the ad, reviewing and vetting perspective applicants. In addition to advertising, the firm also reached out directly to people in the profession who may have had an interest in the Dover position. Once that was done, they reviewed carefully the resumes, qualifications, ran background checks and conducted interviews.

The firm narrowed the field to three candidates which included the Interim Business Administrator and assisted the search committee in arranging and conducting interviews. Before making a final decision they met with a cross section of community leaders to give input as to the qualities and qualifications they thought were important. Those community leaders provided interesting and valuable input.

The final recommendation of the firm was John O. Bennett. Mr. Harnett described Mr. Bennett's credentials as impeccable and he also had familiarity with the Town of Dover. Additionally, his qualifications were unmatched although other candidates were strong as well. Mr. Hartnett noted that several of the community leaders issued high praise for Mr. Bennett and the work he has been doing during interim period.

He stated that it always comes down to the best fit, and he does not hesitate to recommend Mr. Bennett.

Mayor Blackman thanked Mr. Hartnett for his report. The Mayor said she works with John Bennett closely every day and one thing I can say he has restored employee morale. The Mayor said that he has worked with the Department heads to help them multitask with budget planning, infrastructure and vehicles. Mr. Bennett made them to be part of the process and asked them to be part of the process. She also highlighted the fact that he holds weekly meetings with Department Heads. The Mayor highlighted some other things which Mr. Bennett has done included updating our Civil Service list and that since he has been here he has worked in building good working relationships.

Alderwoman Wittner, stated that she can admit when she is wrong. She stated that Mr. Bennett has proven he is the best Administrator for Dover and that she has seen the morale of the Town

change and more open communication, of which she has been a part of. She stated that the Town of Dover is fortunate to have him.

Alderwoman Rugg commented that it has been a pleasure to get to know and work with Mr. Bennett, particularly in securing a Public Health Nurse. She said Mr. Bennett is always thinking of the Town.

Alderwoman Cruz stated that she is very happy with what Mr. Bennett is doing and that he has been doing a good job. She supports the nomination and wants to see the Board achieve and finish what has been started.

Alderman Quinones spoke about working with Mr. Bennett on a few things in the past few weeks and stated that Mr. Bennett is an incredible person who works, but makes others work as well. He stated that Mr. Bennett care for something he cares about, which is the children, particularly on fixing up the parks so that we can see kids have fun. Alderman Quinones stated that he is glad Mr. Bennett is on the team.

Alderman Valencia commented that when he first met Mr. Bennett he liked his experience and believes that he has a lot qualities and finds solutions for most everything presented to him. He hopes that the Board votes for him and if so wishes Mr. Bennett all the best of luck.

Alderman Correa recounted that the Board took a lot of heat for appointing Mr. Bennett and that some were called phony Democrats. Now after 7 months and going through a process, which was promised, was implemented with reviewing resumes, holding interviews and listening to the community. He stated that he believes Mr. Bennett is the most qualified person for our Town and thanked Mr. Bennett for his efforts and looks forward to working with him in the future.

Mayor Blackman also thanked the public for meeting with the search committee. She stated that the community leader's expectations were high and that they wanted someone with experience, leadership and someone who can work with anybody.

Alderman Correa stated that he wants members of the community to know that they are for Cannabis and care about the industry. He stated that the Board is for it but that they want to do it right.

NEW BUSINESS

The first item of New Business was the Introduction of the Budget. Administrator Bennett and CFO John Gross provided an overview of the budget. It was stated that revenues decreased last year by about \$1 Million and Salary and Wages under existing Collective Bargaining Agreements made in the past are increasing by \$1 Million. The Administration and the Finance Committee has been able to significantly cut the tax increase to under 4%. It was also commented that the Town of Dover turned the tide on borrowing and debt payments by passing Res. 107-2021. The Town cut the debt by \$15 Million from a ratio of 3% which is amount to a shutdown to borrow anymore to a safe rate of 1.76%.

Mr. Gross has been a Mayor, Administrator and CFO and that he understands the importance of developing a budget with the importance of the community in mind.

Mr. Gross stated that when he got a call to come to Dover 7 months he did not know what to expect. He stated that Dover had many unique challenges and that it has been his pleasure to work with the Senator Bennett, the Mayor and the Finance Committee.

Mr. Gross also highlighted the budget. It was answered that the average assessed property would see an increase of about \$120.00. Alderwoman Wittner asked what the tax increase for the Municipal Budget was in 2020. Mr. Gross stated that it was 6.6%. Alderwoman Wittner stated that this year is a smaller increase. Alderman Correa asked what the pension costs increase was. Mr. Gross said pension costs are up \$450,000. Other drivers of the budget are Police and Fire Salary and Wages. Mr. Gross said our budget roughly has 98 lines. 38 lines stayed the same, 38 went down and only a few went up, but they were significant.

Alderman Ballesteros asked if lost revenue impacted the Budget. Mr. Gross said lost revenue did have an impact. It was also commented that some of the Union Contracts had two years of 0% raises and last year and this year had 4% raises. Mr. Gross said not only did individuals get 4% raises but because of step increases, a number of salaries are up 10%. Mr. Gross also said that future contract negotiations are going to be critical but the current contracts that began in 2018 are impacting us.

The Budget was Introduced (Res. 108-2021) was approved 8-0, with Alderman Valencia not voting due to technical issues.

Administrator Bennett provided a report to the Board. He reported that all library employees except the Director and a Recreation Department employee is on furlough. He also reported that our COVID-19 numbers are stable and another 20 residents have been vaccinated.

Senator Bennett also reported that construction on the DPW Interior Renovations are beginning next week and the upcoming cleanups in the Town.

He reported that the Recycling Center hours changed to 8-12 Tuesday/Thursday and 8-2 on Saturday. The move was made as a cost savings move and based on usage. The Administration has also held meetings with the Superintendent of Schools.

The Town is also working on obtaining quotes for milling and paving new surfaces for the basketball courts, and that 200 residents have signed up for soccer. If anyone is interested in helping out, please call Town Hall to volunteer.

Administrator Bennett also spoke about the Community Garden and the Integration Ordinance to have and the development of a new bilingual welcoming kit.

Mayor Blackman wanted everyone to know that the reason the Crescent Field Basketball Courts are closed is safety at the direction of our Insurance and that the Town is working to reopen the courts and parks safely. The Mayor also reported that the 300 Anniversary Committee has already held several meetings.
