## REGULAR MEETING MINUTES October 13, 2009

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:07 pm

# ROLL CALL

Present: Aldermen Delaney, Visioli, Donofrio, Picciallo, Timpani, Romaine, Blackman and Mayor Dodd Absent: Aldermen Poolas

Also present were Administrator Close, Attorney Pennella and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only. Seeing no hands or hearing no voices, he closed the meeting to the public.

<u>MAYOR DODD</u> – Mayor Dodd commented that the town has been working on preparations for the King Field Improvement Project for the rehabilitation of the baseball fields. Mayor Dodd, Mr. Close and representatives of Home Depot have met to discuss the rehabilitation of the concession stand. He noted that Home Depot will be sponsoring the renovations to the concession stand. Mayor Dodd is waiting on the details on what Home Depot is willing to provide to the town, with, labor assistance and/or materials assistance.

He noted that the Municipal Alliance would like to sponsor "Operation Medicine Cabinet" and arrangements have been made with the police department to assist with the implementation of the program. Mayor Dodd asked the public to support "IHOP Family Day & Night" fundraiser on October 13<sup>th</sup> & October 15<sup>th</sup> which will benefit the Dover Area Historical Society.

Mayor Dodd announced that the "Halloween Costume Contest" will be hosted on October 29<sup>th</sup> at JFK Commons Park. He also announced that the "31<sup>st</sup> Annual Halloween Fun Run" will be hosted on October 27<sup>th</sup> at Dover High School parking lot.

Mayor Dodd noted the Library Board had a dedication for restoration of a painting done by Dover resident Kate Sutton and thanked Cindy Forrest of the Neighbor News for making the dedication a front page article. He commended the Library Board and Director Robert Tambini on the wonderful ceremony. The restored painting was done by Dover resident Kate Sutton titled "Peaceful Charm of Woods and Water" reflects the history of Dover and was painted about 75 years ago.

Mayor Dodd noted that the health department gave flu vaccinations to about 200 Dover residents. He noted that the swine flu vaccinations will be available in the weeks ahead which will be coordinated by the state and county health departments.

He announced that Sack's Paint & Wallpaper and the Town of Dover will be participating this year in Toy for Tots campaign sponsored by the United States Marines Corps. Reserve. He noted that toy donations (new & unwrapped) for ages infant to 16 years old can be dropped off at Sack's Paint & Wallpaper store and town hall from November 27<sup>th</sup> to December 21<sup>st</sup>. He noted that a special train will stop on North Sussex Street on December 12<sup>th</sup> from 1:30pm-2:30pm to pick up toy donations and for the opportunity to greet Santa and his elves. Mayor Dodd will be participating in this event and encourages the board to get involved.

Mayor Dodd noted that the fire department had their inspection dinner. He commended Chief Paul McDougall and Captain Scott Warner and complimented them for a fine department. Mayor Dodd apologized for not being able to attend the dinner.

Mayor Dodd commended Connie Sibona-Foster, Board of Education President Sue Shauer, Alderwomen Romaine and Blackman and everyone involved with putting up the corn stalks throughout the downtown area.

<u>ALDERMAN TIMPANI</u> – Alderman Timpani understands there will be a plaque for Arthur Ohlsen (a police officer who died in the line of duty) placed on the new Salem Street Bridge. He would like the board to consider putting in a sitting area.

Mayor Dodd said the town requested the plaque from the county and state and there will be a dedication ceremony in the near future. He is not sure if the property Alderman Timpani is talking about is town property. Administrator Close reiterated that there will be a dedication ceremony.

<u>ADMINISTRATOR CLOSE</u> – Many meetings have been held for contract negotiations. Also, work is being done on the fall newsletter. He wanted to commend Don Costanzo for the great job with the flu clinic and wanted the board to know Dover with Don's lead, is ahead of the curve preparing for the H1N1 (Swine Flu) vaccination program. He also wanted to commend the Fire

Department under the command of Chief McDougall and Captain Warner for the fine job with the inspection.

<u>ATTORNEY PENNELLA</u> – The brief for the taxi litigation has been submitted for the payment of their fees, the hearing should be in early November.

<u>ALDERWOMAN BLACKMAN</u> – Alderwoman Blackman and Mayor Dodd attended the Hope House Walk, Community Fair held at the Head Start School and the Regency Grande Nursing & Rehabilitation Center's Annual Labor of Love Day & Gourmet BBQ. Alderwoman Blackman commented that the events were successful and well attended.

**MARIE TAMBINI** - 6-16 E. Blackwell Street – Wanting to thank the administrative office and all for accommodating the people in her building with parking when they were having their lot repaved. She commented she is having a problem with Blue Diamond (garbage hauler) last week a piece of furniture with a sticker on it was not picked up, they did come back after being called. This week a TV was not picked up, again she had to call and they came back. She wanted to report the stop sign at Penn Ave. and Morris Street is faded, and also the manhole cover at Blackwell Street and Morris Street is loose and makes a lot of noise when someone drives over it.

<u>AXEL ACEVEDO</u> - 20 No. Bergen Street - His complaint is about out of town taxi/limo companies working in Dover. He feels this is unfair to himself and other companies in Dover who abide by the ordinance.

Mayor Dodd commented that this board understands and has changed our ordinance to help the Dover companies and has since entered into litigation. Dave Pennella our attorney has done a great job. He would like a meeting set up with the taxi company owners, Attorney Pennella, Administrator Close and Clerk Verga.

JORGE Zuzunago - 1<sup>ST</sup> Class – 116 E. Blackwell St. – His complaint was the same as Axels about out of town companies.

KEVIN ? - Elite Limo - 116 E. Blackwell St. - He is in support of Axel and Jorge.

**<u>Robyn Valle, Esq</u>**. – She is the attorney representing Eagle Limo and they provide service to people in Dover, she would like to be included in the meeting.

Attorney Pennella stated the meeting is for Dover companies only and he believes Eagle Limo had an intra-municipal permit. Clerk Verga stated the board approved the permit but Eagle never provided the necessary documentation, therefore the permit was never issued. Eagle has new owners since then.

Seeing no hands and hearing no voices, Mayor Dodd closed this portion of the meeting to the public.

#### RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AUTHORIZING SUIT AGAINST BRIAD LODGING GROUP, DOVER, LLC

WHEREAS, the Town of Dover, hereinafter "Dover," and Briad Lodging Group Dover, LLC, hereinafter "Briad," entered into a Redeveloper's Agreement; and

WHEREAS, the Redeveloper's Agreement required that Briad utilize a minimum of 50% or more of local contractors as defined in the Redevelopment Agreement; and,

WHEREAS, Briad failed to meet the 50% minimum requirement of local subcontractors; and

WHEREAS, the Redevelopment Agreement provides for a \$250,000.00 liquidated damage payment to the Town by Briad if they fail to meet the minimum local contractor requirement; and

WHEREAS, Briad has refused to pay such liquidated damage amount;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey, as follows:

1. The municipal attorney is hereby authorized to file suit against Briad for breach of the Redeveloper's Agreement to enforce the liquidated damage provision mentioned above.
